- Ordinance No. 498-130125 entitled: “ **An Ordinance Amending Municipal Ordinance No. 476-080523 Particularly Section 145 – other fees and charges (1) by increasing the rates imposed therein and inserting additional fees and charges.**”

REVIEW/RECOMMENDATION/LEGAL OPINION:

This office opines that the subject Ordinance is, in general, within the legislative authority of the Sangguniang Bayan to repeal/amend its prior acts either expressly or by the passage of an essentially inconsistent resolution¹, subject to the availability of funds and to normal and regular accounting and auditing procedures. Hence, we recommend for the declaration of its validity.

AN ORDINANCE AMENDING MUNICIPAL ORDINANCE NO. 476-080523 ENTITLED "2023 REVENUE CODE OF THE MUNICIPALITY OF PALOMPON", PARTICULARLY SECTION 145- OTHER FEES AND CHARGES (1) BY INCREASING THE RATES IMPOSED THEREIN AND INSERTING ADDITIONAL FEES AND CHARGES

BE IT ORDAINED by the Members of the Sangguniang Bayan of Palompon, Leyte duly assembled:

SECTION 1. – TITLE. This ordinance shall be known as an Ordinance amending Municipal Ordinance No. 476-080523 entitled "2023 Revenue Code of the Municipality of Palompon", particularly Section 145- Other Fees and Charges (1) by increasing the rates imposed therein and inserting additional fees and charges.

SECTION 2. – AMENDMENT OF SECTION 145.

OTHER FEES AND CHARGES

1. SANITARY LANDFILL - THERMAL DECOMPOSITION MACHINE

Tipping Fee:

Domestic Residual Waste	1,000.00/ton
Hospital/ Pharmaceutical Waste	3.00/kg.
Chicken Manure	10.00/kl.
Pathological Waste	4.50/kg.

SECTION 3. – REPEALING CLAUSE. All ordinances, resolutions, rules and regulations inconsistent with this ordinance is hereby repealed accordingly.

SECTION 4. – SEPARABILITY CLAUSE. If any section, subsection, sentence, clause or phrase of this Ordinance is for any reason to be invalid or unconstitutional by a decision of any court with competent jurisdiction, such decision shall not affect the validity of the remaining portions of this Ordinance.

SECTION 5. EFFECTIVITY. This Ordinance shall take effect upon its approval.
