Dear Vice-Governor Javier, Jr.:







This selection is based on:

1. The selected LGUs have been identified based on the number of Former Rebels (FRs) in their areas, using data and a heatmap prepared by the ECLIP-Program Management Office to help prioritize the allocation of funds.
2. The timely submission of formal manifestations of interest as previously requested.

Note: While only seven (7) LGUs are initially targeted for funding under the FY 2025 allocation, all other LGUs that submitted their formal manifestations of interest shall be included in the **Priority List**. These LGUs, starting from number eight (8) onward, may be considered for possible funding within FY 2025, subject to the availability of funds.

These are the following pre-implementation documentary requirements:

- Memorandum of Agreement (MOA)
- Letter of Intent (LOI)
- Program of Works (POW)
- Proof of Land Ownership
- *Sanggunian Panlalawigan/Panglungsod* Resolution (explicitly stating LGU commitment to manage and maintain the proposed Halfway House)

Relative hereto, all concerned LGUs in the above-list are hereby directed to submit the required pre-implementation documentary requirements no later than **June 30, 2025**, through Document Management System (DMS) or via email: dilgnboeclippmo@gmail.com, to facilitate due diligence and processing.

This initiative is targeted for implementation within FY 2025, subject to the timely completion of all documentary requirements and approval of the top management. In the event that the LGU anticipate difficulties in complying with the documentary submission requirements within the prescribed timeline, immediate communication to this Office is requested to allow for appropriate recalibration of plans.

SUBJECT : SUBMISSION OF PRE-IMPLEMENTATION DOCUMENTS FOR THE CONSTRUCTION OF HALFWAY HOUSE UNDER THE ENHANCED COMPREHENSIVE LOCAL INTEGRATION PROGRAM (ECLIP) FOR FY 2025

DATE : May 29, 2025

Reference is made to the Memorandum dated March 21, 2025, requesting formal manifestations of interest from LGUs to avail of financial assistance for the construction of Halfway Houses under the DILG-Administered Package of Assistance ECLIP funds for FY 2025. The said memorandum outlined the availability of a total of Thirty-Five Million Pesos (PHP 35,000,000.00) allocated for seven (7) LGUs, with each LGU eligible for Five Million Pesos (PHP 5,000,000.00) to support the establishment of Halfway Houses aimed at facilitating the reintegration of former rebels (FRs)/former violent extremists (FVEs).

Following the review of the initial manifestations of interest and subject to fund availability, this Office has identified the list of LGUs prioritized for this assistance, as follows:
