

**WHEREAS**, Section 129 of Republic Act No. 7160 otherwise known as the Local Government Code of 1991 provides that, each local government unit shall exercise its power to create its own sources of revenue and to levy taxes, fees, and charges subject to the provisions of the said Code which shall accrue exclusively to the local government units consistent with the basic policy of local autonomy;

**WHEREFORE**, on motion of the **Honorable Henry B. Lagarto**, duly seconded by the **Honorable Jerwin R. Sugbo** ; be it

**NOW THEREFORE, BE IT ENACTED, AS IT IS HEREBY ENACTED, BY THE SANGGUNIANG BAYAN OF MAYORGA, IN SESSION ASSEMBLED, BY VIRTUE OF THE POWERS VESTED IN IT BY LAW, THAT:**

#### **SECTION 1. TITLE.**

This Ordinance shall also be known as the "Mayorga Arcade Market Tiendas Operations Ordinance of Mayorga, Leyte."

#### **SECTION 2. SCOPE and COVERAGE.**

This Ordinance shall specifically covers the rules and regulations including the market fees for the operation of the two-storey Mayorga Arcade Market Tiendas in the Municipality of Mayorga, Leyte.

#### **SECTION 3. DECLARATION OF POLICY.**

It is hereby a policy of the Municipality of Mayorga to make the public market more responsive and effective instrument of public service as well as dynamic and viable enterprises thereby strengthening the financial capabilities of the municipality and thus significantly contributing to national and local development. Towards this end, the Municipality of Mayorga shall develop, regulate and standardize public market systems and professionalize market services.

#### **SECTION 4. AUTHORITY.**

This Ordinance is enacted pursuant to Section 447 of RA 7160, otherwise known as the Local Government Code of 1991 which empowers the municipality thru its Sangguniang Bayan to:

1. Appropriate funds for the construction and maintenance or the rental of buildings for the use of the municipality and, upon the majority vote of all the members of the Sangguniang Bayan, authorize the municipal mayor to lease to private parties such public buildings held in a proprietary capacity, subject to existing laws, rules and regulations;
2. Prescribe the terms and conditions under which public utilities owned by the municipality shall be operated by the municipal government or leased to private persons or entities, preferably cooperatives;

3. Require that buildings and the premises thereof and any land within the municipal market be kept and maintained in a sanitary condition and impose penalties for any violation thereof;

#### SECTION 5. PURPOSE.

This Ordinance is enacted for the following purposes, to wit:

1. Regulate the growth and development of the Mayorga Arcade Market Tiendas including its premises;
2. Protect the character and stability of the Mayorga Arcade Market Tiendas and its premises as well as promote an orderly and beneficial development of the same;
3. Promote the health, safety, peace and comfort convenience and general welfare of the occupants therein as well as the general public patronizing the Mayorga Arcade Market Tiendas;

#### SECTION 6. DEFINITION OF TERMS.

When used in terms in this Ordinance, each of the following word and phrases shall be construed to mean as follows:

1. **Article** – a product that is bought and sold. It can also mean something of value, advantage, or use for trade or commerce.
2. **Lessee** - awardee of lease contract to occupy a market stall or space inside the Mayorga Arcade Market Tiendas and are commonly known as stallholders;
3. **Local Government Unit** - refers to the Municipality of Mayorga, Leyte;
4. **Public Market Authorities** - refers to the Municipal Mayor, his/her duly appointed Market Administrator/Supervisor, the Municipal Treasurer, or any other Municipal Officer charged with the management of the day-to-day operation of the public market and/or specific aspects of its operation;
5. **Mayorga Arcade Market Tiendas** - a constructed building or structure owned or operated by the Local Government Unit of Mayorga dedicated to the service of the general public, and where basic food items and other commodities are displayed and offered for sale;
6. **Occupancy Right** – the right to occupy a stall in the Mayorga Arcade Market Tiendas;
7. **Market Stall** - any allotted space inside the Mayorga Arcade Market Tiendas;

8. **Rental Fee** - a charge fixed by law or agency, in the form of money or otherwise given in exchange for the enjoyment or use of a thing for a certain period of time;
9. **Stallholders** - those who have been granted the right to use a stall or more, where they can display or sell their goods, commodities or foodstuffs, and pay rentals thereon.
10. **Vendor** - a general term for a person who sells goods, commodities or foodstuffs within the market premises.

### SECTION 7. CREATION OF A MAYORGA PUBLIC MARKET ADJUDICATION COUNCIL.

There is hereby created a Mayorga Public Market Adjudication Council composed of the following:

Chairman - Municipal Mayor  
Vice-Chairman- Municipal Vice-Mayor  
Members:

Chairman or Vice-Chairman, Committee on Public Market and Slaughterhouse  
Chairman or Vice-Chairman, Committee on Ways & Means  
Municipal Treasurer  
Municipal Planning & Development Officer  
Municipal Engineer Business Permits and Licensing Officer  
General Services Officer  
Market Vendors Association Representative  
Representative from the Business Community

No person shall be a member of the Mayorga Public Market Adjudication Council if he/she has business interest in the market, except the Market Vendors' Association Representative and the Representative from the Business Community.

If in case the abovementioned member/s of the Mayorga Public Market Adjudication Council has business interest in the market, the Sangguniang Bayan will choose among the personnel under the same department who will serve as a member of the Council.

### SECTION 8. POWERS AND FUNCTIONS OF THE MAYORGA PUBLIC MARKET ADJUDICATION COUNCIL.

The Mayorga Public Market Adjudication Council shall be vested with the powers, functions and responsibilities to wit:

1. Create a Bids and Awards Committee who will administer the screening of applicants and opening of bids in connection with the adjudication of vacant or newly constructed stalls or booths in the public market and award market stalls to qualified individuals;
2. Formulate policies, rules, and regulations for market operations and administration for the effective implementation of this ordinance and as the need arises to recommend to the Sangguniang Bayan of any addition, revision and or deletion of the provisions stipulated herein;
3. Recommend to the Offices of the Municipal Mayor and to the Sangguniang Bayan any market related concerns for local legislation and implementation;
4. Hear, settle grievances and or appeal arising out of market operations and administration;
5. Recommend temporary closure, forfeiture or eviction of tenant or lessee to the Municipal Mayor;
6. Enter into a Limited Source Bidding with the winning bidders of the Mayorga Arcade Market Tiendas, allowing a maximum of two (2) stalls in case there are multiple winning bidders interested on a vacant stall after failure of the first two (2) biddings;
7. Enter into a Negotiated Bidding with a winning bidder of the Mayorga Arcade Market Tiendas, allowing a maximum of two (2) stalls after failure of the first two (2) biddings and the Limited Source Bidding;
8. Reduce the minimum bid amount after failure of the first two (2) biddings, the Limited Source Bidding and the Negotiated Bidding. The competitive bidding with the reduced minimum bid amount will first be opened exclusively to the residents of Mayorga including current stall owners from the Mayorga Public Market. Failure of such, will open the bidding to residents from other municipalities;
9. All other matters or occurrences relative to the occupation of vacant stall or space within the Mayorga Arcade Market Tiendas and incidents thereto not mentioned in this ordinance shall be deliberated upon by the Council and any recommendation/s shall be deemed valid by the majority votes of members present. Such recommendation/s shall be submitted to the Sangguniang Bayan for appropriate resolution of approval.

The Council shall convene immediately after the approval of this ordinance and award all vacant stalls to winning applicants/tenants.

### SECTION 9. ESTABLISHMENT OF MARKET BOARD SECRETARIAT.

The Business Permits and Licensing Officer shall serve as the secretariat of the committee. Its duties shall include record-keeping, preparation of meeting agenda, and providing administrative support to the Council. The BPLO is expected to contribute perspective at the ground level, address concerns, and collaborate with the committee to enhance market operations.

### SECTION 10. ADJUDICATION OF STALLS.

- (1) **Lease Period.** The contract of lease for a stall shall be for a period of twenty-five (25) years, renewable upon its expiration and after paying the minimum bid amount, unless revoked in accordance with the provision of this Ordinance;
- (2) **Notice of vacancy.** A notice of vacancy for the newly constructed stalls shall be posted for a period of 10 days to apprise the public of the fact that such space is unoccupied and available for lease. Such notice shall be posted conspicuously on the unoccupied stall and the bulletin board of the market. This notice of vacancy shall be written on cardboard, thick paper, or any other suitable material. The same applies in case of a cancellation of lease of stall;

- (d) Applicants who are Mayorga citizens shall have preference in the case of the Mayorga Arcade Market Tiendas stalls excluding current stall owners in the public market. The posting of the Notice of Vacancy prescribed above shall be for ten (10) working days period. If after the expiration of that period there is no Mayorga citizen applicant, the stall affected thereby may be leased to any applicant from other municipalities including current stall owners in the public market as well as other interested residents of Mayorga after failure of the first bidding. The adjudication of the stall shall be made through the bidding to be conducted by the Bids and Awards Committee created by the Mayorga Public Market Adjudication Council;

In case there is only one Mayorga citizen applicant, the stall applied for shall be adjudicated to him/her. If there are several Mayorga citizen applicants for the same stall, adjudication of the stall shall be made through bidding to be conducted by the Bids and Awards Committee created by the Mayorga Public Market Adjudication Council on the date and hour specified in the Notice. The result of the bidding shall be reported immediately by the Committee to the Municipal Treasurer concerned for appropriate action;

- (e) The minimum bidding amount to secure the occupancy right for lower stalls in the Mayorga Arcade Market Tiendas is Three Hundred Thousand Pesos (Php 300,000.00) and the minimum bidding amount to secure the occupancy right for upper stalls in the Mayorga Arcade Market Tiendas is Two Hundred Thousand Pesos (Php 200,000.00) **NON-REFUNDABLE**;
- (f) The winning bidder shall pay the bid amount to the Municipal Treasurer within the day, otherwise the award shall be granted to the next highest bidder;
- (g) Any applicant who is not satisfied with the adjudication made by the Bids and Awards Committee created by the Mayorga Public Market Adjudication Council of the stall applied for, may file an appeal with the Municipal Mayor who may submit such appeal with his comments and recommendation within the day of the bidding as he may desire to make on the matter. The decision of the mayor in such cases shall be final;

- (h) A Contract of Lease shall be executed between the LGU and the winning bidder on the following day after the bidding, provided, that no appeal was filed with regards to the adjudication proceedings;
- (i) A Certificate of Occupancy shall be issued by the Council to the lessee signed by the Municipal Mayor after the signing of the Contract of Lease with the LGU Mayorga. Thereafter, the Lessee may formally construct necessary structural requirements needed for his business operations under the National Building Code and of this Ordinance;
- (j) Former stallholders with good payment standing with no outstanding arrears with the LGU prior to the renovation of the Mayorga Arcade Market Tiendas may secure their occupancy right without joining the bidding upon paying the minimum bid amount;
- (k) No person up to his/her first degree of consanguinity and affinity shall be allowed to lease more than two stalls within the Mayorga Arcade Market Tiendas unless two (2) failure of bidding occurs;

#### SECTION 11. IMPOSITION OF RENTAL FEES.

There shall be collected the following rental fees:

- (1) On the occupancy of the lower stalls in the Mayorga Arcade Market Tiendas:
  - a. Monthly Rent Php 3,000.00

There shall be an increment of Php 200.00 every year of the monthly rental until such time this ordinance is amended by the Sangguniang Bayan.

- (2) On the occupancy of the upper stalls in the Mayorga Arcade Market Tiendas:
  - a. Monthly Rent Php 2,000.00

There shall be an increment of Php 150.00 every year of the monthly rental until such time this ordinance is amended by the Sangguniang Bayan.

#### SECTION 12. TIME AND MANNER OF PAYMENT.

The fees for the rental of Mayorga Arcade Market Tiendas stalls shall be paid to the Municipal Treasurer or his duly authorized representative within the first fifteen (15) days of each month. In case of a new lessee, it shall be paid thirty (30) days after the execution of the contract.

The Municipal Treasurer or his duly authorized representative shall issue an official receipt as evidence of payment to the rental of the stalls.

### SECTION 13. SURCHARGE FOR LATE OR NON-PAYMENT OF FEES.

The lessee of a stall, who fails to pay the monthly rental fee within the prescribed period shall pay a surcharge of twenty-five (25%) percent of the total rent due plus two percent (2%) penalty per month. Failure to pay the rental fee for three (3) consecutive months shall cause automatic cancellation of lease of stall. The stall shall be declared vacant and subject to adjudication. Failure to operate for ninety (90) days even if rental fee is religiously paid, a notice shall be issued to the stall owner and will be given a grace period of thirty (30) days to operate its business, otherwise the stall shall be declared vacant and subject to adjudication.

A one-time payment Transfer Fee of One Thousand Pesos (Php 1,000.00) shall be collected from the heir / business partner in case of death, physical or mental incapacity of the lessee. Provided that the heir will continue to occupy the stall or if in case of a business partner, the heir or immediate family is not applying for the concerned stall.

### SECTION 14. IMPOSITION OF SECURITY DEPOSIT.

There shall be collected a refundable Security Deposit of Fifteen Thousand Pesos (Php 15,000.00) per winning bidder of the Mayorga Arcade Market Tiendas.

The Security Deposit prescribed in this section shall be paid to the Municipal Treasurer or his authorized representative on the same time of paying the bid amount.

The Security Deposit shall cover for the electrical bill and stall rental in case the stall owner decides to vacate the stall. Such deposit shall thereafter be refunded to the stall owner if all dues with the Municipal Treasury and other utility bills are settled.

### SECTION 15. RULES AND REGULATIONS ON STALLS.

- (1) *Vacancy of stall before expiration of the lease.* If for any reason, a stall holder or lessee discontinues or be required to discontinue his business before his lease of the stall expires, such stall may be considered vacant and its occupancy thereafter shall be disposed of in the manner herein prescribed.

(2) **Partnership with stallholder.** A stallholder who enters into business partnership with any party after he had acquired the right to lease, such stallholder shall have no authority to transfer to his partner or partners the right to occupy the stall. In case of death or any legal disability of such stallholder to continue in his business, the surviving partners may be authorized to continue occupying the stall for a period not exceeding sixty (60) days within which to wind up the business of the partnership. The surviving partner may apply as stallholder if he/she is qualified to occupy a stall under the provisions hereof, provided that the spouse, parent, son/daughter, or relative within the third degree by consanguinity or affinity of the deceased is not applying for the concerned stall.

(3) **Lessee to personally administer his stall.** Any person who has been awarded the right to lease a stall in accordance with provisions hereof, shall occupy, administer and be present personally to operate at his stall within ninety (90) days from award. He may employ helpers, including but not limited to his spouse, parents and children who are actually living with him or employ additional security for their business.

(4) **Dummies, Sub-lease of stalls.** In any case where the person, registered to be the holder or lessee of a stall in the Mayorga Arcade Market Tiendas is found to be not the person who is actually occupying said stall, the lease of such stall will be cancelled or revoked with no refund to the lessee of its bid amount, if upon investigation such holder shall be found to have sub-leased his or her stall to another person, or to have connived with such person so that the latter may for any reason be able to occupy the said stall.

(5) **Return of Bid Amount.**

a. In any case where the stallholder stops operating his/her business under a valid reason, a percentage of the minimum bid amount of Three Hundred Thousand Pesos (Php 300,000.00) for the lower stalls and Two Hundred Thousand Pesos (Php 200,000.00) for the upper stalls in the Mayorga Arcade Market Tiendas may be returned after said stall has been bid-out to a new lessee, under the following percentage breakdown:

1. Fifty percent (50%) on the first year;
2. Forty percent (40%) between the second to third year;
3. Thirty percent (30%) between the fourth and fifth year;

b. In any case where the stallholder who won under the bidding with a reduced bid amount, stops operating his/her business under a valid reason, a percentage of the minimum bid amount approved by the Mayorga Public Market Adjudication Council may be returned after said stall has been bid-out to a new lessee, under the following percentage breakdown:

1. Fifty percent (50%) on the first year;
2. Forty percent (40%) between the second to third year;
3. Thirty percent (30%) between the fourth and fifth year;

#### **SECTION 16. RESPONSIBILITY FOR MARKET ADMINISTRATION.**

The Municipal Treasurer and designated personnel thereof shall exercise direct and immediate supervision and control over the Mayorga Arcade Market Tiendas and upkeep of the premises in accordance with existing ordinances, and other pertinent rules and regulations.

#### **SECTION 17. RESPONSIBILITY OF INDIVIDUAL STALLHOLDERS.**

Individual stallholders shall keep and maintain their stalls in clean and sanitary conditions. They shall likewise be responsible for the cleanliness of the passageways, alleys or spaces immediately in front, behind or beside their stalls. Together with local market authorities and personnel, stallholders shall be responsible for the general cleanliness and sanitation of the Mayorga Arcade Market Tiendas and its premises.

#### **SECTION 18. DISPOSAL OF GARBAGE.**

Individual stallholders shall provide themselves with their own receptacles in order to avoid littering in their premises, considering the proper segregation of solid wastes in accordance with the Solid Waste Management Plan of the municipality. Garbage for disposal shall be kept inside the premises and shall only be brought outside, sealed and tied and properly placed in sacks or bags upon collection schedule by the garbage collectors.

It shall be the responsibility of the individual stallholders to dispose of their garbage within their premises. The disposal of the garbage of the buying public and market personnel shall however be the responsibility of the market personnel.

The waste dumping area for disposed garbage shall be located at a convenient location accessible to garbage collectors. Solid wastes accumulated at each stall shall be transferred to the central dumping area to facilitate efficient solid waste management.

#### SECTION 19. GENERAL LIGHTING FACILITIES.

Adequate general lighting facilities shall be provided and maintained in the Mayorga Arcade Market Tiendas. Stallholders may provide their own lightning facilities on their respective stalls at their own expense, subject to existing safety regulations and market rules.

#### SECTION 20. RESPONSIBILITY FOR LOSS OR DAMAGE OF ARTICLES OR MERCHANDISE.

1. The municipal government shall not be responsible for any loss or damage of the lessee's property caused by fire, theft, robbery, "force majeure", or any other unavoidable cause. All article or merchandise left in the public market shall be at the risk of the stallholder or owner thereof;
2. All articles abandoned in any public market building in violation of any regulation or rules relating to the management of the market administrator or the officer in charge thereof shall be taken under the custody of the market administrator or the officer in charge. In case the articles are claimed within 24 hours, they shall be returned to the owner thereof unless they are so deteriorated as to constitute a menace to public health, in which case, these shall be disposed of in the manner directed by the Market Administrator or the officer in-charge thereof, who may also in his discretion initiate the prosecution of the guilty party, or merely warn him against future violation. In case the article has not deteriorated and are not claimed within the time herein fixed, said article shall be sold at public auction and proceeds thereof shall be disposed of in accordance with the law.

#### SECTION 21. PROHIBITED ACTS.

- (1) It shall be unlawful for any lessee to utilize the Mayorga Arcade Market Tiendas for residential purposes, without prior authorization from the Mayorga Public Market Adjudication Council;
- (2) It shall be unlawful for any person to peddle, hawk, sell or offer for sale, any article in the passageway used by the buying public in the Mayorga Arcade Market Tiendas;

- (3) It shall be unlawful for any person to resist, obstruct, annoy or impede Market Employee or personnel and any public employee in the performance of their duties;
- (4) It shall be unlawful for any lessee to sell or offer for sale any merchandize or articles which have been illegally acquired by the stallholder;
- (5) It shall be unlawful for any lessee to remove, construct and or alter the original structure of any stall or booth, electrical wiring or water connection, without prior authorization from the Sangguniang Bayan, subject to the recommendation from the Mayorga Public Market Adjudication Council.
- (6) It shall be unlawful for any person to carry in possession deadly weapons such as knives, bolos, axes, ice picks, darts, etc., within the Mayorga Arcade Market Tiendas, or in case of stallholders or their helpers, outside their respective stalls;
- (7) It shall be unlawful to use the rented stall as bodega or stockroom;
- (8) Any person whether seller or buyer or just curiosity seeker, is prohibited to Spit on or eject phlegm, urinate, excrete or scatter trash or foreign matters in the premises;
- (9) Gambling is strictly prohibited inside and within the premises of the Mayorga Arcade Market Tiendas;
- (10) Beerhouse, bar, cabaret and other similar businesses are strictly prohibited to operate in the Mayorga Arcade Market Tiendas.




Any person or entity violating, or causing, inducing or abetting the violation of the above prohibitions shall have the following penalties:



**SECTION 25. REPEALING CLAUSE.**


All ordinances, rules and regulations, or part thereof, in conflict with, or inconsistent with any provisions of this Ordinance are hereby repealed or modified accordingly.






