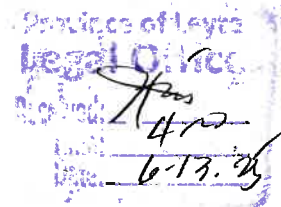

EXPLANATORY NOTE

WHEREAS, Section 16 of Republic Act No. 7160 otherwise known as the Local Government Code under its General Welfare Clause, provides in part that every local government unit shall ensure and support the maintenance of peace and order within their respective territorial jurisdiction;

WHEREAS, Executive Order No. 297, entitled: Regulating the Manufacture, Sale, Distribution and Use of PNP Uniforms, Insignias and Other Accoutrements was signed on October 4, 2000 to control and manage the unauthorized manufacture, sale, and distribution of PNP uniforms, insignias and other accoutrements;

WHEREAS, E.O No. 297 imposes as penalties the immediate closure of establishments, cancellation of business license or permit, condemnation, seizure and forfeiture of unauthorized items, and, imposition of reasonable fines for violators of the said order, all of which could be undertaken by the local government units concerned;

WHEREAS, the unauthorized manufacture, sale, use, and distribution of PNP uniforms, insignias, and other accoutrements impose serious concerns since such symbolic PNP identifiers, instead of providing a comforting sense of security, could be used by lawless elements in the commission of crimes within the municipality;

WHEREAS, considering that a PNP Municipal Station sits within the territorial jurisdiction of the Municipality of Mayorga and there may be a number of business establishments that will engage in the manufacture, sale and distribution of PNP uniforms, insignias, and other accoutrements, there is a dire need to enact a corresponding municipal ordinance to mitigate, or even eradicate the proliferation of unauthorized PNP uniforms and commission of illegal activities within the Municipality of Mayorga, Leyte;

Wherefore, on motion of the **Honorable Joseph A. Amante**, duly seconded by the **Honorable Mark Cloyd M. Tan-piengco**; be it

NOW THEREFORE, BE IT ENACTED, AS IT IS HEREBY ENACTED, BY THE SANGGUNIANG BAYAN OF MAYORGA, IN SESSION ASSEMBLED, BY VIRTUE OF THE POWERS VESTED IN IT BY LAW, THAT:

SECTION 1. TITLE.

This Ordinance shall also be known as: AN ORDINANCE REGULATING THE MANUFACTURE, SALE, DISTRIBUTION AND USE OF PNP UNIFORMS, INSIGNIAS AND OTHER ACCOUTREMENTS IN THE MUNICIPALITY OF MAYORGA, LEYTE.

SECTION 2. SCOPE and COVERAGE.

All businesses, whether in physical, online or in digital platforms, engaged in the manufacture, sale, use and distribution of Philippine National Police uniforms, insignias, and other accoutrements. It includes enterprises dealing with raw materials for the production of aforementioned items.

SECTION 3. AUTHORITY.

This Ordinance is enacted pursuant to the provisions of R.A. 7160 otherwise known as the Local Government Code of 1991 which mandates the LGU to adopt adequate measures to protect, safeguard and improve the quality of life for every Mayorgueño.

SECTION 4. DEFINITION OF TERMS.

For purposes of implementation of this ordinance, the following definitions shall be binding and controlling:

- a) PNP uniforms, insignias, and accoutrements - these are authorized clothing, garment, distinguish mark, emblem, merchandise, or decorations worn by bona fied members and officially acknowledged by the PNP;

- b) PNP Certificate of Conformity - a certification issued by the PNP through the Directorate for Research and Development (DRD) which signifies authority to manufacture, sell, or distribute PNP uniforms, insignias and accoutrements;
- c) Distributor - an authorized agent of a supplier or manufacturer to supply or deliver PNP uniforms, insignias, and accoutrements wherein the latter has a valid PNP Certificate of Conformity;
- d) Manufacture and Sale – an act of producing or trading of fit-to-use, ready-to-wear, or ready-to-use PNP uniforms, insignias, and other accoutrements.

SECTION 5. REQUIREMENT FOR PNP CERTIFICATE OF CONFORMITY AND/OR CERTIFICATE OF DISTRIBUTORSHIP.

All businesses engaged and dealing with PNP uniforms, insignias, and accoutrements must secure a PNP Certificate of Conformity and/or a Certificate of Distributorship before applying for a corresponding business license or permit. All existing business must likewise secure the same certificate prior to its application for business license/permit renewal.

All accredited establishments shall be required to post their accreditation certificate in public and conspicuous area within the establishment,

SECTION 6. COORDINATION WITH THE PNP.

The BPLO will regularly coordinate with the Philippine National Police – Mayorga Police Station for the latest of the manufacturers, suppliers, sellers, distributors, etc. operating in the municipality. The updated list will be the basis of verification by the Local Government Unit of Mayorga thru the BPLO on the status of the applicant for business license/permit.

SECTION 7. AUTHORITY TO INSPECT ESTABLISHMENTS.

The BPLO with the Mayorga Police Station Representative shall be authorized to conduct inspection of business establishments requiring the presentation of its respective PNP Certificate of Conformity and/or Certificate of Distributorship. The authorized distributors of PNP uniforms, insignias, and other accoutrements shall likewise present acceptable proof of authority to supply, sell or trade the aforementioned items.

SECTION 8. RULES AND REGULATIONS.

- (1) Failure to present or submit a PNP Certificate of Conformity and/or PNP Certificate of Distributorship is a ground for denial of application for issuance/renewal of business permit or license for the covered businesses;

- (2) All accredited establishments shall record transactions involving uniforms and accoutrements by documenting the details of the purchase;
- (3) All accredited establishments shall likewise require the members of PNP to present their official and valid PNP identification card prior to any purchase;
- (4) Any person other than members of PNP, who shall purchase uniforms of accoutrements, shall be required to show authorization for purchase from immediate superior and show a photocopy of the official and valid identification card of the principal buyer and person authorized to purchase on his behalf, prior to any transaction.

SECTION 9. PROHIBITED ACTS.

- (a) Purchase or use of uniforms or other accoutrements by individuals who are not members of PNP, except when duly authorized;
- (b) The production, manufacture, storage, sale, distribution or possession of uniforms or other accoutrements without the proper accreditation certificates issued by the PNP and the Business or Mayor's Permit;
- (c) Failure to record, by any person or establishments, every transaction, including details of the distribution of uniforms and other accoutrements;
- (d) The use of any uniform or accoutrements for the purposes other than what is covered by the issued authorization of use.

SECTION 10. PENALTIES.

- (1) For purposes of this Ordinance, after thirty (30) days from the initial findings of non-compliance, continued and subsequent failure to comply with the Rules and Regulations of this Ordinance shall constitute a ground for suspension, revocation, or cancellation of establishment's business permit;
- (2) In case of violation found during the aforementioned inspections for failure to present competent proof of authority to deal PNP uniforms, insignias and other accoutrements, the items found therein shall be seized or confiscated, subject to proper disposal, without prejudice to the cancellation or revocation of business license/permit and the filing of appropriate administrative, civil or criminal case;

(3) Violation of Section 9 of this Ordinance shall subject the violator to the following fines and penalties:

First Offense: **Confiscation of the item, and a fine of One Thousand Pesos (Php 1,000.00);**

Second Offense: **Confiscation of the item, a fine of Two Thousand Pesos (Php 2,000.00);**

Third Offense: **Confiscation of the item and a fine of Two Thousand Five Hundred Pesos (Php 2,500.00), and imprisonment of not more than 2 months at the discretion of the court.**

(4) In case violation is committed by an establishment or juridical person, it shall result to **the payment of corresponding fees under Section 10 (3),** confiscation of items, revocation of its business license or permit, immediate closure of the establishment, including its offices, buildings, warehouses, stockrooms or any other place where the uniforms or other accoutrements are being produced, manufactured, stored, sold and/or distributed, and forfeiture of all the paraphernalia used in the same.

SECTION 11. SEPARABILITY CLAUSE.

If any provision of this Ordinance or any part thereof be declared invalid or unconstitutional, the remaining provisions not affected thereby shall continue in full force and effect.

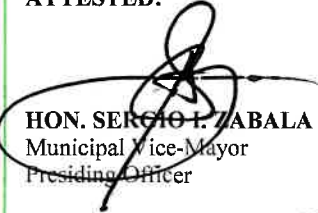
SECTION 12. APPLICABILITY CLAUSE.

All other matters related to the impositions of this ordinance shall be governed by the pertinent provisions of existing laws and other ordinances.

SECTION 13. REPEALING CLAUSE.

All ordinances, resolutions, executive orders or regulations and other issuances inconsistent with the provisions and/or purposes of this Ordinance are hereby repealed, amended or modified accordingly.

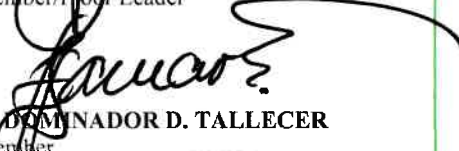
