WHEREAS, pursuant to Department Order No/ 2017-001 issued by the Department of Transportation (DOTr) and the Joint Memorandum Circular No. 001, Series of 2017 issued by the Department of the Interior and Local Government (DILG) and the Department of Transportation (DOTr), Local Government Units (LGUs) are prompted reliable, safe, accessible, environmentally, and comfortable Public Utility Vehicles (PUVs) for the efficient performance of daily social economic activities;

WHEREAS, Section 4 (d) (iii) of the aforesaid Joint Memorandum Circular No. 001, Series of 2017 issued by the Department of the Interior and Local Government (DILG) and the Department of Transportation (DOTr) provides that upon issuance of a Notice of Compliant (NOC), and ordinance shall be passed adopting the Local Public Transport Route Plan (LPTRP) and the same shall be endorsed to the Land Transportation Franchising Regulatory Board (LTFRB) for the conduct of a transparent operator election and issuance of franchises;

WHEREAS, Section 16 of the Local Government Code states that every local Government unit shall ensure and support, among other things, the preservation and enrichment of culture, promote health and safety, enhance the right of the people to a balanced ecology, encourage and support the development of appropriate and self-reliant scientific and technological capabilities, improve public morals, enhance economic prosperity, and social justice, promote full employment among their residents, maintain peace and order, and preserve the comfort and convenience of their inhabitants;

WHEREAS, Section 17 of the local Government Code further provides that LGUs shall endeavor to provide adequate, effective and efficient transportation facilities that would provide access and mobility for the people pursue socio-economic activities;

WHEREAS, it is deemed necessary to implement the Local Public Transportation Route Plan (LPTRP) 2025-2029 of Villaba, Leyte which is consistent with the municipality's goal in ensuring safe mobility of people, goods, and services facilitated through the provision of an effective and efficient transport network;

NOW, THEREFORE, be it ordained by the Sangguniang Bayan of Villaba, Leyte, in session assembled;










SECTION 1. SHORT TITLE. This ordinance shall be known as **"AN ORDINANCE IMPLEMENTING THE LOCAL PUBLIC TRANSPORT ROUTE PLAN (LPTRP) C.Y. 2019-2023 OF VILLABA, LEYTE"**.

SECTION 2. OBJECTIVES. The approval and implementing of Local Public Route Plan (LPTRP) 2025-2029 of Villaba, Leyte is intended to: (i) Improve road safety; (ii) Improve public transport quality; (iii) Reduce air pollution from transport; (iv) Reduce traffic congestion; and (v) Enhance transport equity.

SECTION 3. DEFINITION OF TERMS. For purposes of this Ordinance. The following terms shall mean:

3.1 LPTRP- The Local Public Transport Route Plan formulated by the Municipal Government of Villaba, Leyte detailing the route network, mode, and required number of units per mode for delivering public land transport services, approved by the Department of Transportation (DOTr) and Land Transportation Franchising Regulatory Board (LTFRB), Which serves as a comprehensive local transport plan.

SECTION 4. THE LOCAL PUBLIC TRANSPORT ROUTE PLAN (LPTRP) C.Y. 2025-2029 OF VILLABA, LEYTE. The Local Public Transport Route Plan (LPTRP) 2019-2023 Of Villaba, Leyte, as approved under the Notice of Compliance (NOC) issued by the Land Transportation Franchising Regulatory Board (LTFRB). Regional No.VII, is hereby adopted, subject to full compliance with all applicable laws, rules, and regulations. A copy of the Local Transport Route Plan (LPTRP)2019-2023 of Villaba, Leyte shall form part of this Ordinance.
