

MUNICIPAL ORDINANCE NO. 25-17
Series of 2025

AN ORDINANCE AMENDING ARTICLE II, SECTION 1, OF MUNICIPAL ORDINANCE NO. 24-01, OTHERWISE KNOWN AS THE "REVISED CHARTER OF THE BURAUEN COMMUNITY COLLEGE"

Sponsored by Hon. Cipriano R. Relatorres, Jr.

WHEREAS, the Municipality of Burauen, Leyte enacted Municipal Ordinance No. 24-01, known as the "Revised Charter of the Burauen Community College," to establish and provide for the governance and administration of the Burauen Community College, ensuring its responsiveness to the educational needs of the community and the delivery of quality tertiary education;

WHEREAS, Article II, Section 1 of the said ordinance pertains to the Governing Board of Burauen Community College, and reads:

"Section 1. GOVERNING BOARD. — The highest policy-making body of the College is the Governing Board which shall be referred to as the **BOARD OF TRUSTEES**, or "Board" for brevity, and shall be composed of the following:

- Chairperson : Local Chief Executive
- Vice-Chairperson : College Administrator
- Members :
 - President of the duly recognized Faculty Association
 - President of the duly recognized Student Council
 - President of the duly recognized Alumni Association
 - Chairperson of the *Sangguniang Bayan's* Committee on Education
 - A representative of the Department of Science and Technology (DOST)
 - A representative from the duly recognized Business or Industry Sector
 - Municipal Budget Officer
 - Secretary to the Sanggunian

Resource Person: A representative from CHED

The representative from CHED shall be a permanent resource person who shall have no voting rights. His/her participation shall be limited to providing insights to the voting members."

WHEREAS, the said provision provides that a representative from the CHED shall be a permanent resource person to the Governing Board;

WHEREAS, CHED recommends that the ordinance cite that its representative shall be designated as such by the CHED Chairperson;

WHEREAS, there is a need to align with the recommendation of the Commission on Higher Education by specifying that the CHED Chairperson shall designate the CHED representative to the Governing Board;

NOW, THEREFORE, BE IT ORDAINED BY THE SANGGUNIANG BAYAN OF THE MUNICIPALITY OF BURAUEN, LEYTE, in session duly assembled, that:

Section 1. Article II, Section 1, of Municipal Ordinance No. 24-01, otherwise known as the “Revised Charter of the Burauen Community College”, is hereby amended to read as follows:

“Section 1. GOVERNING BOARD. — The highest policy-making body of the College is the Governing Board which shall be referred to as the **BOARD OF TRUSTEES**, or “Board” for brevity, and shall be composed of the following:

- Chairperson : Local Chief Executive
- Vice-Chairperson : College Administrator

- Members :
 - President of the duly recognized Faculty Association
 - President of the duly recognized Student Council
 - President of the duly recognized Alumni Association
 - Chairperson of the *Sangguniang Bayan’s* Committee on Education
 - A representative of the Department of Science and Technology (DOST)
 - A representative from the duly recognized Business or Industry Sector
 - Municipal Budget Officer
 - Secretary to the Sanggunian

Resource Person: A representative from CHED, who shall be designated by the CHED Chairperson, shall be a permanent resource person who shall have no voting rights. His/her participation shall be limited to providing insights to the voting members.”

Section 2. SEPARABILITY CLAUSE. If, for any reason, any part or provision of this Ordinance shall be held to be unconstitutional or invalid, other parts or provisions hereof which are not affected thereby shall continue to be in full force and effect.

Section 3. REPEALING CLAUSE. All ordinances, resolutions, rules, regulations, or parts thereof, in conflict or inconsistent with any of the provisions of this Ordinance are hereby repealed, amended, or modified accordingly.

SECTION 4. EFFECTIVITY CLAUSE. This Ordinance shall take effect after the required posting and publication are satisfied, as prescribed under the Local Government Code of 1991.
