MUNICIPAL ORDINANCE NO. 502-090625

AN ORDINANCE INSTITUTIONALIZING KATUWANG SA DIWA AT GAWA PARA SA MASAGANANG ANI AT MATAAS NA KITA (KADIWA) NG PANGULO IN THE MUNICIPALITY OF PALOMPON, LEYTE.

Be it ordained by the Sangguniang Bayan of Palompon, Leyte, in session assembled:

WHEREAS, food security plays a crucial role in strengthening economic stability, boosting agricultural productivity, promoting public health, and nurturing social harmony;

WHEREAS, economic growth is primarily driven by three key factors: an increase in investments, enhancements in productivity, and rising levels of consumer spending;

WHEREAS, Local Government Units (LGUs) significantly influence the local economy by promoting business establishment and incubation, supporting enterprise development that leads to sustainable local economic activities;

WHEREAS, DILG Memorandum Circular No. 2024-003 encourages all Local Government Units (LGUs) to set-up the KADIWA ng Pangulo (KNP) in their respective localities in partnership with the Department of Agriculture, Department of Trade and Industry (DTI), Department of Labor and Employment (DOLE) and the Department of the Interior and Local Government (DILG);

WHEREAS, the KADIWA ng Pangulo (KNP) is part of the government's efforts to ensure a stable food supply and affordable products by allowing farmers to sell directly to consumers and eliminating market layers;

WHEREAS, the KADIWA ng Pangulo (KNP) also promotes value chain development by connecting farmers to markets and ensuring that the value generated by agricultural products remains within the local economy;

WHEREAS, the advancement of the One Town, One Product (OTOP) initiative boosts growth for local Micro, Small and Medium Scale Enterprises (MSMEs);

WHEREAS, DILG MC 2024-003 further enjoins LGUs to institutionalize the KADIWA ng Pangulo (KNP) by enacting an ordinance to that effect;

NOW, THEREFORE, BE IT ORDAINED by the Sangguniang Bayan of Palompon, Leyte in a session duly assembled that:

SECTION 1. TITLE. This Ordinance shall be known as the "PALOMPON KADIWA ORDINANCE."

SECTION 2. KADIWA DAY IMPLEMENTATION. The KADIWA ng Pangulo (KNP) shall be conducted by the municipality at least twice a month, preferably every first (1st) and third (3rd) Saturday of every month from 5:30 AM to 9:00 AM, in an area to be designated by the Local Chief Executive.







SECTION 3. KADIWA PRODUCT CLUSTERS. The KADIWA ng Pangulo (KNP) shall have three (3) product clusters, as follows:

- a. Fresh agricultural produce such as rice, fish, vegetables, and fruits grown by farmers and their farmers associations/cooperatives (FCAs) from the various barangays in the municipality;
- b. Processed food products of farmers and fisherfolks associations and cooperatives (FCAs), HAPAG Program, and Micro Small Medium Enterprises (MSMEs) to sell local produce products in the KADIWA; and
- c. Mercado stalls (ready-to-eat) food for micro-enterprises.

SECTION 4. RESPONSIBILITIES OF THE LOCAL GOVERNMENT UNIT (LGU). The LGU through the Municipal Agriculture Office (MAO) shall have the following responsibilities:

- a. Lead in the overall management and operation of the KADIWA;
- b. Facilitate the invitation and mobilization of local micro-entrepreneurs, associations, cooperatives, and MSMEs to sell local produce products in the KADIWA;
- c. Identify and secure a suitable venue for the KADIWA;
- d. Assign stalls and provide any logistical support to participating sellers;
- e. Promote the KADIWA to the community/buyers through an information campaign;
- f. Invite the community/buyers to participate during the KADIWA Day through an Information Campaign (i.e. posting of tarpaulins or streamers, utilizing social media, etc.) and;
- g. Coordinate with concerned offices and/or agencies for guidance in handling, operating, and managing the KADIWA, food, and market supply, prospective sellers, and other arrangements needed for the maintenance of sanitation, peace, order, and public safety of every KADIWA ng Pangulo (KNP) Day.

SECTION 5. RESPONSIBILITY OF THE BARANGAYS. The Punong Barangays are enjoined to promote participation in the KNP among farmers, fishers, FCAs and MSMEs in their respective barangays.

SECTION 6. DESIGNATION OF FOCAL PERSON. The Municipal Mayor shall designate a KADIWA ng Pangulo (KNP) Focal Person who shall come from the Municipal Agriculture Office (MAO) and perform the following functions:


- a. Take charge of the overall implementation of the KADIWA ng Pangulo (KNP);
- b. Keep record of data such as the number of participants and the amount of revenue generated during KADIWA ng Pangulo (KNP) Day, among others, and submit the same to the Department of Agriculture (DA) and DILG; and
- c. Perform other duties and functions as may be assigned by the Municipal Mayor.

SECTION 7. FUNDING. The Municipal Government shall allocate funds for the initial implementation of this ordinance and for the establishment, maintenance, and operation of the KNP in the annual budget of the Municipal Agriculture Office;






