

Dear Vice Gov. Javier:

The Leyte III Electric Cooperative, Inc. (LEYECO III) has been steadfast in its commitment to delivering reliable and efficient electricity services to the nine (9) districts within its franchise area for fifty (50) years. Established in accordance with Republic Act No. 6038 and Presidential Decree No. 269, as amended, LEYECO III was organized to promote, supply, and encourage the fullest use of electric service among its member-consumers on an area coverage basis.

On February 14, 2025, LEYECO III secured a new Certificate of Registration for its Amended Articles of Incorporation from the National Electrification Administration (NEA). Subsequently, we are now preparing to file our application for a new Congressional Franchise. It is worth noting that our original Certificate of Franchise, granted on September 26, 1979 by the National Electrification Commission, remains in effect. However, in view of procedural timelines and in accordance with current legislative requirements, we are mandated to file our application before the House Committee on Legislative Franchises for the issuance of a new franchise.


Throughout the years, LEYECO III has made significant contributions to rural development by implementing electrification programs that aim to make electricity more accessible to underserved and unserved communities under the guidance of NEA. These efforts are central to our mission of uplifting the quality of life in the countryside through reliable power service.

We respectfully recall that two years ago, LEYECO III submitted a request to your esteemed office for a resolution of support or endorsement for the renewal of our franchise, including continued representation. However, with the recent changes brought about by the results of the National and Local Elections, we find it necessary to reiterate our request for your valued endorsement.

Your renewed support is vital as we pursue the extension of our franchise to ensure the continued delivery of electricity services, particularly to areas that remain unenergized, unserved, or underserved. In the event that we are unable to secure a renewed franchise, it will pose a serious challenge in determining who will be able to supply electricity to our area. Such a situation would have significant consequences for the communities we serve and the development gains achieved over the years. Without a renewed franchise, the continuity of our operations—and the welfare of the communities that depend on us—may be adversely affected.

We sincerely hope that this request will merit your most favorable consideration and support. Thank you for your continued partnership and commitment to rural electrification.
