COMMITTEE REPORT

No. 14 Series 2025

This refers to the Ordinance Amending Provincial Ordinance No. 2020-17 entitled "Revised Internal Rules of Procedure of the Sangguniang Panlalawigan of Leyte". Said proposed measure was duly approved on First Reading during the regular session held on July 30, 2025.

It is pertinent to note that Provincial Ordinance No. 2020-17 was passed and approved on November 27, 2020, thereby instituting a comprehensive framework of internal rules intended to govern the conduct, procedures, and official functions of the Sangguniang Panlalawigan of Leyte. Thereafter, the aforementioned ordinance was subjected to amendments and was accordingly adopted and approved on June 30, 2022 through Resolution No. 2022-325.

In view of the continuing necessity to promote legislative efficacy and procedural coherence, the instant proposal seeks to introduce further amendments to Provincial Ordinance No. 2020-17. After due and careful consideration, thorough evaluation, and deliberation, the Committee finds the proposed amendments to be proper, necessary, and consistent with the evolving needs of governance, thereby warranting favorable action to enhance the current rules of the Sangguniang Panlalawigan so that they may march apace with the progress of Leyte.

Wherefore, the Committee recommends the approval of the Ordinance Amending Provincial Ordinance No. 2020-17.

419 HON. CARLOS JERICHO "ICOT" PETILLA: GOVERNOR, PROVINCE OF LEYTE

420 Maupay na aga ha aton nga tanan!

421 First of all, I would like to thank our Vice Governor Leonardo Sany Javier Jr. and to our
422 District Board Members. I would also like to acknowledge RD Felix M. Basallaje, Jr., aton COA
423 Director dinhi ha Region 8. Also, to Almar A. Cubilla, an aton COA-Leyte Province Team
424 Leader.

425 You may be wondering kun nagaano kita didi yana. Actually, there was a proposed ELA.
426 ELA is Executive, Legislative Agenda where the Department Heads and the Legislators which
427 are the Board Member meet to synchronize the programs of the province for the next 3 years.
428 But I see them all the time, in fact I have lunch with them every now and then because they
429 have budget for Lunch, but the Governor has no budget, so I go to them every now and then.
430 And I see the Department Heads also every now and then. But what's the missing link? The
431 missing link probably is we are doing a lot of things here in the province pero as a whole, there
432 is a question on what is everybody doing? I know my part but I don't know what the rest is
433 doing. So, instead of an ELA, we decided na maupay siguro na aton ipresent an program not
434 to the Department Heads, not to the Board Members but present it to the team who makes
435 things happened. And that is all of you. To let you know what the Province of Leyte is doing
436 overall. Now, I have to time it na may ada session. Why? Because it iba ha iyo diri nakilala hit
437 mga Board Members like hit mga bag-o, correct? Yana la niyo nakit.an dba? Now you can see
438 that they all come with all forms of shapes and sizes. I also wanted to tell you and show you
439 how they do things kun nagsesession hira. Actually, these Board Members works and agrues
440 together for the betterment and that's why as what Honorable Gimenez said, "It's a green zone.
441 It's a peace zone." Pwede ha gawas aragway pero pag abot ha Capitolyo waray iton hra
442 aragway, bagkos naglalamanuhay. So, we are here to present to you kun ano an mga
443 programa han province but the problem is there are so many of them that we probably we can't
444 accommodate them in just a half day or even in one day. So, we summarized everything and
445 we cited the ones that are probably not common. So, ano na mga aspect in this government

446 that is something is notable and what is the direction of this government in the next 3 years.
447 This is what we will attempt to present to you but before we do any presentation. There is one

450 continue implementing this.
