378 (Php 18,541.00) per Month Effective FY 2025.

379 Under agenda Item No. 7 is Municipal Ordinance No. 13 of Villaba, Leyte an Ordinance
380 Implementing the Local Public Transport Route Plan C.Y. 2025-2029 of Villaba, Leyte Subject
381 to Full Compliance with all Applicable Laws, Rules, and Regulations.

382 Under agenda Item No. 8 is an Ordinance Granting Cash Incentives to Champion
383 Athletes of the Municipality of Villaba representing in Provincial, Regional, National and

412 Ordinance is not contrary to Section 335 as observed by the Provincial Legal Office. I am not
