#### **I. BACKGROUND**

The proposed ordinance aims to regulate the operation of pedicabs, motorized tricycles, and habal-habal within the territorial jurisdiction of Santa Fe, Leyte. It seeks to promote public safety, ensure orderly transport operations, and generate local revenue through the imposition of regulatory fees and penalties for violations.

The said ordinance was recommended to be declared valid by the Provincial Legal Office in its second endorsement, dated July 28, 2025; however, during the 5<sup>th</sup> regular session of the Sangguniang Panlalawigan, the undersigned chairperson noticed that Section 4 of the said ordinance, which is its fare matrix has some words and figures lacking, leaving some entries therein blank. For that reason, and for purposes of rectification, the undersigned moved that it be referred to this committee.

#### **II. ACTION TAKEN and FINDINGS**

The committee through the chairperson personally visited the Sangguniang Bayan of Santa Fe, Leyte on September 4, 2025 and was able to discuss the matter personally with the author of the ordinance SB Member Rodel Ajeto, who was able clarify the concern. The committee is now in receipt of the corrected version of the subject ordinance and is satisfied with the compliance made by the Sangguniang Bayan of Santa Fe, Leyte.

Likewise, after further review and due deliberation, the Committee finds the proposed ordinance to be compliant with the three tests of validity - substantive, procedural, and formal as follows:

#### **A. Substantive Validity**

- The ordinance promotes public welfare by regulating local transport modes that are widely used by constituents, especially in rural and interior barangays.
- It addresses safety concerns and traffic discipline, particularly in densely populated areas.
- The measure is reasonable, not oppressive, and aligned with the general welfare clause under Section 16 and 186 of the Local Government Code (Republic Act No. 7160).

#### **B. Procedural Validity**

- The ordinance underwent proper legislative processes, including:
  - the mandatory "Three Reading Rule"
  - Committee hearings and stakeholder consultations through a public hearing
  - Public posting and publication in accordance with Section 59, 187 and 188 of RA 7160

#### **C. Legal Validity**

The ordinance draws authority from the following legal provisions:

- Section 447(a)(3)(iii), RA 7160 – Grants the Sangguniang Bayan the power to regulate the operation of tricycles and similar vehicles within the municipality.
- Section 16, RA 7160 – General welfare clause empowering LGUs to enact measures that promote health, safety, and convenience of inhabitants.
- Section 153, RA 7160 – Authorizes LGUs to impose fees and charges for regulation purposes.
- Department of Transportation (DOTr) and DILG Joint Memorandum Circulars – Provide guidelines on local transport regulation, including habal-habal operations where no alternative modes exist.

### **III. RECOMMENDATION**

In view of the foregoing, the committee recommends for the approval of:

Municipal Ordinance No. 2019-07 of the Sangguniang Bayan of Santa. Fe, Leyte, entitled **"An Regulating the Operation of Pedicabs and Motorized Tricycles, to Include Habal-Habal Operating Within the Jurisdiction of Sante Fe, Leyte, Imposing Fees and Penalizing Violators Thereof"**

**C. Pedicab (pot-pot) for Hire** — The rate for pot-pot shall be fixed at Php 5.00. Bonafide students and registered Senior Citizens shall only pay Php 4.00 (discounted rate). However, considering that the route to Pilit and San Roque are quite far, the fare from the market area to Pilit is ₱ 20,00.00, same is true from the market area to San Roque, and vice versa. By the powers vested upon the Sangguniang Bayan by Section 447, paragraph A, sub paragraph VI of the Republic Act 7160, otherwise known as the Local Government Code of 1991, the Sangguniang Bayan of Santa Fe Leyte now ordains:

**Section 1. Title-** This Ordinance shall be known as the "Ordinance Regulating the Operation of Pedicabs (Pot-Pot), and Motorized Tricycles, to include "Habal-Habal" Operating within the jurisdiction of Santa Fe, Leyte imposing fees, and penalizing violators thereof;

**Section 2. Declaration of Policy-** To develop the local economy by maximizing the potential and contribution of the tricycle sector. To promote safety, and protect the riding public.

**Section 3. Definition of Terms-** According to this Ordinance, the following terms shall mean:

- a.) **Tricycle for Hire** - a motor vehicle composed of a motorcycle fitted with a single-wheeled sidecar or a two-wheeled cab operated to render transport services to the general public for a fee.
- b.) **Pedicab for Hire** - is a three-wheeled light passenger vehicle that the driver propels by pedaling, usually with the cab attached to the right side of a bicycle. Also locally known as "pot-pot" it operates to render transport services to the general public for a fee.
- c.) **Color Coding** - means non-operation of tricycle for hire for the specified color.
- d.) **Motorized Tricycle Operator's Permit (MTOPO)** — is the document granting a franchise or license to operate issued to a person, natural or juridical, allowing him/her/it to operate a tricycle-for-hire over a specified route.
- e.) **Pedi-cab Operator's Permit (POP)** — is the document granting franchise or license to operate issued to a person, natural or juridical, allowing him/her/it to operate a Pedicab for hire over a specified route.
- f.) **Habal-Habal-** is a highly improved two-wheeled single motorcycle usually ridden beyond its passenger capacity. Since it is used as public transportation, especially in areas with narrow roads and steeper, rougher terrain, it could carry up to two passengers.

**Section 6. Time and Manner of Payment** — The fees imposed in this Article shall be paid to the Municipal Treasurer upon filling out the application for the required permit. No application for a Motorized Tricycle Operator's Permit (MTO) or Pedicab Operator Permit (POP) shall be given due course without the Official Receipt/s attached to it showing payment of corresponding fees. The deadline for filling out the application is not later than the 20<sup>th</sup> day of January of every year.

**Section 7. Regulatory Acts:** The term of the MTO and POP is one (1) year subject to renewal. It may be suspended/canceled upon due hearing by the Sangguniang Bayan:

- a) No Motorized Tricycle Operator's Permit (MTO) shall be granted unless the applicant has unit/s with valid registration papers from the Land Transportation Office (LTO).
- b) Operators shall only employ drivers for tricycles who are duly licensed by the Land Transportation Office (LTO).
- c) No person shall drive a motorized tricycle or Pedi-cab-for-hire (pot-pot) unless at least 18 years old.
- d) The carrying capacity of Habal-Habal shall only be 3 persons including the driver;
- e) Passenger carrying capacity of motorized tricycles must only be 6 and must be strictly observed.
- f) Refusal to convey passengers is strictly prohibited.
- g) Overloading of passenger farm products and other cargo is strictly prohibited.
- h) Drivers must always WEAR PROTECTIVE HELMET and should practice proper grooming.
- i) Any person operating or driving a tricycle-for-hire or Pedi-cab-for-hire without necessary

Motorized Tricycle Operator's Permit (MTO) or Pedicab Operator Permit (POP) shall be punished by the following:

- First Offense - Php 200.00 (after 10 days for impounding and 50 pesos per day impounding fee for tricycle and 25 pesos for Pedicab.)
  - Second Offense - Php 300.00
  - Third Offense - Php 500.00 and cancellation of MTO/POP for that year.
- j) Late renewal of Motorized Tricycle Operator's Permit (MTO) and Pedi-cab Operator's Permit (POP) shall pay a fine of 2% penalty per month and 25% surcharge / Annum.
    - 1 ) For Motorized Tricycle Operator's Permit (MTO),
    - 2 ) For Pedicab Operator Permit (POP),

**Section 8. Parking of vehicles, motorized vehicles including tricycles, motorcycles, buses, jeepneys, habal-habal, and private vehicles shall park only at the designated parking places designed by the LGU.**

- a) Parking of tricycles and pot-pots along the National Highway from Zone 1 to Zone III to the waiting shed, is STRICTLY prohibited.

**Section 9. Penalty Clause:** There shall be an administrative fine for violation of any provision of this Ordinance:

- First offense - a fine of Php 200.00;
- Second offense - Php 500.00;
- Third offense - Php 1,000.00
- Succeeding offenses - imprisonment of not less than 5 days but not more than 30 days or both upon the discretion of the court and revocation of their Franchise or Business Permit.

**Section 10. - Repealing Clause:** All Ordinances of parts Inconsistent therewith are hereby repealed/ modified accordingly.

**Section 11. - Separability Clause:** If for any reason(s), any part of this Ordinance shall be unconstitutional or invalid, other parts thereof which are not affected thereby shall remain in full force and effect.

**Section 12. - Effectivity Clause:** This ordinance shall take effect after three (3) consecutive weeks by way of posting copies at the bulletin board of the municipal building and in at least three (3) conspicuous places within the municipality of Santa Fe, Leyte.
