

EXPLANATORY NOTE

Katuwang sa Diwa at Gawa para sa Masaganang Ani at Mataas na Kita (KADIWA) was launched and spearheaded by the Department of Agriculture (DA) in 2019, in collaboration with farmers and enterprises registered in the Sagip Saka Registry System for Basic Sectors Agriculture (RSBSA) which seek to empower the community by providing a direct and effective farm-to-consumer food supply chain. The implementation of this program is reiterated by the President Ferdinand R. Marcos, Jr. during his State of the Nation Address (SONA) citing “The KNP system enabled the public to buy goods at cheaper rates and the farmers to sell their crops without having to worry about transportation cost.”

Our One Town, One Product (OTOP), which is the ARASIP, a priority stimulus program for Micro, Small and Medium-Scale Enterprises (MSMEs) as government’s intervention to drive inclusive local economic growth. Thru the leadership of Department of Trade and Industry, OTOP enables localities and communities to determine, develop,

support, and promote products or services that are rooted in its local culture, community resource, creativity, connection, and competitive advantage.

The revival of the KADIWA food terminal shall be a big step towards providing for our citizens in depressed areas and further sparking awareness, particularly of which may spread towards the involvement of local farmers and large enterprises in production of said basic commodities. Poised towards revival, the KADIWA shall take different approach towards extending a hand towards those who are really in need of the said basic commodities. Unlike in the past where such a benefit has been made available to everybody, falling short of saturating the impoverished sector of the community. This has been due to the reason that as an instinctive response to lower priced basic commodities even those who are not necessarily in need of the assistance take much of the benefit given their financial capacity to purchase more than what is needed.

The Local Government Unit of Alangalang, Leyte shall take a more systematic approach towards really reaching out to our citizens below the poverty line. Further, enhancing our administration's capability to support the enterprise development by linking local produce to markets and shouldering transportation costs of farm produced by our local farmers, which facilities job creation and livelihood driver by business investment, increased productivity, and reduce consumer spending in the Municipality.

NOW THEREFORE, BE IT ORDAINED by the Sangguniang Bayan of Alangalang, Leyte in its Regular Session duly assembled:

SECTION 1. SHORT TITLE. This Ordinance shall be known as "Alangalang KNP Ordinance."

SECTION 2. OBJECTIVES. This Ordinance in intended to support the implementation of KADIWA ng Pangulo (KNP) in the Municipality of Alangalang, Leyte with DA, DTI, DOLE and DILG, with the aim of achieving the following objectives.

2.1 To increase participation of local farmers and enterprises as well consumers to KNP;

2.2 To ensure food security, delivery of nutritious food and access to affordable goods and commodities;

2.3 Support farmers to sell agri-produce, to facilitate product regional exchange of OTOP product, and to provide opportunity for local micro-entrepreneurs to market their products;

2.4 To provide market opportunities to MSMEs through local product promotion and eliminating as many marketing layers, allowing producers to earn bigger income from directly and selling their products instead of using trade-intermediaries;

SECTION 3. DEFINITIONS OF TERMS. As used and referred for in this Ordinance. The following, shall be understood. To mean, to wit:

1. KADIWA - Refers to the Katuwang sa Diwa at Gawa para Masaganang Ani at Mataas na Kita.
2. DA - Refers to the Department of Agriculture.
3. RSBA - Refers to Registry System for Basic Sector Agriculture.
4. SONA - Refers to the State of the Nation Address.
5. KNP - Refers to Kadiwa ng Pangulo.

6. OTOP - Refers to One Town One Product.
7. MSMEs - Refers to Micro Small and Medium-Scale Enterprises.
8. DTI - Refers Department of Trade and Industry.
9. DOLE - Refers to Department of Labor and Employment.
10. DILG - Refers to Department of the Interior and Local Government.
11. PDL - Refers to Persons Deprived of Liberty.
12. GSO - Refers to General Services Office.
13. OMA - Refers to the Office of Municipal Agriculture.
14. PESO - Refers to Public Employment Service Office.
15. MENRO - Refers to Municipal Environment and Natural Resources Office.
16. PNP - Refers to Philippine National Police.

SECTION 4. POLICY CONTENT AND GUIDELINES.

- 4.1 KNP shall run every 15th and 30th every month starting August 30, 2024
- 4.2 The grand launch held last June 1, 2024 commenced the opening of AGRI - AQUA FAIR to highlight the town fiesta celebration.
- 4.3 KNP shall have 3 market areas or product clusters;
- 4.4 Agriculture produce such as rice, vegetable and fruits of farmers for the various barangays;
- 4.5 Processed goods both food and non-food produce by MSMEs as OTOP products of different barangay and;
- 4.6 Mercato stalls (ready-to-eat-food) for micro-enterprises of the host LGU.
- 4.7 The venue of the KNP may be in a closed or an open space area provided there are available tents, tables and chairs. It should be well - ventilated and with areas that can accommodated stalls for selling products, area for eating and parking.
- 4.8 No registration fee shall be collected from participating farmer/MSME merchants nor from visiting consumers.

SECTION 5. ROLES AND RESPONSIBILITIES.

KADIWA ng Pangulo (KNP) is a joint program and collaborative arrangement among concern government agencies of national government and local government units. It also encourage full participation and support of non - government organizations, business sectors and cooperatives. The MLGU shall have following responsibilities in the implementation of KNP, as follows:





SECTION 6. MONITORING AND EVALUATION

The Office Municipal Agriculture (OMA) shall establish a monitoring and evaluation system in order to evaluate the impact on the economy, which shall provide the estimated number of people that visited the KNP, time and place of KNP activity, number of consumers and sellers/entrepreneurs that participated including the revenue generated during the KNP Day, and shall submit report DA copy furnished the DILG Alangalang.




SECTION 10. EFFECTIVITY CLAUSE. This Ordinance shall take effect upon approval of this Ordinance.
