**MUNICIPAL ORDINANCE NO. 2025-09**  
**SPONSOR: HON. KENT JEFFLORD C. GUILLERMO**

**“THE REVISED TUBERCULOSIS CARE ASSISTANCE PROGRAM (TBCAP) AND ITS IMPLEMENTING RULES AND REGULATIONS”**

**BE IT ORDAINED**, by the Sangguniang Bayan of Alangalang, Leyte in session assembled that –

**SECTION 1. TITLE**

This ordinance shall be called **“THE REVISED TUBERCULOSIS CARE ASSISTANCE PROGRAM (TBCAP) AND ITS IMPLEMENTING RULES AND REGULATIONS”**.

**SECTION 2. DECLARATION OF POLICY.**

It is hereby declared the policy of the Municipality of Alangalang to implement a Comprehensive Tuberculosis Care Assistance Program (TBCAP) in order to ensure the health and well-being of the people of Alangalang.

**SECTION 3. AUTHORITY AND PURPOSE.**

As provided for in Article II, Section 15 of the Philippine Constitution, it states that the “State shall protect and promote the right to Health of the people and to instill health consciousness among them”, and Article XIII, Section II further states that the State shall adopt an integrated and

comprehensive approach to health development which shall endeavor to make essential goods, health, and other social services available to all people at affordable cost. There shall be priority for the needs of the underprivileged, sick, disabled, women, and children. Further to carry out the objectives set to forth or to fully support the Millenium Development Goals (MDGs).

**SECTION 4.. SCOPE AND APPLICATION.**

This Ordinance shall be adopted by the Municipality in the implementation of the Tuberculosis Care Assistance Program (TBCAP).

**SECTION 5. UNDERTAKINGS OF THE MUNICIPALITY.**

5.1 The Local Government Unit shall ensure the prioritization and enrollment of all residents found to be TB presumptive case and women to PhilHealth.

5.2 The Local Government Unit shall set up a revolving fund for the TBCAP incentive scheme in the amount of P 100,000 and it shall be administered by the Municipal Treasurer. The fund shall be replenished at seventy-five percent (75%) utilization, subject to usual accounting and auditing rules and regulations. For its initial implementation, the LGU may use the MCP trust fund to supply the P 100,000 revolving fund if the LGU has no existing TB DOTS Package receipts from PhilHealth;

5.3 The Local Government Unit shall continuously appropriate the needed fund for the cash incentive from the Operating Cost of the PhilHealth TB DOTS Package Receipts to wit:

- a.) The TB-detected case patient shall receive a cash incentive for every facility visit or compliance to the treatment schedule herein set forth to cover all his expenses in terms of transportation, communication, supply, and food during his/her facility stay. The LGU may opt to adopt its own distribution scheme or the following proposed scheme of the P1,200.00 incentive.

**SECTION 7. REPEALING CLAUSE**

All Ordinances, executive orders, issuances including rules and regulations inconsistent with this ordinance are hereby repealed and/or modified accordingly.

**SECTION 8. EFFECTIVITY CLAUSE.** This ordinance shall take effect upon approval.
