This office opines that the subject Ordinance is, in general, within the legislative authority of the Sangguniang Bayan to repeal/amend its prior acts either expressly or by the passage of an essentially inconsistent resolution¹, subject to the availability of funds and to normal and regular accounting and auditing procedures. Hence, we recommend for the declaration of its validity.

ORDINANCE NO. 2025-010

AN ORDINANCE AMENDING AND REVISING MUNICIPAL ORDINANCE NO. 2024-23 OF CALUBIAN, LEYTE ENTITLED: “AN ORDINANCE REGULATING THE HOLDING OF DISCOS AND BENEFIT DANCES”, LOWERING THE PENALTIES TO BE IMPOSED THERETO.

WHEREAS, discos and benefit dances are the most popular and easily resorted to means of community entertainment at night, as well as of raising funds for community-based beneficial projects, including, but not limited to, the construction or repair of chapels and schools, repainting of courts or buildings, etc.;

WHEREAS, the participation in discos and benefit dances, is in line with the community’s empathy, compassion and its desire to help and contribute in community projects, while simultaneously enjoying at the same time the entertainment value it promises to give;

WHEREAS, in general, the benefit that discos or benefit dances give or promises to give to the community is of doubtless significance, however, in the absence of proper regulations, it is prone to unexpected turn of events such as the violence of patrons or attendees especially in their tired or drunken state;

WHEREAS, for the general welfare of the general public – taken in the context of the real security threats – it is hereby established that there is a need to regulate the holding of discos and benefit dances affecting the places, days and the span of time these are held;

WHEREAS, after a public hearing conducted on October 7, 2024, the Honorable Sangguniang Bayan enacted Municipal Ordinance No. 2024-23 entitled: “An Ordinance Regulating the Holding of Discos and Benefit Dances” on October 17, 2024 during the 98th Regular Session, which was later on approved by the Municipal Mayor Hon. Marciano A. Batiancela, Jr. on October 29, 2024;

WHEREAS, the Sangguniang Panlalawigan, in its Resolution No. 2024-526 during the 115th Regular Session held on December 3, 2024 stated:

“xxx Ordinance No. 2024-23, is generally in accordance with its power under Section 447(a) of the Local Government Code of 1991 (R.A. 7160). However, the penal provisions of the proposed Ordinance under Section 4 are in contravention with Section 447 (a) (1)(iii) of the Local Government Code. Hence, further review of the Proposed Ordinance is recommended; xxx

WHEREAS, the August Body, deemed it proper to return said ordinance to SB of origin; xxx

RESOLVED, as it is hereby resolved, to RETURN TO THE SANGGUNIANG BAYAN OF ORIGIN ORDINANCE NOS. 2024-2 OF CALUBIAN, LEYTE, FOR FURTHER REVIEW ON THE PENALTY PROVISION.”

WHEREAS, Section 447 (a)(1)(iii) of the Local Government Code provides that the Sangguniang bayan shall “Approve ordinances imposing a fine not exceeding Two thousand five hundred pesos (P2,500.00) or an imprisonment for a period not exceeding six (6) months, or both in the discretion of the court, for the violation of a municipal ordinance”, hence, there is a need to revise the aforementioned municipal ordinance;

WHEREAS, Municipal Ordinance No. 2024-23 is hereby adopted in its entirety but is however revised only as to the lowered penalty provision. Moreover, this Ordinance, upon approval of the Honorable Sangguniang Panlalawigan shall be published in lieu of the Municipal Ordinance No. 2024-23;

NOW, THEREFORE, on motion of SB Member Hon. Jullian Marc A. Batiancela, duly seconded by the Majority of all the Sangguniang Bayan members present;

BE IT ORDAINED, AS IT IS HEREBY ORDAINED, by the Sangguniang Bayan of Calubian, Leyte in session assembled, that:

Section 1. Objective. – This Ordinance shall regulate the holding of discos and benefit dances in an orderly, secure and peaceful manner.

Section 2. Issuance of Permit, Requirements. – The Office of the Municipal Mayor is hereby authorized to issue permits for the holding of discos and benefit dances, provided that ALL of the following conditions are present:

- 2.1. That a Barangay Clearance or Permit is first secured from the barangay concerned;
- 2.2. That the disco or benefit dance shall start not earlier than 7:00 in the evening and end not later than 4:00 in the early morning of the day following;

- 2.3. That the place where the disco or benefit dance is held shall be enclosed or fenced – in case it is held outside of a covered dance hall or a gym;
- 2.4. That minors shall not be admitted inside the dance arena at 10:00 in the evening and beyond such time;
- 2.5. That the benefit dance or disco shall only be held on Fridays or Saturdays, unless when the Annual Fiesta Celebration falls on another day;
- 2.6. That bringing of any form of firearms and other deadly weapon inside the dance arena is absolutely prohibited.
- 2.7. That after such disco or benefit dance is held, each Barangay is required to submit a Financial Report or Statement to the Municipal Mayor, as reportorial requirement. The same shall be a condition precedent and the compliance therewith is required for the issuance of the next request for permit, if any.

Section 3. Revocation of Permit, When Made. – The permit so issued may be recalled or revoked by the Municipal Mayor, based on an actual finding that any of the requirements enumerated in Section 2 of this Ordinance has not been complied with or is being violated. If peace and order is disturbed in the occasion of the disco or benefit dance, the Calubian Police may, at any time during such disturbance, halt or stop the benefit dance or disco, and the previously issued permit would thereafter be considered as automatically revoked.

Section 4. Holding of a Disco or Benefit Dance Without a Permit, Person/s Liable. – The Punong Barangay or the President of the organizing or sponsoring association or group or any responsible officer/s thereof shall be held liable for holding a disco or benefit dance in violation of any of the conditions enumerated in Section 2, for which a compromised penalty of TWO THOUSAND FIVE HUNDRED PESOS (Php 2,500.00) shall be imposed.

Any person who violates this Ordinance after the payment of the compromised penalty shall be charged a penalty of:

First Offense	Php 1, 000.00
Second Offense	Php 1, 500.00
Third Offense	Php 2, 500.00

Failure to pay the compromised penalty shall give rise to the filing of a case in court, for the conviction wherein a fine of TWO THOUSAND FIVE HUNDRED PESOS (Php 2,500) or *Thirty (30) Days as maximum period of imprisonment*, shall be imposed upon the violator at the discretion of the court.

Section 5. Separability Clause. If any provision of this Ordinance is declared invalid or unconstitutional, the remaining provision not affected thereby, shall continue to be in full force & effect.

Section 6. Repealing Clause. All ordinances, rules, and regulations, other issuances or parts thereof which are inconsistent with this Ordinance is hereby repealed, most specifically provisions under Municipal Ordinance No. 2024-23.

AN ORDINANCE AMENDING AND REVISING MUNICIPAL ORDINANCE NO. 2024-23 OF CALUBIAN, LEYTE ENTITLED: "AN ORDINANCE REGULATING THE HOLDING OF DISCOS AND BENEFIT DANCES", LOWERING THE PENALTIES TO BE IMPOSED THERETO.

WHEREAS, discos and benefit dances are the most popular and easily resorted to means of community entertainment at night, as well as of raising funds for community-based beneficial projects, including, but not limited to, the construction or repair of chapels and schools, repainting of courts or buildings, etc.:

WHEREAS, the participation in discos and benefit dances, is in line with the community's empathy, compassion and its desire to help and contribute in community projects, while simultaneously enjoying at the same time the entertainment value it promises to give;

WHEREAS, in general, the benefit that discos or benefit dances give or promises to give to the community is of doubtless significance, however, in the absence of proper regulations, it is prone to unexpected turn of events such as the violence of patrons or attendees especially in their tired or drunken state:

WHEREAS, for the general welfare of the general public – taken in the context of the real security threats – it is hereby established that there is a need to regulate the holding of discos and benefit dances affecting the places, days and the span of time these are held;

WHEREAS, after a public hearing conducted on October 7, 2024, the Honorable Sangguniang Bayan enacted Municipal Ordinance No. 2024-23 entitled: “An Ordinance Regulating the Holding of Discos and Benefit Dances” on October 17, 2024 during the 98th Regular Session, which was later on approved by the Municipal Mayor Hon. Marciano A. Batiancela, Jr. on October 29, 2024;

WHEREAS, the Sangguniang Panlalawigan, in its Resolution No. 2024-526 during the 115th Regular Session held on December 3, 2024 stated:

“xxx Ordinance No. 2024-23, is generally in accordance with its power under Section 447(a) of the Local Government Code of 1991 (R.A. 7160). However, the penal provisions of the proposed Ordinance under Section 4 are in contravention with Section 447 (a) (1)(iii) of the Local Government Code. Hence, further review of the Proposed Ordinance is recommended; xxx

WHEREAS, the August Body, deemed it proper to return said ordinance to SB of origin; xxx

RESOLVED, as it is hereby resolved, to RETURN TO THE SANGGUNIANG BAYAN OF ORIGIN ORDINANCE NOS. 2024-2 OF CALUBIAN, LEYTE, FOR FURTHER REVIEW ON THE PENALTY PROVISION.”

WHEREAS, Section 447 (a)(1)(iii) of the Local Government Code provides that the Sangguniang bayan shall “Approve ordinances imposing a fine not exceeding Two thousand five hundred pesos (P2,500.00) or an imprisonment for a period not exceeding six (6) months, or both in the discretion of the court, for the violation of a municipal ordinance”, hence, there is a need to revise the aforementioned municipal ordinance;

WHEREAS, Municipal Ordinance No. 2024-23 is hereby adopted in its entirety but is however revised only as to the lowered penalty provision. Moreover, this Ordinance, upon approval of the Honorable Sangguniang Panlalawigan shall be published in lieu of the Municipal Ordinance No. 2024-23;

NOW, THEREFORE, on motion of SB Member Hon. Jullian Marc A. Batiancela, duly seconded by the Majority of all the Sangguniang Bayan members present;

BE IT ORDAINED, AS IT IS HEREBY ORDAINED, by the Sangguniang Bayan of Calubian, Leyte in session assembled, that:

Section 1. Objective. – This Ordinance shall regulate the holding of discos and benefit dances in an orderly, secure and peaceful manner.

Section 2. Issuance of Permit, Requirements. – The Office of the Municipal Mayor is hereby authorized to issue permits for the holding of discos and benefit dances, provided that ALL of the following conditions are present:

- 2.1. *That a Barangay Clearance or Permit is first secured from the barangay concerned;*
- 2.2. *That the disco or benefit dance shall start not earlier than 7:00 in the evening and end not later than 4:00 in the early morning of the day following;*

- 2.3. That the place where the disco or benefit dance is held shall be enclosed or fenced – in case it is held outside of a covered dance hall or a gym;
- 2.4. That minors shall not be admitted inside the dance arena at 10:00 in the evening and beyond such time;
- 2.5. That the benefit dance or disco shall only be held on Fridays or Saturdays, unless when the Annual Fiesta Celebration falls on another day;
- 2.6. That bringing of any form of firearms and other deadly weapon inside the dance arena is absolutely prohibited.
- 2.7. That after such disco or benefit dance is held, each Barangay is required to submit a Financial Report or Statement to the Municipal Mayor, as reportorial requirement. The same shall be a condition precedent and the compliance therewith is required for the issuance of the next request for permit, if any.

Section 3. Revocation of Permit, When Made. – The permit so issued may be recalled or revoked by the Municipal Mayor, based on an actual finding that any of the requirements enumerated in Section 2 of this Ordinance has not been complied with or is being violated. If peace and order is disturbed in the occasion of the disco or benefit dance, the Calubian Police may, at any time during such disturbance, halt or stop the benefit dance or disco, and the previously issued permit would thereafter be considered as automatically revoked.

Section 4. Holding of a Disco or Benefit Dance Without a Permit, Person/s Liable. – The Punong Barangay or the President of the organizing or sponsoring association or group or any responsible officer/s thereof shall be held liable for holding a disco or benefit dance in violation of any of the conditions enumerated in Section 2, for which a compromised penalty of TWO THOUSAND FIVE HUNDRED PESOS (Php 2,500.00) shall be imposed.

Any person who violates this Ordinance after the payment of the compromised penalty shall be charged a penalty of:

Failure to pay the compromised penalty shall give rise to the filing of a case in court, for the conviction wherein a fine of TWO THOUSAND FIVE HUNDRED PESOS (Php 2,500) or *Thirty (30) Days as maximum period of imprisonment*, shall be imposed upon the violator at the discretion of the court.

Section 5. Separability Clause. If any provision of this Ordinance is declared invalid or unconstitutional, the remaining provision not affected thereby, shall continue to be in full force & effect.

Section 6. Repealing Clause. All ordinances, rules, and regulations, other issuances or parts thereof which are inconsistent with this Ordinance is hereby repealed, most specifically provisions under Municipal Ordinance No. 2024-23.

Section 7. Effectivity. This Ordinance shall take effect after fifteen (15) days from posting and publication, immediately upon approval of the Municipal Mayor and the Honorable Sangguniang Panlalawigan of Leyte.




