Gentlemen and Ladies:

Pursuant to the provisions of the Local Government Code of 1991 (Republic Act No. 7160), our preliminary review of the **General Fund Supplemental Budget No. 02 FY 2025** of the **Municipality Burauen, Leyte** duly enacted by the Sangguniang Bayan through **Appropriation Ordinance No. 25-34** with a total appropriation in the amount of **P3,379,270.31** reveals compliance with the same law and its implementing Rules and Regulations.

A RESOLUTION ADOPTING THE SUPPLEMENTAL ANNUAL INVESTMENT PROGRAM (AIP) NO. 5, FOR CALENDAR YEAR 2021, OF THE MUNICIPALITY OF BURAUEN, LEYTE, AS EMBODIED IN MDC RESOLUTION NO. 2021-07, SERIES OF 2021, OF THE MUNICIPAL DEVELOPMENT COUNCIL WITH THE TOTAL AMOUNT OF TWENTY FOUR MILLION ONE HUNDRED TWENTY SEVEN THOUSAND PESOS AND SEVENTY ONE CENTAVOS (PHP 24,127,961.71), INTENDED TO FINANCE THE PROGRAMS/PROJECTS OF THE LOCAL GOVERNMENT UNIT OF BURAUEN, LEYTE

WHEREAS, by virtue of MDC Resolution No. 2021-07, series of 2021, the Supplemental Annual Investment Program No. 5 for Calendar Year 2021, of the Municipality of Burauen, Leyte, was unanimously approved and endorsed by the members of the Municipal Development Council, for adoption of the Sangguniang Bayan, in compliance with existing rules and regulations, considering the implementation of a priority program/project of the LGU which was not funded, and PPA was not included in the regular AIP, but require prompt action, amounting to Twenty four Million One Hundred Twenty Seven Thousand Nine Hundred Sixty One Pesos and Seventy One Centavos (PHP 24,127,961.71), as follows:
