**COMMITTEE ON WAYS AND MEANS**  
COMMITTEE REPORT No. 15 series of 2025

Referred to this Committee is a letter from the Provincial Governor, Carlos Jericho L. Petilla, requesting the August Body for the amendment of Provincial Ordinance No. 2024-01, entitled "An Ordinance Levying Fees and Charges for the Use of Facilities and Equipment Owned by the Provincial Government of Leyte, Series of 2024."

The proposed amendment seeks to insert Sub-section 8.1 under Section 8 of the ordinance, which shall authorize the grant of a three percent (3%) discount on payments made through the Provincial Government's Online Payment System, integrated in the eBooking System. The objective of this proposed insertion is to encourage greater utilization of digital payment platforms, enhance operational efficiency, promote ease of doing business, and foster broader adoption of online government services.

Upon due deliberation, the Committee finds that the proposed amendment is reasonable, practical, and consistent with the policy of the Provincial Government to modernize administrative systems and enhance the delivery of public services. The adoption of a digital incentive mechanism is viewed as a progressive measure to transition constituents toward the use of secure, convenient, and efficient online platforms, thereby reducing dependence on manual processes.

Hence, the Committee recommends the approval of the proposed amendment.

Be it enacted by the Sangguniang Panlalawigan of Leyte in session assembled:

**Section 1. Amendment.** Ordinance No. 2024-01 entitled "An Ordinance Levying Fees and Charges for the Use of Facilities and Equipment Owned by the Provincial Government of Leyte Series of 2024" is hereby amended by inserting a new sub-section 8.1 under Section 8 to read as follows:

*"Section 8. (xxx)*

*8.1 To encourage and maximize the use of online payments, the Province shall grant a three percent (3%) discount for payments made through the Online Payment option in the eBooking System."*

**SECTION 2. Separability Clause.** If, for any reason, any provision of this Ordinance is declared unconstitutional or invalid, the other provisions not affected thereby shall remain in full force and effect.

**SECTION 3. Repealing Clause.** All ordinances, executive orders, and other issuances inconsistent with this Ordinance are hereby repealed or modified accordingly.

**Section 4. Effectivity.** This ordinance shall take effect immediately upon approval.

661 Barangay Clearances. There's no quarrel, Mr. Chair, because we really collect Barangay  
662 Clearance fee. But in this case, it is the Sangguniang Bayan who established the fees. Maybe  
663 our Committee on Rules can enlighten us. We can do that.

681 Bayan will be the one to impose fees to be collected in obtaining a Barangay Clearance? I  
682 believe there's also a local autonomy of the barangay and they're the ones who should be the  
683 one enacting the respective Ordinances in the collection of the barangay fees. So, I think the  
684 question of Board Member Uy is correct, that it should not be the Sangguniang Bayan who  
685 shall be the one imposing the said rate because I think it is beyond the authority of the  
686 Sangguniang Bayan, but the authority of the Barangay Council.
