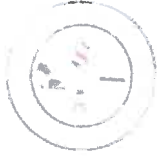

A RESOLUTION ENDORSING AND INTERPOSING NO OBJECTION TO BUSINESS OPERATION OF COLLECTING, HANDLING, TRANSPORTING, STORING, TREATING, AND DISPOSING OF, INCLUDING BUT NOT LIMITED TO INDUSTRIAL AND MEDICAL HAZARDOUS WASTES AT CLEANAWAY PHILIPPINES INC. (CPI) IN LIDE INDUSTRIAL DEVELOPMENT ESTATE (LIDE), BARANGAY LIBERTAD, ISABEL, LEYTE.

WHEREAS, presented before this body project profile BUSINESS OPERATIONS OF COLLECTING, HANDLING, TRANSPORTING, STORING, TREATING, AND DISPOSING OF, INCLUDING BUT NOT LIMITED TO INDUSTRIAL AND MEDICAL HAZARDOUS WASTES;

WHEREAS, CPI with its representatives and/in coordination with Local Officials has conducted Multi-Sectoral Consultations and Technical Presentation in our barangay to fully address/clarify issues and concerns with regards to the project;

WHEREAS, to fully realize that development if for the people, CPI must effectively and religiously operate the facility to protect the local environment from the harmful nature of industrial and medical hazardous wastes in accordance with Republic Act 6969 (An Act to Control Toxic

Substances and Hazardous and Nuclear Wastes), so as to avoid the dangers of contamination with the rising volume of waste generation;

WHEREAS, the operation of such facility will assist the barangay, local and provincial government to properly implement environmental laws particularly on industrial and medical hazardous wastes monitoring at par with the current demands on proper treatment and disposal of these kind of wastes;

WHEREAS, said project will boost the socio-economic, industrial development and environmental-health protection not only of LIDE but the whole barangay of Libertad, Isabel, Leyte;

WHEREAS, environmental mitigating measures must be implemented by CPI during operational phase in consonance to the prevalent national environmental and health laws mandated by the Department of Environment and Natural Resources and the Department of Health;

WHEREAS, it was agreed that 70-80 (%) of the total workforce shall be hired from Barangay Libertad. Provided however, that the applicant(s) shall pass all the requirements and qualifications of the company.

WHEREAS, it was further agreed that CPI shall extend financial assistance amounting to P20,000 every Annual celebration of Araw ng Barangay Libertad and provide assistance to other local programs of Barangay Libertad as endorsed by the Barangay Chairman.


