RESOLUTION NO. 036-SY2025

A RESOLUTION FOR THE REVISION OF RESOLUTION NO, 028 S2025 WHICH RESOLUTION SHOULD BE ADDRESSED TO THE SANGGUNIANG PANLALAWIGAN OF LEYTE, REQUESTING FOR THE CLOSURE OF TABONTABON TO BRGY. DIGAHUNGAN, DAGAMI, LEYTE ROAD SECTION FOR VEHICLES ABOVE TWO AND ONE HALF (2.5) TONS UNTIL SUCH TIME THAT THE DEFECTIVE BOX CULVERT BRIDGE IS REPAIRED OR REPLACED AND CERTIFIED SAFE FOR VEHICULAR TRAFFIC.

WHEREAS, the Municipality of Tabontabon recognizes its duty to protect life, property, and infrastructure by ensuring that public roads, bridges, and other facilities within its territorial jurisdiction are safe for public use;

WHEREAS, it has been reported that the existing box culvert bridge along the Tabontabon–Brgy. Digahungan, Dagami, Leyte road section has been found defective and poses a significant risk of collapse if subjected to heavy vehicular loads;

WHEREAS, continuous passage of vehicles weighing more than two and one-half (2.5) tons over the said structure may aggravate the damage, compromise the safety of the riding public, and further endanger the stability of the road section;

WHEREAS, under Section 21 of Republic Act 7160, otherwise known as the Local Government Code of 1991, local government units may, through their respective sanggunian, regulate the use of municipal, provincial roads and bridges within their jurisdiction in the interest of public welfare and safety;

NOW THEREFORE, on motion by Hon. Francisco M. Fernandez, unanimously seconded;

BE IT RESOLVE, AS IT IS HEREBY RESOLVED to revise Resolution No. 028 S2025 which resolution should be addressed to the Sangguniang Panlalawigan of Leyte, requesting for the closure of Tabontabon to Brgy. Digahungan, Dagami, Leyte road section for vehicles above two and one half (2.5) tons until such time that the defective box culvert bridge is repaired or replaced and certified safe for vehicular traffic;
