

AN ORDINANCE GRANTING A FRANCHISE TO OPERATE A MOTORIZED TRICYCLE-FOR-HIRE WITHIN THE TERRITORIAL JURISDICTION OF THE MUNICIPALITY OF BURAUEN, LEYTE

WHEREAS, Section 447(a)(3)(vi) of Republic Act No. 7160, otherwise known as the Local Government Code of 1991, empowers the Sangguniang Bayan to regulate the operation of tricycles-for-hire and grant franchises for their operation within the municipality;

WHEREAS, the Municipal Tricycle Franchising and Regulatory Board (MTFRB), through the Business Permits and Licensing Officer (BPLO), has endorsed the application of Mr. Francisco Jr. R. Redondo as a qualified applicant for a new motorized tricycle-for-hire franchise;

WHEREAS, the Committee on Transportation, Public Utilities, and General Services favorably recommended the granting of the said franchise;

NOW, THEREFORE, upon the motion duly made and seconded, be it enacted by the Sangguniang Bayan of Burauen, Leyte, in session assembled:

Section 1. GRANT OF FRANCHISE. A franchise is hereby granted to FRANCISCO JR. R. REDONDO to operate one (1) unit of motorized tricycle-for-hire along the Poblacion route within the territorial jurisdiction of the Municipality of Burauen, Leyte.

Section 2. VEHICLE SPECIFICATIONS. The authorized unit shall have the following specifications:

Make:	RUSI
Engine No.:	RW162FMJJA100643
Chassis No.:	RWCLPK203RE100643
LTO Plate No.:	H819CS

Section 3. COMPLIANCE. The grantee shall comply with all applicable rules and regulations of the Municipality of Burauen and the Land Transportation Office (LTO), and shall secure the necessary permits and clearances for the continued operation of the franchise.

Section 4. EFFECTIVITY. This Ordinance shall take effect immediately upon approval.

ENACTED, this 17th day of July 2025, at the Municipality of Burauen.




