AN ORDINANCE GRANTING A FRANCHISE TO OPERATE A MOTORIZED TRICYCLE-FOR-HIRE WITHIN THE TERRITORIAL JURISDICTION OF THE MUNICIPALITY OF BURAUEN, LEYTE

WHEREAS, Section 447(a)(3)(vi) of Republic Act No. 7160, otherwise known as the Local Government Code of 1991, empowers the Sangguniang Bayan to regulate the operation of tricycles-for-hire and grant franchises for their operation within the municipality;

WHEREAS, the Municipal Tricycle Franchising and Regulatory Board (MTFRB), through the Business Permits and Licensing Officer (BPLO), has endorsed the applications of the following individuals as qualified applicants for motorized tricycle-for-hire franchises:

WHEREAS, the Committee on Transportation, Public Utilities, and General Services favorably recommended the granting of the said franchise;



ENACTED, this 24th day of July 2025, at the Municipality of Burauen.




