

**AN ORDINANCE APPROVING THE REQUEST FOR DROPPING AND CHANGE OF UNIT OF A MOTORIZED TRICYCLE-FOR-HIRE FRANCHISE REGISTERED UNDER DEXTER A. PALITA WITHIN THE MUNICIPALITY OF BURAUEN, LEYTE**

**WHEREAS**, Section 447(a)(3)(vi) of Republic Act No. 7160, otherwise known as the Local Government Code of 1991, empowers the Sangguniang Bayan to regulate the operation of tricycles-for-hire and grant franchises for their operation within the municipality;

**WHEREAS**, the Municipal Tricycle Franchising and Regulatory Board (MTFRB), through the Business Permits and Licensing Officer (BPLO), has endorsed the request of **Mr. Dexter A. Palita** for the **dropping and change of unit** under his existing motorized tricycle-for-hire franchise;

**WHEREAS**, the Committee on Transportation, Public Utilities, and General Services favorably recommended the granting of the said franchise;

**NOW, THEREFORE**, upon the motion duly made and seconded, be it enacted by the Sangguniang Bayan of Burauen, Leyte, in session assembled:

**Section 1. APPROVAL OF CHANGE OF UNIT.** The request of Mr. Dexter A. Palita for the dropping of his previous unit and substitution with a new unit under his existing franchise is hereby approved, as follows:


**Section 3. EFFECTIVITY.** This Ordinance shall take effect immediately upon approval.
