

HELD AT THE SESSION HALL ON SEPTEMBER 1, 2025

ORDINANCE NO. 2025-08

“AN ORDINANCE ESTABLISHING THE SANGGUNIANG KABATAAN (SK) OFFICES AND MANDATING THE ALLOCATION OF SPACE IN THEIR BARANGAY SITES AND/OR MULTI-PURPOSE HALLS”

INTRODUCED BY: HON. BERNARD JOEY D. MESTULA

SECTION 1. TITLE - This ordinance shall be known as “SK OFFICE ESTABLISHMENT ORDINANCE OF ALBUERA.”

SECTION 2. DECLARATION OF POLICY- It is hereby declared as policy of the municipality to establish adequate, effective, responsive and enabling mechanism and support system to address the needs of the youth, among which is the establishment of a Sangguniang Kabataan office which shall also be used as Barangay Youth Center within the Barangay Hall of each barangay within the jurisdiction of the Municipality of Albuera.

SECTION 3. DEFINITION OF TERMS - For purposes of this ordinance, the following terms are hereby defined:

- a. Youth - Republic Act 10742 or the "Sangguniang Kabataan Reform Act of 2015" refers the youth to those persons whose ages range from fifteen (15) to thirty (30) years old as defined in Republic Act No. 8044.
- b. Sangguniang Kabataan - is a council meant to represent the youth in each barangay in the Philippines.
- c. SK Office -refers to the room or building where the SK officials performs their official works and functions.

SECTION 4. MAINTENANCE AND IMPROVEMENT OF SK OFFICE- The SK officials concerned, establishing the office in the barangay multi- purpose hall are tasked to improve and beautify their office through the procurements of chairs, tables, computer set, printer, air condition and other office materials and equipment under capital outlay or MOOE chargeable to SK fund, subject to usual accounting and auditing rules and regulations.

SECTION 5. ALLOCATION OF SPACE - Every Barangay Local Government Unit (BLGU) within the jurisdiction of the Municipality of Albuera, Leyte is required to provide an office space in the existing Multi-Purpose Hall to serves as office of the Sangguniang Kabataan concerned. Likewise, the BLGU and Sangguniang Kabataan concerned in the barangay are tasked to identify an available lot portion in the barangay site for the construction of the Sangguniang Kabataan office whenever they have funding for the purpose. However, if the BLGU has an existing vacant or unused building, they may allow the SK to use the same under any terms and conditions to be provided for in a resolution. The BLGU may donate the same to its Sangguniang Kabataan.

SECTION 6. SEPARABILITY CLAUSE - If any provision of this ordinance is held invalid or unconstitutional, the same shall not affect the validity and effectivity of the other provisions hereof.


SECTION 7. REPEALING CLAUSE - Pertinent provisions of all other laws, ordinances, executive orders and rules and regulations contrary to or inconsistent with the provisions of this ordinance are hereby repealed or modified accordingly.

SECTION 8. EFFECTIVITY CLAUSE - This ordinance shall take effect 15 days upon its approval and after due compliance with all the requirements provided under R.A. 7160. Otherwise known as the Local Government Code of 1991.




