





SECTION 3. There is hereby imposed fees for the acquisition of auction documents/bidding documents as follows :

a) Floor Price	Maximum Cost of Public Auction in Docs/Bidding Docs
P100,000.00 and below	- P 500.00
More than P 100,000.00 up to P500,000.00	- P 1,000.00
More than P500,000.00 up to P 1,000,000.00	- P 1,500.00
More than P 1,000,000.00	- P 2,000.00
b) Certifications (ADC related)	- P 150.00
c) Replacement Document	- P 100.00

SECTION 4. All fees shall be paid to the Municipal Treasurer or his/her authorized representative and the payment made is non-refundable ;

SECTION 5. This ordinance shall take effect immediately upon approval.


