**AN ORDINANCE IMPOSING FEES ON ULTRASOUND PROCEDURE AT THE JAVIER MUNICIPAL INFIRMARY OF THE MUNICIPALITY OF JAVIER, LEYTE.**

**WHEREAS**, all Local Government Units are mandated to generate resources and revenues thru, among others, the imposition of reasonable fees and charges for all services rendered to private persons and entities ;

**NOW THEREFORE**, be it enacted by the Sangguniang Bayan of Javier, Leyte, **THAT** :

**SECTION 1.** The enactment shall be known as " AN ORDINANCE IMPOSING FEES ON ULTRASOUND PROCEDURE AT THE JAVIER MUNICIPAL INFIRMARY OF THE MUNICIPALITY OF JAVIER, LEYTE".

**SECTION 2.** The following fees shall be collected for the Ultrasound Procedure conducted at the Javier Municipal Infirmary:

**SECTION 3.** Indigent patients who are residents of Javier, Leyte are exempted from payment of the Ultrasound Procedure availed, provide that, a Certificate of Indigency issued by the Municipal Social Welfare and Development Office (MSWDO) must first be submitted to Javier Municipal Infirmary.

All Municipal Officials, Employees , Contract of Service and Job Orders can avail a Twenty Percent (20%) discount of payment for the Ultrasound Procedure availed, provided that, a Certificate of Employment or Certification of Contract of Service issued by the Human Resource Officer must first be submitted to the Javier Municipal Infirmary.

**SECTION 4.** Payment shall be made at the Office of the Municipal Treasurer.

**SECTION 5.** If for any reason, any provision of this Ordinance shall be declared not valid by any court of competent jurisdiction, such judgement shall not affect the other provisions or part thereof which shall continue to be in force and effect.

**SECTION 6.** All Ordinances, Resolutions, Rules, and Regulations or any part thereof which are in conflict with or inconsistent with the provision of this ordinance are hereby repealed or modified accordingly.






