

WHEREAS, health is a fundamental human right and a key component of inclusive development, and it is the duty of the State, through all levels of government, to ensure accessible, quality, and equitable healthcare services for all;


WHEREAS, Republic Act No. 11223, otherwise known as the Universal Health Care Act, mandates the transformation of the health system to be more responsive and people-centered, with Primary Care Facilities as the foundation of effective service delivery;

WHEREAS, the Department of Health (DOH), through Administrative Order No. 2020-0047, established the policies and procedures for the licensing of Primary Care Facilities, setting the minimum standards to ensure safe, effective, and quality primary care services across the country;


WHEREAS, the Municipal Health Officer of Mayorga, with the support of the Local Chief Executive, has proposed the formal transition of the existing Rural Health Unit (RHU) into a Primary Care Facility in accordance with DOH guidelines, starting with its renaming to reflect its new role and function;

WHEREAS, the proposed renaming and institutional support are vital steps in achieving full licensing and accreditation as a Primary Care Facility, which will lead to better access to essential health services, health promotion, disease prevention, early detection, and management of common illnesses for the people of Mayorga;

WHEREAS, the Sangguniang Bayan recognizes the importance of aligning the municipality's health programs with national policies and affirms its full support to initiatives that strengthen the capacity, infrastructure, workforce, and operations of local health facilities;

WHEREFORE, on motion of the **Honorable Mark Cloyd M. Tan-piengco**, duly seconded by the **Honorable Ronnie S. Saballa**; be it

NOW THEREFORE, BE IT ENACTED, AS IT IS HEREBY ENACTED, BY THE SANGGUNIANG BAYAN OF MAYORGA, IN SESSION ASSEMBLED, BY VIRTUE OF THE POWERS VESTED IN IT BY LAW, THAT:

SECTION 1. TITLE.

This ordinance shall be known as the "MAYORGA PRIMARY CARE FACILITY ORDINANCE OF 2025."

SECTION 2. OFFICIAL RENAMING.

The existing **Rural Health Unit (RHU)** located at **Poblacion Zone III Mayorga, Leyte**, is hereby officially renamed as the "**Mayorga Primary Care Facility.**"

This change shall reflect in all government records, signages, official communications, and public documents of the Municipal Government.

SECTION 3. DECLARATION OF POLICY.

It is hereby declared the policy of the Municipal Government of Mayorga to:

- Institutionalize and strengthen primary care services as the frontline of the local health system;
- Comply with national standards and requirements set forth by the Department of Health under Administrative Order No. 2020-0047 and other related issuances;
- Support the licensing, implementation, and sustained operations of the Mayorga Primary Care Facility;
- Ensure that quality healthcare is available, accessible, acceptable, and affordable to all residents of the municipality.


SECTION 4. COMPREHENSIVE SUPPORT FOR LICENSING AND IMPLEMENTATION.


The Municipal Government shall extend full technical, administrative, and financial support necessary for the following:

1. Infrastructure upgrades and improvements of the health facility;

2. Procurement of essential equipment, instruments, and supplies required under DOH licensing standards;
3. Capacity building and training of healthcare personnel in line with service delivery goals;
4. Provision of essential drugs, diagnostics, and information systems for health service delivery;
5. Formulation of local health plans and monitoring mechanisms to ensure compliance and quality improvement.

SECTION 5. BUDGETARY APPROPRIATION AND FUNDING.

The Municipal Government shall allocate funds annually for the operation and development of the Mayorga Primary Care Facility, which may be sourced from:

- Regular appropriations under the General Fund;
- Local Development Fund (LDF);
- Grants or subsidies from national government agencies and donors;
- Other sources as may be authorized by law.

Supplemental budgets may be prepared when additional funding is required to meet licensing and compliance milestones.

SECTION 6. IMPLEMENTATION AND MONITORING.

The Municipal Health Officer, in coordination with the Office of the Municipal Mayor, the Municipal Planning and Development Coordinator, and the Municipal Budget Officer, shall be responsible for the implementation, planning, documentation, and submission of reports in relation to this Ordinance.

The Sangguniang Bayan Committee on Health and Sanitation shall conduct regular oversight functions to ensure accountability and progress.

SECTION 7. INFORMATION AND ADVOCACY.

The Municipal Government shall conduct information dissemination, community engagement, and advocacy programs to raise awareness about the role, services, and benefits of the Primary Care Facility to the public.

SECTION 8. SEPARABILITY CLAUSE.

If any provision of this Ordinance or any part thereof be declared invalid or unconstitutional, the remaining provisions not affected thereby shall continue in full force and effect.

SECTION 9. APPLICABILITY CLAUSE.

All other matters related to the impositions of this ordinance shall be governed by the pertinent provisions of existing laws and other ordinances.

SECTION 10. REPEALING CLAUSE.

All ordinances, resolutions, executive orders or regulations and other issuances inconsistent with the provisions and/or purposes of this Ordinance are hereby repealed, amended or modified accordingly.




This ordinance shall take effect immediately upon the date of its approval.


