



MUNICIPAL ORDINANCE NO. (244) 220

AN ORDINANCE IMPOSING FEES AND CHARGES FOR THE USE OF THE PANDAY ELOY BUILDING.

SECTION 1. Short Title- this Ordinance shall be known as the "Panday Eloy Building Usage Fee Ordinance".

SECTION 2. Definition of Terms – When used in this Ordinance, the foregoing terms shall be construed as follows:

1. Rental – the fee paid for the temporary use of a property or facility of the Municipal Government of Matag-ob
2. Day – 6AM to 5PM
3. Night – 6PM to 3AM

SECTION 3. Scope- this ordinance shall cover rental, fees and charges of the newly constructed new evacuation center, otherwise known as Panday Eloy Building.

SECTION 4. Rental – for the use of Panday Eloy Building shall be as follows:





SECTION 5. Payment of Fees – Payment of fees shall be made to the Municipal Treasurer only. Occupancy shall only be allowed after the application for Lease have been approved and signed by the Municipal Mayor, and all the fees and charges have been paid.

Section 6. EXEMPTIONS – the following entities shall be exempt from paying the venue rental but they shall have to pay the electricity consumption:

- a. Dep Ed
- b. Other Government Offices/Agencies

SECTION 7. Penal Clause/Administrative Provision – Any applicant who fails to comply with the provisions stipulated in the Application Form and any provision of this ordinance shall be subject to disapproval of his/her Application.

SECTION 8. Separability Clause - If, for any reason, any section or provision of this ordinance, or any part thereof, or the application of such section, provision or portion is declared invalid or unconstitutional, the remainder thereof shall not be affected by such declaration.

SECTION 9. Amendments Clause. This ordinance may be amended or modified as necessary through the appropriate legislative process.

SECTION 10. Effectivity- This Ordinance shall take effect upon approval.
