

AN ORDINANCE IMPOSING RENTAL FEE FOR THE USE OF GOVERNMENT FACILITIES AND EQUIPMENTS OWNED BY THE MUNICIPAL GOVERNMENT OF KANANGA, LEYTE.

WHEREAS, The Local Government Unit of Kananga owns the Two (2) Storey Multi-Purpose, Evacuation Center (PAGCOR Building), One (1) Storey Evacuation Center, One (1) Storey Quarantine Center, 1 unit of Backhoe and Self-Loading Truck for the different functions and activities of the LGU-Kananga, Leyte;

WHEREAS, other government agencies and private sectors may have interest to avail of the use of the Two (2) Storey Multi-Purpose Evacuation Center (PAGCOR Building), One (1) Storey Evacuation Center, One (1) Storey Quarantine Center, 1 unit of Backhoe and Self-Loading Truck for their functions and activities.

WHEREAS, these government facilities need maintenance for their operation and use;

NOW THEREFORE, be it ordained by the Sangguniang Bayan of the Municipality Kananga, Leyte, as follows:

SECTION 1: There shall be fee to be imposed for the Rental of the following properties of LGU-Kananga to wit:

- a. Rentals for Multi-purpose Evacuation Center (PAGCOR Building)
 - a.1 Rental Per Hour with aircon - Php 1,200.00
 - a.2 Rental Per Hour without Aircon - Php 150.00
- b. Rentals for Evacuation Center (One (1) Storey Building)
 - b.1 Rental Per Hour with aircon - Php 900.00
 - b.2 Rental Per Hour without Aircon - Php 150.00
- c. Rentals for one (1) Storey Quarantine Center
 - c.1 Rental Per Hour with aircon - Php 900.00
 - c.2 Rental Per Hour without Aircon - Php 150.00
- d. Self-Loading Truck
 - d.1 Rental per Hour - Php 700.00

SECTION 2: Exemption of payment. Governmental use which may be facilitated by the local offices of the LGU Kananga or by any of the National Government Agencies or Offices

[Handwritten signatures and initials]

may be exempted from payment after submission of satisfactory proof and permission/approval as mentioned in the next section of this Ordinance.

SECTION 3. Permission must be first secured. The supposed user shall first secure permission from the Office of the Mayor or Office of the Municipal Administrator before arranging the payments to be made at the Municipal Treasurer's office for disposition.

SECTION 4: Time of payment. Payment shall be made before the use of the above-mentioned facility.

SECTION 5: Guidelines shall be issued. The Municipal Mayor shall formulate measures to carry out the effective implementation of this ordinance.

SECTION 6: Penal Clause. Any violation of the provisions of this ordinance shall be fined of not less than Php 1,000.00 but not more than Php 1,500.00 or an imprisonment of not less than one (1) week but not more than 2 weeks at the discretion of the court.

SECTION 7: Effectivity. This ordinance shall take effect upon the approval.


