



MUNICIPAL ORDINANCE NO. 25-005

AN ORDINANCE APPROVING THE RATES OF FEES OF THE SERVICES, FACILITIES, AND AMENITIES OFFERED IN THE INLAND RESORT HOTEL SITUATED IN BARANGAY MALINAO, MAHAPLAG, LEYTE.

BE IT ENACTED, as it is hereby enacted, by the Sangguniang Bayan of Mahaplag, Leyte, in session assembled:

Section 1. AUTHORITY AND PURPOSE. This is in accordance to Section 17 (a)(b)(2)(ix) and (xi) of the Local Government Code of 1991 (RA 7160) mandating that local government units shall endeavor to be self-reliant and shall exercise such other powers and discharge such other functions and responsibilities as are necessary, appropriate, or incidental to efficient and effective provisions of the basic services and facilities such as municipal enterprises, tourism facilities and other tourist attractions.

Section 2. MAHAPLAG INLAND RESORT HOTEL. The Local Government Unit of Mahaplag establishes and operates the Mahaplag Inland Resort Hotel situated in Barangay Malinao, Mahaplag, Leyte as a municipal enterprise, tourism facility and tourist attraction.

Section 3. RATES AND FEES. The rates and fees of the services, facilities, and amenities offered in the Mahaplag Inland Resort Hotel shall be as follows:

Section 4. The income collected from the operation of the Mahaplag Inland Resort Hotel shall accrue to the General Fund of the Local Government Unit of Mahaplag.

Section 5. SEPARABILITY CLAUSE. If, for any reason, any item, section or provision of this Ordinance is declared invalid or unconstitutional, the other items, sections or provisions thereof which are not affected thereby shall continue to be in full force and effect.

Section 6. REPEALING CLAUSE. All ordinances, resolutions or parts thereof, whose provisions are in conflict with or contrary to the provisions of this ordinance are hereby repealed, amended or modified accordingly.

Section 7. EFFECTIVITY CLAUSE. This Ordinance shall take effect upon approval by the Local Chief Executive.




