

“AN ORDINANCE TRANSFERRING OUR EXISTING MUNICIPAL INFIRMARY AT BARANGAY BAIKARAN, SAN MIGUEL, LEYTE TO THE NEWLY CONSTRUCTED MUNICIPAL INFIRMARY LOCATED AT BARANGAY LIBTONG, SAN MIGUEL, LEYTE”

WHEREAS, Section 16 of the Local Government Code of 1991 (Republic Act 7160) provides that every local government unit shall exercise powers essential to the promotion of the general welfare, including the right to establish and maintain health facilities;

WHEREAS, the San Miguel Infirmary has been serving the people of San Miguel, Leyte in its present location at Barangay Baikaran, San Miguel, Leyte, but due to the newly constructed infirmary building which is suitable for hospital purposes, it has been deemed necessary to transfer said facility to a more suitable site;

WHEREAS, the proposed site at Barangay Libtong, San Miguel, Leyte has been identified as the most strategic and appropriate location to ensure accessibility, safety, and improved delivery of health services to the constituents of San Miguel;

WHEREFORE, on motion of Hon. Francis Jay D. Sabdao duly seconded by all members present;

NOW THEREFORE, BE IT ENACTED, AS IT IS HEREBY ENACTED BY THE SANGGUNIANG BAYAN OF SAN MIGUEL, LEYTE, BY VIRTUE OF THE POWERS VESTED IN IT BY LAW, IN SESSION ASSEMBLED, that:



AN ORDINANCE TRANSFERRING OUR EXISTING MUNICIPAL INFIRMARY AT BARANGAY BAIRAN, SAN MIGUEL, LEYTE TO THE NEWLY CONSTRUCTED MUNICIPAL INFIRMARY LOCATED AT BARANGAY LIBTONG, SAN MIGUEL, LEYTE"

Sponsor: HON. FRANCIS JAY D. SABDAO
SB Member/Chairman on Rules, Privileges, Ordinance and Health

Section 1. Title: This Ordinance shall be known and cited as: "AN ORDINANCE TRANSFERRING OUR EXISTING MUNICIPAL INFIRMARY AT BARANGAY BAIRAN, SAN MIGUEL, LEYTE TO THE NEWLY CONSTRUCTED MUNICIPAL INFIRMARY LOCATED AT BARANGAY LIBTONG, SAN MIGUEL, LEYTE."

Section 2. Transfer of Infirmary
The San Miguel Infirmary is hereby transferred from its present location at Barangay Bairan, San Miguel, Leyte to Barangay Libtong, San Miguel, Leyte.

Section 3. Funding
The necessary funds for the transfer, improvement, and operation of the infirmary shall be charged against the funds of the Local Government Unit of San Miguel, Leyte subject to availability and usual government accounting and auditing rules and regulations.


Section 4. Implementing Office
The Municipal Health Office, in coordination with the Office of the Mayor, the Municipal Engineering Office, and other concerned offices, shall implement this Ordinance.

Section 5. Repealing Clause
All ordinances, resolutions, and executive orders inconsistent with this ordinance are hereby repealed or modified accordingly.

Section 6. Effectivity
This Ordinance shall take effect immediately upon approval and compliance with publication and posting requirements as mandated under the Local Government Code of 1991.


