



BE IT ORDAINED BY THE 20TH SANGGUNIANG BAYAN OF ABUYOG, LEYTE IN A REGULAR SESSION ASSEMBLED; that:



SECTION 1. TITLE - This ordinance shall be known as "2025 AMENDATORY ORDINANCE APPROVING THE CORRECTION OF THE SALARY GRADE OF THE DIFFERENT PLANTILLA POSITIONS AT THE ABUYOG COMMUNITY COLLEGE, LOCAL GOVERNMENT UNIT, ABUYOG, LEYTE"
