Pursuant to the provisions of the Local Government Code of 1991 (Republic Act No. 7160), our preliminary review of the **General Fund Supplemental Budget No. 4 FY 2025** of the **Municipality Kananga, Leyte** duly enacted by the Sangguniang Bayan through **Appropriation Ordinance No. 24L.25-009** with a total appropriation in the amount of **P2,000,000.00** reveals compliance with the same law and its implementing Rules and Regulations.

ORDINANCE NO. 24L.25-009
(Series of 2025)

AN ORDINANCE APPROPRIATING THE AMOUNT OF TWO MILLION PESOS (P2,000,000.00) EMBODIED UNDER SUPPLEMENTAL BUDGET NO. 4 CY 2025 FOR THE CONTINUED OPERATION OF THE MUNICIPAL GOVERNMENT OF KANANGA, LEYTE FOR THE PERIOD FROM JANUARY 1 TO DECEMBER 31, YEAR 2025, AND FOR OTHER PURPOSES.

WHEREAS, the Local Chief Executive, in pursuance of the provision of Section 444 (3) (ii) of Republic Act No. 7160, has caused the preparation of Supplemental Budget No. 4 outlining therein the Budgetary Requirements for the continued delivery of basic services, facilities, other functions of the Local Government under Section 17 of the said Code;

WHEREAS, the Sangguniang Bayan, through the Committee of the Whole, in the exercise of its power under the Local Government Code, has considered the proposed Supplemental Budget, reviewed evaluated and recommended the approval of the ordinance embodying the proposed appropriation for the Supplemental Budget No. 4 for Calendar Year 2025.

NOWHEREFORE, considering the above cited premises; be it enacted by the 24th Sangguniang Bayan of Kananga, Leyte on a regular session duly assembled on this 11th day of November 2025 and upon motion of SB Member Fernando M. Aseo, duly seconded by All SB Members present, to wit:

Section 1. The Supplemental Budget No. 4 of the Municipality Government of Kananga for Fiscal Year 2025 in the total amount of Two Million Pesos (P2,000,000.00) for the continued operation of the Municipal Government of Kananga, Leyte for the period from January 1 to December 31, Year 2025, and for other purposes is hereby approved.

The budget documents consisting of the following are incorporated herein and made integral part of this ordinance:

1. Budget Message
2. Certification of Availability of Funds
3. Statement of Funding Sources
4. Statement of Supplemental Appropriation CY 2025

Section 2. Sources of Funds – The sources of fund for the Supplemental Budget No. 4, FY 2025 in the total amount of Two Million Pesos (P2,000,000.00) shall be as follows:

Section 3. Use of funds. The amount of Two Million Pesos (P2,000,000.00) is hereby appropriated for the Supplemental Budget No. 4 for FY 2025 of the Municipality of Kananga, as follows:

Section 4. Expenditure Component – Except by act of the Sangguniang Bayan, no changes or modification shall be made on the expenditure items authorized in the ordinance as detailed in the LBP Form 161 duly signed by the Municipal Budget Officer and the Local Chief Executive.

Any changes or modifications in the expenditure items in violation of this shall subject the erring official or employee to appropriate criminal and administrative sanctions as maybe provided under existing laws.

Section 5. Use of Savings and Augmentation. In accordance with Section 336 of Republic Act No. 7160, the Local Government Code of 1991, the Municipal Mayor and the Presiding Officer of the Sangguniang Bayan are authorized to augment any item in the approved annual budget for their respective offices from savings in other items within the same expense class of their respective appropriations.

For their purpose, “savings” refer to portions or balances of any programmed appropriation free from any obligation or encumbrance still available after the satisfactory completion or the unavoidable discontinuance or abandonment of the work, activity or purpose for which the appropriation is authorized or arising from unpaid compensation and related costs pertaining to vacant positions and leaves of absences without pay.

“Augmentation” implies the existence in the budget of an item, project or activity or purpose with an appropriation which, upon implementation or subsequent evaluation of needed resources, is determined to be deficient.

Section 6. Separability Clause – If, for any reason, any item of expenditure appropriated in this ordinance is declared unlawful nor invalid, other items of the appropriations which are not otherwise affected shall continue in full force and effect.

Section 7. Effectivity Clause – This Ordinance shall take effect upon approval.


