





AN ORDINANCE APPROVING THE REQUEST FOR DROPPING AND CHANGE OF UNIT OF A MOTORIZED TRICYCLE-FOR-HIRE FRANCHISE REGISTERED UNDER GREY ANN P. CORAÑES WITHIN THE MUNICIPALITY OF BURAUEN, LEYTE

WHEREAS, Section 447(a)(3)(vi) of Republic Act No. 7160, otherwise known as the Local Government Code of 1991, empowers the Sangguniang Bayan to regulate the operation of tricycles-for-hire and grant franchises for their operation within the municipality;

WHEREAS, the Municipal Tricycle Franchising and Regulatory Board (MTFRB), through the Business Permits and Licensing Officer (BPLO), has endorsed the request of Grey Ann P. Coraños for the dropping and change of unit under his existing motorized tricycle-for-hire franchise;

WHEREAS, the Committee on Transportation, Public Utilities, and General Services favorably recommended the granting of the said franchise;

NOW, THEREFORE, upon the motion duly made and seconded, be it enacted by the Sangguniang Bayan of Burauen, Leyte, in session assembled:

Section 1. APPROVAL OF CHANGE OF UNIT. The request of Grey Ann P. Coraños for the dropping of his previous unit and substitution with a new unit under his existing franchise is hereby approved, as follows:






