



This office opines that the subject Ordinance is, in general, within the legislative authority of the Sangguniang Bayan under Sections 447(a)(3)(vi)<sup>1</sup> of the Local Government Code of 1991 (R.A 7160). Hence, we recommend for the declaration of its validity.



**AN ORDINANCE AWARDING A FRANCHISE TO JESSA S. PEÑAFLOR FOR THE OPERATION OF A MOTORIZED TRICYCLE-FOR-HIRE ALONG THE POBLACION ROUTE, MUNICIPALITY OF BURAUEN, LEYTE**

WHEREAS, Section 447(a)(3)(vi) of Republic Act No. 7160, otherwise known as the Local Government Code of 1991, empowers the Sangguniang Bayan to regulate the operation of tricycles-for-hire and grant franchises for their operation within the municipality;

WHEREAS, Ms. Jessa S. Peñaflor has applied for a franchise to operate a motorized tricycle-for-hire along the Poblacion route within the Municipality of Burauen, Leyte;

WHEREAS, the Committee on Transportation, Public Utilities, and General Services favorably recommended the granting of the said franchise;

NOW, THEREFORE, upon the motion duly made and seconded, be it enacted by the Sangguniang Bayan of Burauen, Leyte, in session assembled:

**Section 1. GRANT OF FRANCHISE.** A franchise is hereby granted to MS. JESSA S. PEÑAFLOR to operate one (1) unit of motorized tricycle-for-hire along the Poblacion route within the territorial jurisdiction of the Municipality of Burauen, Leyte.


**Section 2. VEHICLE SPECIFICATIONS.** The authorized unit shall have the following specifications:



**Section 3. COMPLIANCE.** The grantee shall comply with all applicable rules and regulations of the Municipality of Burauen and the Land Transportation Office (LTO), and shall secure the necessary permits and clearances for the continued operation of the franchise.

**Section 4. EFFECTIVITY.** This Ordinance shall take effect immediately upon approval.




