1143 constituent. We were informed that we are already at the second to the last spot in the world
1144 on quality of education that we have. So, I just want to invite everybody to join me in my
1145 advocacy to make several trucks of food kitchen and scatter them throughout Leyte so that we
1146 can feed the children and make schedule so that this Board we have right now will make a
1147 difference.

1148 HON. RAISSA J. VILLASIN: 2ND DISTRICT BOARD MEMBER

1149 Actually, Vice Gov that is one of the options we are looking at. The DOH has a
1150 supplemental nutrition program so their plan is to partner with a carenderia but they are finding
1151 it difficult to implement in municipalities because kokonti lang ang carenderia sa atin. So, one
1152 of the options also is that the municipality will have a mobile kitchen or community kitchen
1153 wherein they can also utilize Senator Kiko's SAGIP SAKA where in the community can buy the
1154 supplies within the municipality so that the chain just goes around the municipality. Thank you
1155 so much Vice Gov for that advocacy kasi mas magiging madali na po yung magiging
1156 implementation natin sa Nutrition Program in the Province of Leyte kasi isa po isa po yan sa
1157 pwede gawin, not only supplemental feeding but also in times of disaster, natural calamities
1158 wherein it could be utilized in the feeding programs specially in the evacuation centers.

1159 HON. LEONARDO M. JAVIER JR: PRESIDING OFFICER/VICE GOVERNOR

1160 Okay. May programa na pala ang DOH. Hindi ko alam eh.

1161 HON. RAISSA J. VILLASIN: 2ND DISTRICT BOARD MEMBER

1162 Kaso po parang hindi po sya sustainable kasi kailangan pa magkipagpartner sa
1163 carenderia and masyado po malaki ang budget kung ipeper beneficiary. For now, naka pilot
1164 test po sya sa 8 municipalities all over the province and we are looking at kung ano ang
1165 magiging magandang way but so far, Dulag, Julita and Barugo are 3 of the eight pilot sites.

1166 For long and sustainable option, they are planning for the community kitchen for the
1167 sustainability kasi hindi rin kakayanin kung magpartner ng carenderia for the whole entire
1168 time. As of now okay daw sya kasi meron down na account from DOH but what if tapos na
1169 yung term ng funding from DOH, yun yung magiging problema later on.

1171 Please just join me in this advocacy so we can help our constituents.

1172 Anyways, it's been a nice session today.
