COMMITTEE REPORT No. 26 S. 2025

Referred to this Committee, pursuant to Resolution No. 2025-497 dated October 14, 2025, is the request of Mr. Antonio G. Celajes, Jr., Vice President of Cleanaway Philippines, Inc., seeking the support of this Body for the issuance of a Resolution Endorsing and Interposing No Objection to the company's business operations.

The Committee notes that, on September 20, 2025, Cleanaway Philippines, Inc. formally transmitted to the Sangguniang Panlalawigan a letter request for the issuance of a Resolution Endorsing and Interposing No Objection to its business operations involving the handling, treatment, and management of hazardous and/or medical waste.

In accordance with regulatory requirements applicable to enterprises engaged in hazardous or medical waste management, the Committee directed the applicant to secure and submit Barangay and Municipal Resolutions Endorsing and Interposing No Objection to the conduct of such operations within the respective local jurisdictions, as a prerequisite to any favorable action by the Sangguniang Panlalawigan.

The Committee further notes that the applicant has duly complied with the foregoing directive and that the requisite local endorsements have been submitted, reviewed, and properly evaluated.

In view of the foregoing, and after due deliberation, the Committee respectfully recommends the issuance of a Resolution Interposing No Objection provided that henceforth, Cleanaway will no longer be bringing into the Province of Leyte medical waste materials from Cebu and other provinces without prior approval of the Sangguniang Panlalawigan.
