**REVIEW/RECOMMENDATION/LEGAL OPINION:**

This office opines that the subject Ordinance is, in general, within the legislative authority of the Sangguniang Bayan to repeal/amend its prior acts either expressly or by the passage of an essentially inconsistent resolution<sup>1</sup>. Hence, we recommend for the declaration of its validity.

**ORDINANCE NO. 2025-014**

AN ORDINANCE AMENDING CHAPTER III, ARTICLE E ON FEES ON IMPOUNDING OF ASTRAY ANIMALS; CHAPTER III, ARTICLE I ON REGISTRATION AND TRANSFER FEES ON LARGE CATTLE; AND CHAPTER IV, ARTICLE F ON DOG VACCINATION FEE, OF MUNICIPAL ORDINANCE NO. 2023-01 OTHERWISE KNOWN AS "AN ORDINANCE REVISING THE MUNICIPAL REVENUE CODE"

NOW, THEREFORE

On motion of Hon. Jullian Marc A. Batiancela, seconded by the Majority of all the Sangguniang Bayan members present;

BE IT ORDAINED BY THE SANGGUNIANG BAYAN OF CALUBIAN, LEYTE, in a session assembled, THAT:

SECTION 1. AMENDMENTS. Section 5A.07 of Municipal Ordinance No. 2023-01 is HEREBY AMENDED, to wit:

CHAPTER III. PERMIT AND REGULATORY FEES

Article E. Fees on Impounding of A stray Animals

SECTION 3E.01. DEFINITIONS. When used in this Article.

- (a) **Astray Animal** means an animal which is set loose unrestrained, and not under the complete control of its owner, or the charge or in possession thereof, found roaming at large in public or private places whether fettered or not.
- (b) **Public Place** includes national, provincial, municipal, or barangay streets, parks, plazas and such other places open to the public.
- (c) **Private Place** includes privately-owned streets or yards, rice fields or farmlands or lots owned by an individual other than the owner of the animal.
- (d) **Large Cattle** refers to domesticated animals in the bovine family, including: cows, horses, mules, and asses.
- (e) **Pet Animals** refers to animals that are kept in home as companions and treated kindly, can be symbiotic relationship that benefits both the animal and the human this includes dogs, cats and birds.

SECTION 3E.02. IMPOSITION OF FEE. There shall be imposed the following fees for each day or fraction thereof on each head of astray animal found running or roaming at large, or fettered in public or private places.

Pet Animals	150.00

SECTION 3E.05. PENALTY. Owners whose animal are caught astray and incurring damages to plants, properties and to humans shall pay the following fines.

In addition to the fine, the owners shall pay the amount of damage incurred, if any, to the property owner.

*Article I. Animal Health Certification, Registration and Transfer Fee on Large Cattle*

**SECTION 3I.01. ANIMAL HEALTH CERTIFICATE FEE FOR LIVE ANIMALS (LIVESTOCK, POULTRY, FIGHTING COCKS AND SMALL ANIMALS). Definition.**

- (a) **Live Animals** refer to a special type of "goods", covers all living animals including hatching eggs, classified into subcategories according to their nature.
- (b) **Livestock and production animals** are domestic animals and poultry intended for breeding, production of milk, meat and eggs or labor.
- (c) **Slaughter Animals** are domestic animals includes horses, cow, hogs/swine, sheep, goats and domestic poultry like chickens, turkeys, guinea fowls, ducks, geese, pheasants and quails intended to be slaughtered as soon as they arrive in the destination.
- (d) **Small Animals** are animals that receive the protection of humans in exchange for their presence alone, their beauty or talents this includes dogs, cats and birds.

**SECTION 3I.02. IMPOSITION FEE.**

The carrier is required to pay the fee in the Municipal Treasurer for which the certificate shall be issued after by the Office of the Municipal Agriculturist.

The carrier must provide a barangay certificate from the barangay where the animal has been acquired.

The carrier needs to produce a disinfection clearance from their origin.

**SECTION 3I.03. TIME AND MANNER OF PAYMENT.**

The Certification Fee shall be paid to the Municipal Treasurer before proceeding to the Office of the Municipal Agriculturist for the issuance of the Health Certification.

The carrier must present the barangay certification and the disinfection clearance to the Office of the Municipal Agriculturist prior to the issuance of Health Certification.

**SECTION B.31.04. ADMINISTRATIVE PROVISIONS.**

The Municipal Agriculturist and/or authorized representative shall issue the Animal Health Certification after the settlement at the Municipal Treasurer and presenting the barangay certification.

The Municipal Agriculturist and/or authorized representative shall issue the Animal Health Certification only to animals that are in healthy condition and free from any communicable disease.

The Municipal Agriculturist and/or authorized representative shall examine the animal before issuance of the Animal Health Certificate.

Issuance of Animal Health Certification must have no corrections or must not be tampered with otherwise the same will be disregarded and considered.

Validity of the Health Certification shall be three (3) calendar days only and for one (1) time shipment only.

**SECTION 31.05. PENALTY.**

Any person(s) or entities found any provision in whole or in part of this ordinance, shall be fined with the following:

Offenses	Amount of Fee
First Offense	500.00
Second Offense	1,000.00
Third Offense	2,000.00

For the third and succeeding offenses, plus imprisonment of one (1) month and or upon discretion of the Court.

If the violation is committed by any juridical entity, the President, the General Manager, or the individual entrusted with the administration thereof at the time of commission of the violation, shall be held responsible or liable thereof.

**SECTION 4F.01. IMPOSITION FEE**

There shall be collected/imposed from every owner of the dog and cat a registration and vaccination fee within the territorial jurisdiction of the Municipality.

**SECTION 4F.02. TIME OF PAYMENT**

The fee shall be paid to the Municipal Treasurer prior to the vaccination of the pet in close coordination with the Office of the Municipal Agriculturist.

Fees	Amount per head
Registration	100.00
Vaccination	70.00

**SECTION 4F.03. ADMINISTRATIVE PROVISIONS**

1.a Every dog/cat three (3) months of age and older should be submitted by the owner for vaccination against rabies every year.

XXX

3.a The Municipal Agriculturist and/or authorized representative shall provide certificate of registration for the dog/cat as proof of registration.

3.b. The registration of cat/dog shall be done only once.

XXXXX

**SECTION 4F.04. PENALTY**

(a) Pet owners who refuse to have their pet vaccinated against rabies shall be liable to pay for the vaccination of both the animal and the individual bitten by their dog/cat.

(b) Pet owners who refuse to have their dog/cat put under observation after said animal has bitten an individual shall be meted a fine of two thousand pesos (2,000.00).

(c) Pet owners who refuse to have their dog/cat put under observation and do not shoulder the medical expenses of the person bitten by their pet shall meted a fine of two thousand five hundred pesos (2,500.00).

(d) Any person found guilty of trading dog/cat meat shall be fined not less than two thousand pesos (2,000.00) per dog and subjected to imprisonment for one (1) month and or upon discretion of the Court.

(e) Any person found guilty of using electrocution as a method of euthanasia shall be fined not less than two thousand pesos (2,000.00) per act and subject to imprisonment for one (1) month and or upon discretion of the Court.

(f) If the violation is committed by an alien, he or she shall be immediately deported after service of sentence without any further proceedings.

**SECTION 2. SEPARABILITY CLAUSE.** If any provision of this Ordinance is declared invalid or unconstitutional, the remaining provision not affected thereby, shall continue to be in full force & effect.

**SECTION 3. REPEALING CLAUSE.** All ordinances, rules, and regulations, other issuances or parts thereof which are inconsistent with this Ordinance is hereby repealed.


