**REVIEW/RECOMMENDATION/LEGAL OPINION:**

This office opines that the subject Ordinance is, in general, within the legislative authority of the Sangguniang Bayan to repeal/amend its prior acts either expressly or by the passage of an essentially inconsistent resolution<sup>1</sup>. Hence, we recommend for the declaration of its validity.



**NOW, THEREFORE**

On motion of Hon. Jullian Marc A. Batiancela, seconded by the Majority of all the Sangguniang Bayan members present;

BE IT ORDAINED BY THE SANGGUNIANG BAYAN OF CALUBIAN, LEYTE, in a session assembled, THAT:

**SECTION 1. AMENDMENTS.** Section 5A.07 of Municipal Ordinance No. 2023-01 is HEREBY AMENDED, to wit:

**CHAPTER III. PERMIT AND REGULATORY FEES**

*Article A. Mayor's Permit Fee on Business*

**SECTION 3A.03. ADMINISTRATIVE PROVISIONS.**

**(g) Prohibited Acts.** The following acts are herein prohibited and shall be subject to revocation or black-listing of future applications for business permits:

- i. Those establishments, stores or businesses without any valid or existing business permit since its operation, or for the current calendar year;
- ii. Operation of business or selling of goods or services, outside of what is approved, or operating beyond the scope of the permit granted by the Municipality
- iii. A business who signified or declared its closure or retirement, but continues to operate without securing a business permit.
- iv. Any other violations contrary to law, customs and morals under existing laws, orders. rules and regulations of the Municipality or the Philippines.

**(h) Penalties**

Any person(s) or entities found any of the above-mentioned prohibited acts, shall be fined with the following:

Offenses	Amount of Fine
First Offense	500.00
Second Offense	1,500.00
Third Offense, and subsequent offenses	2,500.00

Any second violation or offense shall be subject to the revocation of business permit, and suspension and to an immediate closure of the establishment for a minimum period of thirty (30) days, subject to blacklisting or bar for renewal or application of business permit for a period of one (1) year.

Prior to the imposition of fines and penalties, the Business Permit and Licensing Office (BPLO) shall issue Show Cause Orders upon proper investigation of any violation of said business establishments. Upon approval and discretion of the Municipal Mayor of the recommended fines and penalties from the BPLO, may the decision be final and executory, subject to a justified cause by the establishment, if any.

**SECTION 2. SEPARABILITY CLAUSE.** If any provision of this Ordinance is declared invalid or unconstitutional, the remaining provision not affected thereby, shall continue to be in full force & effect.

**SECTION 3. REPEALING CLAUSE.** All ordinances, rules, and regulations, other issuances or parts thereof which are inconsistent with this Ordinance is hereby repealed

**SECTION 4. EFFECTIVITY.** This Ordinance shall take effect after fifteen (15) days from posting and publication, immediately upon approval of the Municipal Mayor and the Honorable Sangguniang Panlalawigan of Leyte.


