322 municipal civil registrations service which are provided by the Office of the Municipal Registrar.

323 The ordinance provided an implementation mechanism where in those mentioned in the
324 ordinances such as judges, prosecutors, policemen, teachers and etc just have to submit their
325 appointment letter to the Office of Civil Registrar of Alangalang, Leyte. And once it will be
326 verified that they are indeed assigned in the Municipality of Alangalang, fees of services of the
327 Municipal Registrar of Alangalang are waived.
