



EXCERPTS FROM THE MINUTES OF THE 16TH REGULAR SESSION OF THE SANGGUNIANG BAYAN OF PASTRANA HELD LAST OCTOBER 27, 2025 AT THE SANGGUNIANG BAYAN SESSION HALL, PASTRANA LEYTE

Municipal Ordinance No. 004 – 2025 Series of 2025

“THE NEW COMPREHENSIVE ANTI-SMOKING/ANTI-VAPING ORDINANCE OF THE MUNICIPALITY OF PASTRANA”

WHEREAS, the LOCAL GOVERNMENT CODE OF 1991 (REPUBLIC ACT NO 7160) accords every local government unit power and authority to promote the general welfare within its territorial jurisdiction,

WHEREAS, the REPUBLIC of the PHILIPPINES, under the Framework Convention on TOBACCO CONTROL (FCTC) to which it is a party, determined to give priority to the right to protect public health and to promote measures of TOBACCO CONTROL based on current and relevant scientific, technical and economic considerations, and agreed to implement the measures provided in the treaty

WHEREAS, the PHILIPPINE CLEAN AIR ACT of 1991 (Republic Act 8749) declared the right of every citizen to breathe clean air, prohibits smoking inside enclosed public places including public vehicles and other means of transport, and directs Local Government Units to implement this provision;

WHEREAS, the 1987 Constitution of the Republic of the Philippines declares that the state shall protect and promote the right to health of the people and instill health consciousness among them;

WHEREAS, the Tobacco Regulation Act of 2003 (Republic Act. No 9211) prohibits smoking in certain public places whether enclosed or outdoors; prohibits the purchase and sale of cigarettes and other tobacco products from and to minors and in certain places frequented by minors; imposes bans and restrictions on advertising, promotion and sponsorship activities of tobacco companies; and directs Local Government units to implement these provisions;

WHEREAS, the Municipality of Pastrana recognized that the local government must act with outmost urgency to denormalize the culture of smoking and tobacco consumption through comprehensive and proven effective tobacco control measures;

WHEREAS, the Municipality of Pastrana recognize the fundamental and irreconcilable conflict between tobacco industry's interests and public health policy, and realized the need to be alert to an informed of any efforts by the tobacco industry to undermine or subvert tobacco control efforts;

WHEREAS, scientific evidence has shown that there is no safe level of exposure to tobacco smoke; that effective measures to protect from exposure to it requires the total elimination of smoking and tobacco smoke; and that approaches other than 100% smoke-free environments, including ventilation, air filtration and the use of designated smoking areas (whether with separate ventilation systems or not) have repeatedly been shown to be ineffective;

WHEREAS, an increasing number of Filipinos die each year of tobacco-related diseases such as stroke, heart disease, and various cancers, among others;

NOW THEREFOR, BE IT ENACTED, as it is hereby enacted the Sangguniang Bayan of the Municipality of Pastrana, in session assembled, by virtue of the powers vested in it by law, that:

SECTION 1. TITLE

This ordinance shall be known as the "THE NEW COMPREHENSIVE ANTI-SMOKING/ANTI VAPING ORDINANCE OF THE MUNICIPALITY OF PASTRANA."

SECTION 2. DEFINITION OF TERMS

- 1. ENCLOSED PUBLIC PLACES** - shall mean any building or any part thereof where its windows and/or doors are partly or completely closed and where people customarily and freely enter, gather or stay.
- 2. Smoking/vaping** - shall mean the use or possession of a lighted object or battery operated which emits vapor/smoke device which contain tobacco, including cigars and cigarettes.
- 3. Public conveyance** - shall mean any type of vehicle primarily devoted to transporting and conveying of people on land, sea or air for a fee, and is classified generally as public utility vehicle.

4. School Premises – shall mean areas within any institutions of learning whether private or public devoted primarily to pre-elementary, elementary, secondary or tertiary level of education.

SECTION 3 PROHIBITED ACTS – any person is prohibited from smoking/ vaping in all enclosed public places, public conveyance and in all school premises in Pastrana, Leyte. Smoking/vaping, however, is allowed in enclosed public places but only in designated smoking/vaping areas equipped with exhaust facilities which are to be identified by the administrator, owner operator or manager of said establishment/ public building or office.

SECTION 4. POSTING OF SIGNS.

- a. The Municipal Engineers Office and the Municipal Health Office shall be responsible in posting prominently and conspicuously the signs, logos, markings, symbols or any informative devices designating “NO SMOKING/NO VAPING” and “SMOKING/VAPING AREA” in enclosed public places owned and operated by the municipality of Pastrana for the guidance and information of the public.
- b. The Owners/managers/administrators of business/ establishments or private offices and school authorities are required to post prominently and conspicuously the signs, logos, markings, symbols or any other informative devices designating “NO SMOKING/NO VAPING” and “SMOKING/VAPING AREA” for the guidance and information of the public.
- c. Removal, defacing or tampering of the said signs, logos, markings or symbols posted in accordance herewith is strictly prohibited.

In case the sticker/logo or sign regarding the “NO SMOKING/NO VAPING” prohibition of this ordinance shall be tampered or removed in any establishment by any person, the administrator, owner, operator or manager of the said establishment shall be responsible in procuring a replacement of the same within ten (10) days from the removal/tampering of the same. Failure to do so shall be a ground for the imposition of the penalty mentioned in section 6 hereof.

- d. Within ten (10) days from the effectivity of this Ordinance, the Municipal Health Office is required to conduct an inspection of all business establishments and school premises and require the owner, managers, operators or school administrators to post signs, logos, markings or symbols designating the “NO SMOKING/NO VAPING” and “SMOKING/VAPING AREA”, if any, within ten (10) days from the date of inspection

SECTION 5. APPROPRIATION – it is hereby appropriated an initial amount of TWENTY THOUSAND (P 20, 000.00) Pesos for the implementation of this Ordinance and every year thereafter, a reasonable amount shall be included in the budget of the Municipal Treasurer’s Office for the continuing implementation of this Ordinance.

SECTION 6. PENALTY – Any adult found in violation of this Ordinance shall be punished with a fine of Five Hundred Pesos (₱500.00) for the first offense and One Thousand Pesos (₱1,000.00) for the second offense. For the third and subsequent offenses, a fine of Two Thousand Five Hundred Pesos (₱2,500.00) or imprisonment of Twenty-Four (24) hours, or both, shall be imposed at the discretion of the court.

In accordance with Republic Act No. 9211 and Republic Act No. 11467, minors found smoking, vaping, or using any tobacco or vapor product shall not be subjected to any criminal liability or imprisonment. Instead, the minor shall be immediately apprehended and referred to the Municipal Social Welfare and Development Office (MSWDO) for appropriate intervention, which shall include counseling, health education on the harmful effects of tobacco and vapor products, and mandatory notification and involvement of the parent or legal guardian. Repeated violations by a minor shall warrant continued participation in intervention or rehabilitation programs as may be prescribed by the MSWDO.

Any person, owner, administrator, manager, or school administrator who allows, tolerates, or fails to prevent minors from smoking, vaping, or using tobacco or vapor products within their premises, or who fails to post the required signage under Section 4(d) of this Ordinance, shall be penalized with a fine of Two Thousand Five Hundred Pesos (₱2,500.00) or imprisonment of Twenty-Four (24) hours, or both, at the discretion of the court.

SECTION 7. ENFORCING AGENCY – PNP, Municipal Health Office, School Authorities, Barangay Officials and Barangay Tanods, MTO.

SECTION 8 REPEALING CLAUSE – All ordinances, rules, orders and regulations or parts thereof, which are inconsistent or in conflict with any of the provisions of this ordinance are hereby modified and/or repealed accordingly.

SECTION 9. EFFECTIVITY

This Ordinance shall take effect immediately upon its approval and publication.

MINUTES OF THE PUBLIC HEARING ON THE MUNICIPAL ORDINANCE “THE NEW COMPREHENSIVE ANTI-SMOKING/ANTI-VAPING ORDINANCE OF THE MUNICIPALITY OF PASTRANA” HELD LAST OCTOBER 21, 2025 AT THE PASTRANA MUNICIPAL COVERED COURT, THIS MUNICIPALITY.

PRELIMINARIES

- a. The Public Hearing was conducted by the Office of the Sangguniang Bayan of Pastrana, Province of Leyte, spearheaded by the SB Committee Chairman on Health and Sanitation, together with the members of the said committee.
- b. The activity was well-attended by Barangay Chairpersons, Sangguniang Kabataan Chairpersons, Department Heads, and other interested parties. *(Attached is the attendance sheet.)*
- c. The Public Hearing was presided over by **Hon. Pio M. Tan**, SB Committee Chairman on Health and Sanitation.
- d. The Public Hearing formally started at **3:23 PM** with a prayer and the singing of the Philippine National Anthem, both rendered through an overture.

II. PARLIAMENTARY PROCEEDINGS

- a. The Draft Ordinance entitled “**The New Comprehensive Anti-Smoking/Anti-Vaping Ordinance of the Municipality of Pastrana**” was presented by Hon. Pio M. Tan and was read by SB Staff **Mr. Emelito Salvador Silva** through a PowerPoint presentation. After the presentation, Hon. Tan proceeded to discuss the various sections of the proposed ordinance and invited corrections, comments, and suggestions from the participants. Hon. Gerardo S. Carian encouraged everyone to share their ideas, assuring them that all inputs would be deliberated thoroughly.
- b. The Presiding Officer opened the floor for questions and clarifications on **Sections 1, 2, and 3** (Title, Definition of Terms, and Prohibited Acts). No questions or clarifications were raised.
- c. Dr. Rolando A. Sulla inquired regarding Section 4 (Posting of Signs). The Presiding Officer responded that the Municipal Engineering Office, together with the Municipal Health Office, shall be responsible for the preparation and installation of the signages.
- d. **Hon. Geraldine Austria**, Barangay Chairwoman of Barangay Cabaohan, asked whether the ordinance applies to the poblacion area or all the barangays in the municipality. The Presiding Officer clarified that it will cover the entire Municipality of Pastrana, including **all 29 barangays**.

e. **Mr. Valentino Enting** of Barangay Guindapunan asked about the definition of “enclosed public place” in relation to the terminal. The Presiding Officer explained that the terminal is considered a public place due to high public foot traffic.

f. **Hon. Nathan Letrodo** suggested removing “public conveyance” from the ordinance as it is not applicable to the municipality.

g. **Hon. Gerardo S. Carian** inquired whether the cockpit arena would be included under prohibited acts (Section 3).

h. **Dr. Rolando A. Sulla**, Municipal Health Officer, raised a similar concern regarding the procurement of signages.

i. The Presiding Officer clarified that the **Municipal Engineering Office** and the **Municipal Health Office** will provide signages for the población area, while private establishments will likewise be provided signages by the LGU.

j. **Hon. Carian** further suggested on the inclusion of karaoke bars in the ordinance and it has been acknowledged and noted.

k. **Hon. Mark Joseph Lagera**, SK Chairman of Barangay Yapad, asked if who would replace the signages if it will be removed or damaged. The Presiding Officer answered that the **establishment owner** will be responsible for replacing damaged or missing signages.

k. **Hon. Rea Fay C. Depaudhon**, SK Chairman of Barangay Macalpiay, suggested that such responsibility should not fall on the owner rather on the individual who caused the loss/damage of signages.

l. **Hon. Carian** recommended that signages be made durable and long-lasting. The Presiding Officer acknowledged the suggestion and assured that the Engineering Office would install signages at a height that discourages tampering. He also requested store owners to help monitor the signages, emphasizing cooperation.

m. **Hon. Chito C. Cayaco** stated that the **LGU Pastrana** will fund the signages, with a program design to be prepared for the bidding process. The Presiding Officer expressed appreciation and highlighted the importance of collaboration with SB Members and Barangay Officials.

n. **Hon. Leodegario Escobar II**, SK Chairman of Barangay Lima, proposed that signages include a note or disclaimer prohibiting their removal or destruction, stating that violators shall be liable for replacement. The Presiding Officer agreed, adding that any person who removes or defaces the signage shall be subject to penalties.

o. The Presiding Officer proceeded to read **Section 5 (Appropriation), Section 6 (Penalty), and Section 7 (Enforcing Agency)**. He again invited questions and clarifications, and several concerns were addressed accordingly.

III. APPROVAL OF THE ORDINANCE

The proposed ordinance, “**The New Comprehensive Anti-Smoking/Anti-Vaping Ordinance of the Municipality of Pastrana**,” received overwhelming support and was met with applause from the participants. A motion for its approval was made by **Hon. Aiza G. Silva**, Barangay Chairperson of Barangay District II, and was duly seconded by **Hon. Armando Lagera**, Barangay Chairperson of Barangay Sapsap.

IV. CLOSURE OF THE PUBLIC HEARING

With the approval of the ordinance by the majority of the participants and with everyone expressing satisfaction with the results of the public hearing, the session was formally closed by **Hon. Chito C. Cayaco**.

V. ADJOURNMENT

There being no other matters to discuss, **Hon. Rea Fay C. Depaudhon** moved for the adjournment of the Public Hearing, which was duly seconded by **Hon. Ariel E. Macasil**. The meeting was adjourned at 4:40 PM.

MINUTES OF THE **COMMITTEE HEARING** ON THE PROPOSED ORDINANCE “THE NEW COMPREHENSIVE ANTI-SMOKING/ANTI-VAPING ORDINANCE OF THE MUNICIPALITY OF PASTRANA” LAST SEPTEMBER 16, 2025 AT THE SANGGUNIANG BAYAN SESSION HALL

COMMITTEE HEARING PROCEEDINGS

The Committee Hearing was called to order by the Presiding Officer, Hon. Pio M. Tan, at exactly 11:33 in the morning. The hearing commenced with a prayer delivered through an overture.

Thereafter, the Presiding Officer directed the Sangguniang Bayan Secretary-Designate to conduct the roll call. Having confirmed the presence of a quorum, the Presiding Officer acknowledged the attendance of the committee members and proceeded to present the agenda.

The Presiding Officer likewise acknowledged the presence of the invited resource person, Dr. Rolando A. Sulla, Municipal Health Officer (MHO) of the Pastrana Rural Health Unit (RHU).

Dr. Sulla provided an overview and presented the proposed ordinance section by section for the committee’s review, comments, suggestions, and possible corrections.

During the deliberation, the committee agreed to insert the term “anti-vaping” after every mention of “anti-smoking” throughout the proposed ordinance, as the two are incorporated under the same provisions.

Hon. Rodel M. Tobilla was recognized and suggested consulting the Municipal Engineering Office to prepare a Program of Works for the signages to be used in the implementation of the ordinance in order to determine the initial budgetary requirements. He further remarked that the penalties provided in the draft ordinance were relatively minimal and proposed the following revised penalty scheme:

- First Offense – ₱500.00
- Second Offense – ₱1,000.00
- Third Offense – ₱2,500.00 and/or 24 hours imprisonment

He also recommended that the same penalties be imposed on owners, administrators, managers, or school administrators who fail to post the mandatory signage in compliance with the ordinance. This proposal was agreed upon by the majority of the committee members.

Hon. Nathan G. Letrodo was recognized and suggested including the Municipal Treasurer’s Office as part of the enforcing agencies, being the office authorized to collect penalties.

After thorough discussion, Hon. Rodel M. Tobilla moved to recommend the proposed ordinance entitled:

“THE NEW COMPREHENSIVE ANTI-SMOKING/ANTI-VAPING ORDINANCE OF THE MUNICIPALITY OF PASTRANA”

for Second Reading in the next regular session. The motion was duly seconded by Hon. Alex C. Sequito and was approved by the body.

There being no other matters to discuss, Hon. Rodel M. Tobilla moved to adjourn the committee hearing, which was duly seconded by Hon. Nicole Marie C. Marcos. The hearing was adjourned at 12:47pm and was formally closed with a prayer led by Hon. Loida B. Villablanca.
