899 only take 20 minutes from Jaro.

901 I think, Mr. Chair, that we need to pass a Resolution requesting the Leyte 4th
902 Engineering District to give us an update on the plan of this unfinished road. Because
903 walang gamit, mayroon tayo'ng road d'yan tapos putol naman, hindi maka deretso. So
904 maybe we can pass a Resolution requesting the 4th District of the DPWH to continue, to
905 fast track the unfinished section of that road, Mr. Chair.
