
WHEREAS, Barangay Liwayway is a productive barangay whose economy and livelihood are primarily dependent on agriculture;


WHEREAS, the barangay consists largely of agricultural lands and irrigated land areas which are essential for food production, food security, and sustainable livelihood of its residents;



ARTICLE I
GENERAL PROVISION
Section 1. Title


This Ordinance shall be known and cited as the “Barangay Mining Moratorium Ordinance of Barangay Liwayway MacArthur, Leyte”.


Section 2. Purpose and Objectives


This ordinance is enacted to:


- a. Protect and ensure food security for the residents of Barangay Liwayway;

- d. Protect the health, safety, welfare, and rights of the local communities and future generations.







ARTICLE II
DECLARATION OF MORATORIUM
Section 3. Mining Moratorium

A moratorium of **forty (40) years** is hereby imposed on the entry, conduct, and operation of all mining activities, whether small-scale or large-scale, within the territorial jurisdiction of Barangay Liwayway.

Section 4. Scope of Prohibition

The moratorium shall cover, but is not limited to, mineral exploration, extraction, processing, quarrying, and related activities conducted by any individual, corporation, cooperative, or entity, whether public or private.

ARTICLE III
FINAL PROVISIONS

Section 5. Enforcement

The Barangay Council, in coordination with appropriate municipal and national government agencies, shall ensure the strict implementation and enforcement of this Ordinance.

Section 6. Separability Clause

If any provision of this Ordinance is declared invalid or unconstitutional, the remaining provisions shall continue to be in full force and effect.

Section 7. Effectivity CLAUSE - This Ordinance shall take effect immediately upon approval and posting in conspicuous places within Barangay Liwayway, as required by law.
