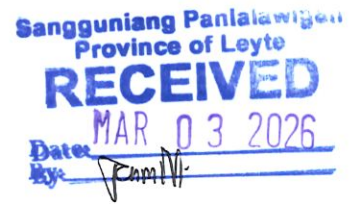

“AN ORDINANCE CREATING THE MUNICIPAL LAW ENFORCEMENT UNIT FOR THE ENFORCEMENT OF MUNICIPAL ORDINANCES AND APPROPRIATING FUNDS THEREOF.”

APPROVED ON 3rd and final reading on Jan. 26, 2026

BE IT ORDAINED by the Sangguniang Bayan of Alangalang, Leyte in session assembled:

SECTION 1. TITLE. This ordinance shall be known as **“Municipal Law Enforcement Unit Ordinance of Alangalang, Leyte.”**

SECTION 2. DECLARATION OF POLICY. It is hereby declared the policy of the Municipality of Alangalang, Leyte to ensure the effective enforcement of all duly enacted municipal ordinances, rules, and regulations to promote peace, order, environmental protection, public safety, and community welfare.

SECTION 3. CREATION OF THE MUNICIPAL LAW ENFORCEMENT UNIT (MLEU). There is hereby created a **Municipal Law Enforcement Unit (MLEU)** under the Office of the Municipal Mayor, tasked with enforcing all municipal ordinances and related regulations.


