



**AN ORDINANCE DROPPING AND CANCELLING FROM THE ROLL OF FRANCHISES THE  
 MOTORIZED TRICYCLE-FOR-HIRE FRANCHISE PREVIOUSLY GRANTED TO FRANCISCO  
 E. GAJE, JR. WITHIN THE TERRITORIAL JURISDICTION OF THE MUNICIPALITY OF  
 BURAUEN, LEYTE**

**WHEREAS**, Section 447(a)(3)(vi) of Republic Act No. 7160, otherwise known as the Local Government Code of 1991, empowers the Sangguniang Bayan to regulate the operation of tricycles-for-hire and grant franchises for their operation within the municipality;

**WHEREAS**, well-settled is the rule that the power to grant includes the corollary power to withhold or recall;

**WHEREAS**, Article XI, Section 20 of Municipal Ordinance No. 12-04, series of 2012, provides that an operator wishing to stop service completely shall report such termination in writing to the Sangguniang Bayan;

**WHEREAS**, Mr. Francisco E. Gaje, Jr. has submitted to the Office of the Sangguniang Bayan a written application for the dropping or cancellation of the Motorized Tricycle-for-Hire Franchise previously granted to her;

**WHEREAS**, the Committee on Transportation, Public Utilities, and General Services favorably recommended the granting of the said franchise;

**NOW, THEREFORE**, upon the motion duly made and seconded, be it enacted by the Sangguniang Bayan of Burauen, Leyte, in session assembled:

**Section 1. DROPPING AND CANCELLATION OF FRANCHISE.** The Motorized Tricycle-for-Hire Franchise previously granted to **MR. FRANCISCO E. GAJE, JR.** is hereby dropped and cancelled from the official roll of active franchises of the Municipality of Burauen, Leyte.

**Section 2. VEHICLE SPECIFICATIONS.** The authorized unit shall have the following specifications:






