

AN ORDINANCE DROPPING AND CANCELLING FROM THE ROLL OF FRANCHISES THE MOTORIZED TRICYCLE-FOR-HIRE FRANCHISE PREVIOUSLY GRANTED TO KRISTINE MAE C. VENCIO WITHIN THE TERRITORIAL JURISDICTION OF THE MUNICIPALITY OF BURAUEN, LEYTE

WHEREAS, Section 447(a)(3)(vi) of Republic Act No. 7160, otherwise known as the Local Government Code of 1991, empowers the Sangguniang Bayan to regulate the operation of tricycles-for-hire and grant franchises for their operation within the municipality;

WHEREAS, well-settled is the rule that the power to grant includes the corollary power to withhold or recall;

WHEREAS, Article XI, Section 20 of Municipal Ordinance No. 12-04, series of 2012, provides that an operator wishing to stop service completely shall report such termination in writing to the Sangguniang Bayan;

WHEREAS, Ms. Kristine Mae C. Vencio has submitted to the Office of the Sangguniang Bayan a written application for the dropping or cancellation of the Motorized Tricycle-for-Hire Franchise previously granted to her;

WHEREAS, the Committee on Transportation, Public Utilities, and General Services favorably recommended the granting of the said franchise;

NOW, THEREFORE, upon the motion duly made and seconded, be it enacted by the Sangguniang Bayan of Burauen, Leyte, in session assembled:

Section 1. DROPPING AND CANCELLATION OF FRANCHISE. The Motorized Tricycle-for-Hire Franchise previously granted to **MS. KRISTINE MAE C. VENCIO** is hereby dropped and cancelled from the official roll of active franchises of the Municipality of Burauen, Leyte.

Section 2. VEHICLE SUBJECT TO FRANCHISE CANCELLATION. The cancellation pertains to the following motorized tricycle unit previously authorized under the said franchise:

Make:	Skygo
Engine No.:	161FMJN5125579
Chassis No.:	LX8PCK50XNE021182
LTO Plate No.:	240HQM

Upon approval of this Ordinance, the above-described unit shall no longer be authorized to operate as a tricycle-for-hire within the Municipality of Burauen, Leyte.

Section 3. EFFECTIVITY. This Ordinance shall take effect immediately upon approval.




