AN AMENDMENT TO ARTICLE E, CHAPTER V OF MUNICIPAL ORDINANCE NO. 126, S-2020 OTHERWISE KNOWN AS THE "2020 REVISED REVENUE CODE OF THE MUNICIPALITY OF VILLABA"

PREFATORY STATEMENT

Section 447 (a) of the Local Government Code of 1991 provides that, the Sangguniang Bayan, as a Legislative Body of the Municipality, shall enact ordinances, approve resolution and appropriates funds, for the general welfare of the municipality and its inhabitants pursuant to Section 16 of this code and in the proper exercise of the corporate powers of the municipality as provided.

Further, in the same law mentioned in the preceding paragraph, it states that, each local government unit shall exercise its power to create its own sources of revenue and to levy fees and charges subject to the provisions of the Code which shall accrue exclusively to the local government unit consistent with the basic policy of local autonomy

On September 7, 2020, the Sangguniang Bayan approved Municipal Ordinance No. 126, S-2020 otherwise known as the "2020 Revised Revenue Code of the Municipality of Villaba".

However, the public have raised their concerns as to the bracketing of water charges. Hence, there is a need to amend the provision of the said Ordinance pertaining to the Charges for Use of Waterworks System in relation to the rates recommended by the Municipal Treasurer's Office.

Now, Therefore, on motion by the Hon. Meriam P. Umpad, duly seconded en masse,

Be it ordained by the Sangguniang Bayan in regular session duly assembled that:

SECTION 1. SHORT TITLE. This ordinance shall be known as "An Ordinance








SECTION 2. ARTICLE E, CHAPTER V of MUNICIPAL ORDINANCE NO. 126, S-2020 is hereby amended to read as follows:

“Section 5e. 01. Imposition of Charges. - The fees and charges provided herein shall be collected for the water services operated and managed by the Municipal Waterworks System.

Section 5e. 02. Time of Payment. - The water rental is due and payable to the Office of the Municipal Treasurer within the first five (5) working days of the following month after the receipt of the bill.












Section 5e. 03. Administrative Provisions.

- a. A written application filed to the Office of Villaba Municipal Waterworks or Municipal Treasurer's Office shall be required in order to avail the abovementioned services;
- b. A cash or guarantee deposit in the amount of three hundred pesos (Php 300.00) shall be required for every customer or applicant prior to rendering of initial service. The said deposit shall answer for any unpaid, due and demandable water charges or bill in accordance with the foregoing rates, which shall automatically be set-off against the cash deposit for failure to pay the monthly fee beyond five (5) working days of the following month. In case where the cash deposit is insufficient to cover the water bills and charges, the same shall be disconnected for failure of the customer to settle the difference;
- c. For billing purposes, a water meter shall be read one (1) month after its connection and every month thereafter. Reading of meter shall be held every first week of the following month;
- d. For reconnection of service upon the request of the customer after it has been disconnected for its delinquency, a reconnection fee in the amount of three hundred pesos (Php 300.00) shall be charged. However, in case of re-opening of connection upon the request of the customer due to voluntary disconnection, a re-opening fee of five hundred pesos (Php 500.00) shall be collected for the said service;
- e. Service connection for residential use shall not use pipes bigger than one-half (1/2) inch in diameter;
- f. Service connection using pipes bigger than the one mentioned in the preceding paragraph, it shall be allowed. Provided, that it is for commercial or industrial purposes only;
- g. Every multi-door apartment or boarding house/s shall have a separate water service connection and separate water meter for every occupant or lessee therein;
- h. Delinquent consumers account with unpaid water charges from previous years, a promissory note filed with the Municipal Treasurer's Office shall be required to settle the same in staggered basis. However, failure of the former to comply the agreed installment terms of payment, the consumer shall be automatically declared in default, and the unpaid amount shall become due and demandable. Disconnection shall then be made.

Section 5e. 04. Rebates and Penalties.

- a. A two percent (2%) rebates from the current amount due shall be granted if payment is made on the due date and within five (5) working

days of the following month. However, delinquent consumers shall not be entitled for such benefits;

- b. A penalty of five percent (5%) to all unpaid amount shall be charged for failure to pay the bill within the prescribed period as mentioned in Section 5e. 02 of this Ordinance. The same penalty shall be charged to all unpaid bills which became due for several years.
- c. A disconnection of water service shall be implemented for being delinquent for two (2) consecutive billing periods. Water meter shall be confiscated and deposited in the Municipal Treasurer's Office.
- d. A fine of Five Hundred Pesos (Php 500.00) shall be charged for replacement of new water meter without the authority of Villaba Municipal Waterworks or Municipal Treasurer's Office.
- e. Any consumer illegally tapping of water lines after disconnection of services due to delinquency, shall be charged the amount of Two Thousand Pesos (Php 2,000.00) as penalty.

SECTION 3. SEPARABILITY CLAUSE. If for any reason or reasons, any part or provision of this ordinance shall be held unconstitutional or invalid, other parts hereof which are not affected thereby shall continue to be in full force and in effect.

SECTION 4. REPEALING CLAUSE. Any ordinance, rules and regulations and executive issuances found inconsistent with the provisions of this ordinance are hereby repealed or modified accordingly.

SECTION 5. EFFECTIVITY. This ordinance shall take effect upon its approval.





Mrs. Ana Marie B. Sarino, the Acting Municipal Treasurer manifested that all the suggestions were duly noted. On the other hand, she manifested that the proposed ordinance will take effect on January 2026.


Hon. Roque M. Compra, Sangguniang Bayan Member clarified that when a consumer is delinquent and disconnected for its delinquency, will that consumer be charged of the corresponding penalties?

Mrs. Sarino answered to the affirmative.
