101 Yes, go ahead, Mr. Floor Leader.

103 I was not able to prepare a Committee Report but yesterday I visited the Cebu Port
104 Authority and had a meeting with General Manager and Vice Chairman of the Port
105 Authority, Francisco C. Comendador III and the representative of the private sectors, the
106 Shipper's Commissioner Joy Roble. I was inquiring, pursuant to our resolution, why
107 several trips in the shipping industry were canceled and why they posted an 1,800 fuel
108 adjustment fees for the cargoes and the fare were double like for example from 100 to
109 200. That is the situation, so I inquired with them.

110 There is no written report but I think is of the essence. They were explaining the
111 whole sale hosted price as what they call for the industrial price. It used to be that their
112 price was lower than the retail. In the gasoline station, for example if the price of Deisel is
113 90, their price is 80. So, there is a 10–12-peso difference that makes the industrial
114 cheaper. But it has become strange because retail is cheaper compared to industrial.
115 Yesterday, when we were at the meeting, they called the suppliers. The retail was 94
116 pesos per liter of Deisel while in the industrial, they called two suppliers, one is 101 and

117 the other is 103 per liter. In the case of Roble Shipping, they use 1 million liters a month.
118 The difference of 12 pesos for them is 12 million. So, it has disrupted their finances. So,
119 that is the situation. Board Member Kabigting and myself experienced that situation where
120 all flights has been canceled. So, I also inquired about that then I knew na ang
121 pinakamahal pala is the Aviation gas, it's like kerosene and the most expensive that is
122 why airlines had to adjust and that was the time na simulang mag peak ang prices. That's
123 all for the verbal committee report from the Committee on Disaster Risk and Reduction
124 Management. Thank you, Mr. Chair.
