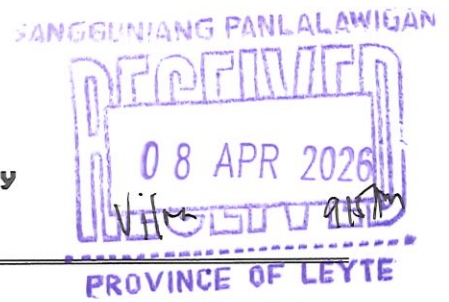

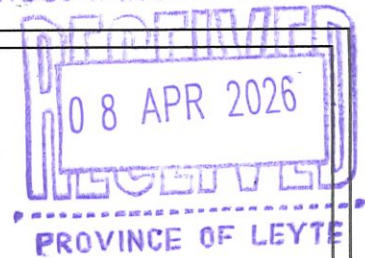

SERIES OF 2026

AN ORDINANCE INSTITUTIONALIZING THE GRANT OF INCENTIVES TO ATHLETES AND COACHES FROM THE MUNICIPALITY OF JARO, LEYTE WHO BRING HONOR BY QUALIFYING AND/OR WINNING IN LOCAL, REGIONAL, NATIONAL, AND INTERNATIONAL SPORTS COMPETITIONS, AND PROVIDING FUNDS THEREOF.

INTRODUCED BY: HON. VIANCA MAE N. FAMILAR
Chairman on Committee on Youth, Sports and Development

WHEREAS, section 16 of the Local Government Code (Republic Act No. 7160) empowers local government units to promote the general welfare of their constituents, including the formulation and implementation of programs for the development of youth and the advancement of sports;

WHEREAS, the Municipality of Jaro, Leyte recognizes the outstanding dedication, discipline, and achievements of student-athletes and resident athletes who bring honor to the municipality and the country through their participation in local, regional, national, and international sports competitions;

WHEREAS, it is deemed necessary to institutionalize a system of incentives and recognition for these athletes and their coaches, as a means of rewarding excellence, motivating continuous participation, and providing support for their training and development;

NOW THEREFORE, BE IT ORDAINED by the Sangguniang Bayan of the Municipality of Jaro, Leyte, in session duly assembled, that:

SECTION 1. TITLE- This Ordinance shall be known as the “**Sports Excellence and Athlete Incentives Ordinance of Jaro, Leyte.**”

SECTION 2. COVERAGE- This Ordinance shall apply to all bona fide student-athletes and community-based athletes who fall within the scope of this measure, including those who are residents of the Municipality of Jaro and those who, though not currently residing therein, can establish verifiable roots or affiliation with the Municipality of Jaro and have brought honor and recognition to the same, subject to the following criteria:

1. They are resident of the Municipality of Jaro, as evidenced by any valid proof of residency, or athletes who can sufficiently establish their roots, origin, or verifiable affiliation with the Municipality of Jaro;
2. They represent their school, institution, sports club, the Municipality of Jaro, or the Philippines in officially recognized sports competitions;
3. They have qualified for, participated in, or won medals in any of the following levels of sports activities or competitions:
 - Local and Regional Competitions such as the Provincial Meet, EVRAA, and SCUAA;
 - National Competitions such as the Philippine National Games, Palarong Pambansa, and Batang Pinoy;
 - International Competitions such as the Southeast Asian (SEA) Games, Asian-level tournaments, World Championships, and the Olympic Games;
4. They have brought honor, recognition, and prestige to the Municipality of Jaro or the country through their participation, qualification, or victory in the above-mentioned sports activities.

This Ordinance also extends the same coverage to coaches, trainers, or mentors who have directly supervised said athletes and contributed to their athletic performance, subject to validation and qualification requirements.

SECTION 3. SPORTS COMPETITIONS COVERED- This Ordinance shall apply to athletes and coaches participating in the following officially recognized sports competitions, categorized according to their scope and level of representation. Only sanctioned, accredited, or government-recognized sports events shall be covered.

A. LOCAL AND REGIONAL COMPETITIONS

1. These include athletic events representing schools, districts, zones, municipalities, or regions within the Philippines:
2. Provincial Meet
3. Eastern Visayas Regional Athletic Association (EVRAA)
4. State Colleges and Universities Athletic Association (SCUAA)
5. Other DepEd, CHED, or LGU-recognized regional sports events

B. NATIONAL COMPETITIONS



These include events where athletes represent their school, local government unit, or region at the national level:

1. Philippine National Games (PNG)
2. Palarong Pambansa
3. Batang Pinoy
4. Other national tournaments organized or sanctioned by PSC, PATAFA, NSA, or other National Sports Associations

C. INTERNATIONAL COMPETITIONS

These include events where athletes represent the Philippines or are accredited to compete in recognized international sports federations:

1. Southeast Asian (SEA) Games
2. Asian Games
3. World Championships in various sports
4. Olympic Games



- 5. Other international competitions officially sanctioned by the Philippine Sports Commission (PSC), Philippine Olympic Committee (POC), or an International Sports Federation

D. GENERAL PROVISION

Only athletes and coaches who formally qualify, participate, or win in the competitions listed above shall be entitled to incentives under this Ordinance. Additional competitions may be recognized through the recommendation of the Office of the Municipal Mayor, subject to approval by the Sangguniang Bayan.

SECTION 4. INCENTIVES- The following incentives shall be granted *per event* and *per athlete*, upon validation and submission of requirements:

E. Incentives for Coaches

Coaches shall receive a minimum of twenty-five percent (25%) of the incentive awarded to the athlete per event.

F. Special Citation

All qualifiers and medalists shall receive a **Certificate of Recognition** during the annual Municipal Athletes' Recognition Ceremony.

SECTION 5. REQUIREMENTS FOR GRANTING INCENTIVES- The athlete must submit the following:

- a. Proof of residency;
- b. Certification of participation issued by the school district supervisor, sports coordinator, event organizer, or the Philippine Sports Commission;
- c. Official results or medal tally or any official documents that prove your participation;

SECTION 6. IMPLEMENTING OFFICE- The Office of the Municipal Mayor, through the Sangguniang Kabataan (SK) Federation Office and the Local Youth Development Office (LYDO), shall serve as the primary implementing bodies of this Ordinance.

They shall be responsible for the following:

1. Processing, verification, and validation of athlete and coach documents, including proof of residency, competition results, certifications, and endorsements.

2. Coordinating with schools, sports coordinators, coaches, and concerned sports organizations to authenticate participation and achievements.
3. Preparing the evaluation report and incentive computation for approval by the Office of the Mayor.
4. Facilitating the disbursement of incentives in coordination with the Municipal Treasurer's Office and the Municipal Accountant's Office.
5. Maintaining a centralized database of all athletes and coaches who qualify for incentives under this Ordinance.
6. Leading the annual Municipal Athletes' Recognition Ceremony, in collaboration with the Municipal Sports Development Office and other relevant offices.
7. Recommending updates, amendments, or expansions to the incentive system based on emerging sports programs and national standards.

Other concerned departments may be tapped for technical assistance, certification validation, and any other support deemed necessary for the effective implementation of this Ordinance.



SECTION 7. FUNDING- Funds shall be sourced from:

- a. Municipal Sports Development Fund;
- b. Youth Development Fund (YDF) allocation for sports;
- c. Supplemental budget.
- d. Other funds legally appropriated.

The LGU shall ensure an annual budget allocation for program continuity.

SECTION 8. AWARDING OF INCENTIVES- The release of incentives shall be made within **thirty (30) days** upon submission and verification of all required documents by the implementing offices.

A **Municipal Athletes' Recognition Ceremony** shall be conducted annually under the Office of the Municipal Mayor, in coordination with the SK Federation Office and the Local Youth Development Office (LYDO), to formally award the incentives, certificates, and recognitions to all qualified athletes and coaches.



In cases where immediate release is necessary-such as participation in another upcoming competition-the incentives may be released earlier, subject to the approval of the Municipal Mayor, provided that all requirements have been duly submitted and validated.

SECTION 9. SEPARABILITY CLAUSE- If any provision of this ordinance is declared invalid, the remaining provisions shall remain in effect.

SECTION 10. REPEALING CLAUSE- All inconsistent ordinances or parts thereof are hereby repealed or modified accordingly.

SECTION 11. EFFECTIVITY- This ordinance shall take effect upon approval and compliance with posting requirements under RA 7160.




A MUNICIPAL ORDINANCE APPROVING THE ANNUAL BUDGET OF THE LOCAL GOVERNMENT UNIT OF JARO FOR FISCAL YEAR 2026, ENACTING APPROPRIATION ORDINANCE NO.01, SERIES OF 2026, IN THE TOTAL AMOUNT OF THREE HUNDRED TWENTY-SEVEN MILLION, THIRTY-TWO THOUSAND, SIX HUNDRED EIGHTY-FIVE PESOS (PHP 327, 032,685.00) COVERING THE VARIOUS EXPENDITURES FOR THE OPERATION OF THE MUNICIPAL GOVERNMENT OF JARO, LEYTE FOR FISCAL YEAR 2026 AND APPROPRIATING THE NECESSARY FUNDS THEREFORE.

Hon. Carmencita clarified that based on the concerned of Hon. Francisco Altres regarding the existing balance the **Twenty-Five Million Six Hundred Twenty-Five Thousand Two Hundred Seventy-Three Pesos and Five Centavos (Php 25,625, 275.05)** are just estimated.

She also added that regarding the purchase of vehicle is not possible since the budget is reenacted.

The Chair stated that the matter may be addressed through a supplemental budget. However, due to the current budget constraints of the infirmary, the proposed purchase of a vehicle may not be feasible this year. He emphasized that priority will be given to the infirmary's budget. He also noted that the proposal has not yet been submitted to the Municipal Mayor.

The Chair gave the floor to Hon. Carmencita G. Tañala to offer the motion.




AN ORDINANCE IMPOSING THE CURFEW HOURS AGAINST MINORS BELOW 18 YEARS OLD FROM 10:00 P.M. TO 4:00 A.M., AMENDING MUNICIPAL ORDINANCE NO. 14, SERIES OF 1992, PROVIDING PENALTIES THEREOF AND FOR OTHER PURPOSES.

Hon. Teofilo Cabello presented the amendments follows;


SECTION 3. DEFINITION OF TERMS-

A. Curfew hours- Means the hour from 10:00 P.M to 4:00 A.M the next morning. On the account off the Annual Town Fiesta, Christmas, and NewYear Celebrations, curfew hours from November 27 to December 31 shall be from 12:00MN to 4:00A.M. On Christmas Eve (December 24) and NewYear's eve (December 31) celebration in the Barangays, curfew hours shall be from 12:00MN to 4:00A.M. On annual barangay fiesta celebrations, the celebrating barangay on vesper night shall have curfew hours from 12:00MN to 4:00 A.M.

- E. Minor Violator** – a minor who violated this ordinance.
- G. Apprehension** – the act through which the minor is placed under temporary control and custody of the law enforcement office, social worker, the Barangay Council for the Protection of Children (BCPC), and the women and Children`s Crisis Center.
- H. Parents-** (5) A person who is biological parent, adoptive parent or a stepparent of a minor.
- M. Guardian**– means;
 - 1. A person who has been appointed by court as guardian of the minor
 - 2. A public or private agency with whom a minor has been placed for custody by a court.
 - 3. A person in charge of the custody or who is taking care of minor, whether relative or not.
 - 4. A person who is at least 18 years of age and authorize by the parent of guardian to accompany a minor in a public place or to have the care and custody over him/her.
- N. Barangay Council for the Protection of Children (BCPC)** – the barangay council tasked to implement the rules of this ordinance, council the minor, his/her parent/s or guardian/s, and to coordinate with proper government institution/s, or agency for the general welfare of the minor found in violation of this ordinance.
- O. Municipal Social Welfare Development Office (MSWDO)** – the office assigned to formulate and implement comprehensive programs and services to minors of this ordinance.
- P. Law Enforcement Officer** – A government employee or official such as a person in authority, his/her agent as defined in Article 152 of the Revised Penal Code, a Policeman or a Barangay Tanod who is responsible for prevention, investigation and apprehension of individuals suspected or found to have violated any provision of this Ordinance.
- Q. Child at Risk** – refers to a child who is vulnerable to and at the risk of committing criminal offenses because of personal, family and social circumstances, such as, but not limited to the following:


1. Being abused by any person through **sexual, physical, psychological, mental, economic** or any other, means and the parents or guardian refuse, are unwilling, or unable to provide protection for the child;
2. Being exploited including **sexually or economically**.
3. **Being abandoned or neglected**, and after diligent search and inquiry, the parent or guardian cannot be found;
4. **Coming from a dysfunctional or broken family** or without a parent or guardian;
5. **Being out of school**;
6. **Being a street child**;
7. **Being a member of a gang**;
8. **Living in a community with a high level of criminality or drug abuse**;
9. **Living in situations of armed conflict**.

R. **BCPC Certification of Attendance – Certification providing the attendance of the minor violator together with the parent/guardians to the BCPC seminar and counselling.**

SECTION 6. PENALTIES – Violations of this ordinance shall be penalized as follows:

1st OFFENSE– the minor violator, together with his/her parent/guardian shall undergo counseling at the MSWDO the following morning, except for Saturdays and Sundays. Counseling shall resume the following Monday. The minor will then be referred to the Barangay Council for the Protection of Children for proper recording on the Registry of Child at Risk (CAR) and Children in Conflict with Law (CICL) and for counseling by the BCPC. The BCPC shall issue a Certification of Attendance to the violator and his/her parent/guardian to be presented to the Punong Barangay for recording as a requirement under 2nd Offense of this Section.

2nd OFFENSE– the minor violator, together with his/her parent/guardian shall undergo counseling at the MSWDO the following morning, except for Saturdays and Sundays. Counseling shall resume the following Monday. The minor will then be referred to the Barangay Council for the Protection of Children for proper recording on the Registry of Child at Risk (CAR) and Children in Conflict with Law (CICL).



Further, the parent/guardian shall be required to attend a Parent education Seminar. The BCPC shall coordinate with the Municipal Population Officer for scheduling and for performing the seminar. The parent/guardian shall render community service for 8 hours. The community service be facilitated and supervised by the BCPC. The BCPC shall issue a Certification of Attendance to the parent/guardian to be presented to the Punong Barangay for recording as requirements under 3rd Offense of this Section. Moreover, within ten (10) days from apprehension, the parent/ guardian shall plant two (2) fruit Bearing trees in their barangay for which Certificate of Compliance shall be issued and forwarded by the BCPC to the Punong Barangay.

3rd OFFENSE- the minor violator, together with his/her parent/guardian shall undergo counseling at the MSWDO the following morning, except for Saturdays and Sundays. Counseling shall resume the following Monday. The minor will then be referred to the Barangay Council for the Protection of Children for proper recording on the Registry of Child at Risk (CAR) and Children in Conflict with Law (CICL).





Further, minor violator, together with his/her parent/guardian shall undergo an intervention program facilitated and supervised by the BCPC. Monthly progress report shall be submitted by the BCPC to the MSWD Office for monitoring. Certificate of Compliance or Certificate of Non-Compliance shall be submitted by the Chairman of BCPC to the MSWDO. In case of Non- Compliance, the BCPC shall set another conference with the parent/guardians and the minor to discuss the problem, and agreement has to be made. This shall be monitored by the MSWDO.

The Chair sought clarification regarding minors who do not have parents and who have committed serious crimes but cannot be imprisoned.

Hon. Teofilo Cabello responded that the Department of Social Welfare and Development (DSWD) and the BCPS will take charge of such cases.

Hon. Lanulfo M. Borja stated that the ordinance primarily covers curfew hours. However, during daytime outside Granja Kalinawan National High School, there are minors engaging in gambling activities. Since these incidents occur outside curfew hours, they are not covered by the ordinance, which he noted as a gap that needs to be addressed.

Hon. Macanda asked whether the ordinance applies only to individuals aged 18 and below. He further stated that there are cases where parents instruct their minor children to purchase liquor, which is prohibited, and inquired whether this would pose any issues.



Hon. Teofilo Cabello stated that he had previously passed an ordinance prohibiting minors from purchasing liquor and cigarettes. He added that this ordinance will be strictly implemented alongside the curfew ordinance through public announcements and proper dissemination.

Hon. Macanda suggested including in the ordinance provisions addressing minors who engage in lottery betting.

Hon. Cabello stated that he would revisit the ordinance and reminded the body that minors are also not allowed to stay in computer shops during class hours.

Hon. Vianca Familiar stated that during their upcoming KK Assembly, she will announce and explain the ordinance to the youth. She further suggested including provisions concerning minors who are accepted into lodging houses without proper identification, as well as minors who join gangs. She added that she and Hon. Cabello intend to propose a separate ordinance to address these concerns.

Hon. Cabello stated that the ordinance remains open for amendments during the third and final reading and the public hearing. He assured that all constructive suggestions and comments raised during the public hearing will be duly noted.

Hon. Zandro T. Morabe suggested highlighting the PNP hotline numbers in every barangay to ensure proper reporting and coordination.



Hon. Rey P. Aure inquired about minors who are not on the streets but are staying inside coin-operated Wi-Fi spots during curfew hours.





OTHER MATTERS:

1. The Municipal Local Government Operations Officer, Mr. Jude Allan S. Villero, presented several important programs and expressed his intention to orient the Sangguniang Bayan (SB) Members. He also sought the support of the august body for the successful implementation of these programs.

a. **Foreign Travel Authority**

He emphasized that the government has tightened regulations on foreign travel. Municipal and provincial officials must secure a Travel Authority approved by the Regional Director. Emergency travel must be approved by the DILG Secretary through the Central Office.

All elected and appointed officials, from the municipal level down to the barangay level, are covered by this requirement.



b. **For official travel, the following documents are required:**

- i. Duly notarized affidavit stating that no administrative or criminal case has been filed against the applicant
- ii. Clearance from Money and Property Accountability
- iii. Invitation Letter
- iv. Capacity Development Agenda
- v. Travel Itinerary
- vi. Travel Order issued by the immediate superior
- vii. For unofficial or personal travel, the following are required:
- viii. Approved Leave of Absence
- ix. Duly notarized affidavit stating that no administrative or criminal case has been filed against the applicant
- x. Clearance from Money and Property Accountability

c. **Barangay Assembly Day**

He stated that, as much as possible, their office will participate in the upcoming Barangay Assembly Day activities.

d. **Retooled Community Support Program (RCSP)**




He explained that this program is in relation to Executive Order No. 70 concerning the Local Communist Armed Conflict (LCAC). Jaro is among the areas identified with the presence of communist groups. The program adopts a whole-of-nation approach to end armed conflict.

e. **Local Legislative Awards**

He informed the body that the Sangguniang Bayan will participate and aim to qualify for the Local Legislative Awards. The criteria will be discussed at a later time with the SB Secretary and the Vice Mayor.

The policy applies to all elected officials. Government programs must not be named after any official, and personal branding is strictly prohibited.



Violations may result in penalties ranging from fines of Php 500,000.00 to Php 2,000,000.00 and imprisonment of up to six (6) months.

The Barangay Assembly is scheduled on the following dates: March 1, 14, 15, 20, 21, 22, 28, and 29, 2026.

WHEREAS, section 16 of the Local Government Code (Republic Act No. 7160) empowers local government units to promote the general welfare of their constituents, including the formulation and implementation of programs for the development of youth and the advancement of sports;

WHEREAS, the Municipality of Jaro, Leyte recognizes the outstanding dedication, discipline, and achievements of student-athletes and resident athletes who bring honor to the municipality and the country through their participation in local, regional, national, and international sports competitions;

WHEREAS, it is deemed necessary to institutionalize a system of incentives and recognition for these athletes and their coaches, as a means of rewarding excellence, motivating continuous participation, and providing support for their training and development;




NOW THEREFORE, BE IT ORDAINED by the Sangguniang Bayan of the Municipality of Jaro, Leyte, in session duly assembled, that:

SECTION 1. TITLE- This Ordinance shall be known as the “**Sports Excellence and Athlete Incentives Ordinance of Jaro, Leyte.**”

SECTION 2. COVERAGE- This Ordinance shall apply to all bona fide student-athletes and community-based athletes who fall within the scope of this measure, including those who are residents of the Municipality of Jaro **and those who, though not currently residing therein, can establish verifiable roots or affiliation with the Municipality of Jaro and have brought honor and recognition to the same**, subject to the following criteria:

1. They are resident of the Municipality of Jaro, as evidenced by any valid proof of residency, or athletes who can sufficiently establish their roots, origin, or verifiable affiliation with the Municipality of Jaro;
2. They represent their school, institution, sports club, the Municipality of Jaro, or the Philippines in officially recognized sports competitions;
3. They have qualified for, participated in, or won medals in any of the following levels of sports activities or competitions:
 - Local and Regional Competitions such as the Provincial Meet, EVRAA, and SCUAA;
 - National Competitions such as the Philippine National Games, Palarong Pambansa, and Batang Pinoy;
 - International Competitions such as the Southeast Asian (SEA) Games, Asian-level tournaments, World Championships, and the Olympic Games;
4. They have brought honor, recognition, and prestige to the Municipality of Jaro or the country through their participation, qualification, or victory in the above-mentioned sports activities.

This Ordinance also extends the same coverage to coaches, trainers, or mentors who have directly supervised said athletes and contributed to their athletic performance, subject to validation and qualification requirements.



SECTION 3. SPORTS COMPETITIONS COVERED- This Ordinance shall apply to athletes and coaches participating in the following officially recognized sports competitions, categorized according to their scope and level of representation. Only sanctioned, accredited, or government-recognized sports events shall be covered.

A. LOCAL AND REGIONAL COMPETITIONS

1. These include athletic events representing schools, districts, zones, municipalities, or regions within the Philippines:
2. Provincial Meet
3. Eastern Visayas Regional Athletic Association (EVRAA)
4. State Colleges and Universities Athletic Association (SCUAA)
5. Other DepEd, CHED, or LGU-recognized regional sports events

B. NATIONAL COMPETITIONS


These include events where athletes represent their school, local government unit, or region at the national level:

1. Philippine National Games (PNG)
2. Palarong Pambansa
3. Batang Pinoy
4. Other national tournaments organized or sanctioned by PSC, PATAFA, NSA, or other National Sports Associations

C. INTERNATIONAL COMPETITIONS

These include events where athletes represent the Philippines or are accredited to compete in recognized international sports federations:

1. Southeast Asian (SEA) Games
2. Asian Games
3. World Championships in various sports
4. Olympic Games



5. Other international competitions officially sanctioned by the Philippine Sports Commission (PSC), Philippine Olympic Committee (POC), or an International Sports Federation

D. GENERAL PROVISION

Only athletes and coaches who formally qualify, participate, or win in the competitions listed above shall be entitled to incentives under this Ordinance. Additional competitions may be recognized through the recommendation of the Office of the Municipal Mayor, subject to approval by the Sangguniang Bayan.

SECTION 4. INCENTIVES- The following incentives shall be granted *per event* and *per athlete*, upon validation and submission of requirements:

E. Incentives for Coaches

SECTION 5. REQUIREMENTS FOR GRANTING INCENTIVES- The athlete must submit the following:

- a. Proof of residency;
- b. Certification of participation issued by the school district supervisor, sports coordinator, event organizer, or the Philippine Sports Commission;
- c. Official results or medal tally or any official documents that prove your participation;

SECTION 6. IMPLEMENTING OFFICE- The Office of the Municipal Mayor, through the Sangguniang Kabataan (SK) Federation Office and the Local Youth Development Office (LYDO), shall serve as the primary implementing bodies of this Ordinance.

They shall be responsible for the following:

- 1. Processing, verification, and validation of athlete and coach documents, including proof of residency, competition results, certifications, and endorsements.

2. Coordinating with schools, sports coordinators, coaches, and concerned sports organizations to authenticate participation and achievements.
3. Preparing the evaluation report and incentive computation for approval by the Office of the Mayor.
4. Facilitating the disbursement of incentives in coordination with the Municipal Treasurer's Office and the Municipal Accountant's Office.
5. Maintaining a centralized database of all athletes and coaches who qualify for incentives under this Ordinance.
6. Leading the annual Municipal Athletes' Recognition Ceremony, in collaboration with the Municipal Sports Development Office and other relevant offices.
7. Recommending updates, amendments, or expansions to the incentive system based on emerging sports programs and national standards.

Other concerned departments may be tapped for technical assistance, certification validation, and any other support deemed necessary for the effective implementation of this Ordinance.



SECTION 7. FUNDING- Funds shall be sourced from:

- a. Municipal Sports Development Fund;
- b. Youth Development Fund (YDF) allocation for sports;
- c. Supplemental budget.
- d. Other funds legally appropriated.

The LGU shall ensure an annual budget allocation for program continuity.

SECTION 8. AWARDING OF INCENTIVES- The release of incentives shall be made within **thirty (30) days** upon submission and verification of all required documents by the implementing offices.

A **Municipal Athletes' Recognition Ceremony** shall be conducted annually under the Office of the Municipal Mayor, in coordination with the SK Federation Office and the Local Youth Development Office (LYDO), to formally award the incentives, certificates, and recognitions to all qualified athletes and coaches.



In cases where immediate release is necessary-such as participation in another upcoming competition-the incentives may be released earlier, subject to the approval of the Municipal Mayor, provided that all requirements have been duly submitted and validated.

SECTION 9. SEPARABILITY CLAUSE- If any provision of this ordinance is declared invalid, the remaining provisions shall remain in effect.

SECTION 10. REPEALING CLAUSE- All inconsistent ordinances or parts thereof are hereby repealed or modified accordingly.

SECTION 11. EFFECTIVITY- This ordinance shall take effect upon approval and compliance with posting requirements under RA 7160.

SERIES OF 2026**

AN ORDINANCE ENACTING THE COMPREHEHNSIVE SPORTS AND DEVELOPMENT CODE OF THE MUNICIPALITY OF JARO, PROVINCE OF LEYTE, PROVIDING FOR A SYSTEMATIC, INCLUSIVE, AND SUSTAINABLE SPORTS DEVELOPMENT PROGRAM, CREATING THE NECESSARY STRUCTURES AND OTHER PUPRPOSES

INTRODUCED BY: HONORABLE VIANCA MAE N. FAMILAR
Chairman on Committee on Youth, Sports and Development

WHEREAS, Sports play a vital role in promoting physical and mental health, character formation, discipline, teamwork, social cohesion, peace-building, and youth development in the community.

WHEREAS, The Municipality of Jaro recognizes the need for a comprehensive, coordinated, and long-term policy framework to strengthen grassroots sports, athlete development, and community participation in sports and physical activities.



WHEREAS, The proposed Jaro Comprehensive Sports Development Code of 2026 seeks to institutionalize inclusive and sustainable sports programs, establish appropriate governance mechanisms, and ensure the proper management, maintenance, and utilization of municipal sports facilities, including the Jaro Sports Arena and the Jaro Sports Gymnasium.

WHEREAS, The Code provides for the creation of the Municipal Sports Development Council (MSDC) and the Sports Development Unit, the formulation of a Municipal Sports Development Plan, the institutionalization of grassroots and barangay sports programs, the conduct of an Annual Municipal Sports Calendar and the Salugnon Sports Cup, and the promotion of safe, child-friendly, and inclusive sports environments.

WHEREAS, The adoption of this Code is consistent with national policies on sports development, youth empowerment, public health, and local governance, and supports the Municipality's commitment to holistic and participatory development.



NOW THEREFORE, BE IT ORDAINED by the Sangguniang Bayan of the Municipality of Jaro, Leyte, in session duly assembled, that:

**ARTICLE I
TITLE, POLICY, AND OBJECTIVES**

SECTION 1. TITLE- This Ordinance shall be known and cited as the *"The Jaro Comprehensive Sports Development Code of 2026"*.

SECTION 2. DECLARATION OF POLICY- It is hereby declared the policy of the Municipality of Jaro to:

- a. Recognize the importance of sports in promoting physical fitness, mental health, discipline, teamwork, and character formation, particularly among children and youth.
- b. Support sports as a tool for nation-building, social cohesion, peace, and community development.
- c. Ensure that sports programs and facilities of the Municipality are safe, inclusive, accessible, and responsive to the needs of all sectors, including children, youth, women, persons with disabilities, indigenous peoples, and senior citizens.



- d. Align local sports development with national sports policies and programs, including those of the Department of Education (DepEd), the Philippine Sports Commission (PSC), and other concerned agencies.




SECTION 3. OBJECTIVES- This Code aims to:

- a. Establish a comprehensive, long-term sports development framework for the Municipality.
- b. Create and strengthen institutional mechanisms for planning, implementing, monitoring, and evaluating sports programs.
- c. Promote grassroots sports in all barangays and schools and develop pathways for talented athletes towards higher levels of competition.
- d. Ensure safe and child-friendly sports environments, free from abuse, hazing, harassment, and discrimination.
- e. Provide adequate and sustainable funding for sports programs, facilities, and human resource development.

**ARTICLE II
DEFINITION OF TERMS**

SECTION 4. DEFINITION OF TERMS- For purposes of this Code, the following terms are defined:

- a. **Sports**– Any organized physical activity or game, competitive or recreational, governed by rules, promoting physical fitness, skills, teamwork, and fair play.
- b. **Grassroots Sports**– Community-based, mass participation sports programs intended to encourage participation, develop basic skills, and identify potential athletes at the barangay and school levels.
- c. **Athlete**– Any individual who regularly participates in sports training and competitions, whether amateur or elite, representing a barangay, school, organization, or the Municipality.
- d. **Coach/Trainer**– A person who plans, leads, or supervises sports training and development of athletes.
- e. **Sports Official/Referee/Umpire**– A person who enforces the rules and regulations of a sport during competitions.



- f. **Sports Program**– A planned series of sports-related activities or interventions, including training, tournaments, clinics, festivals, and capacity-building activities.
- g. **Sports Facility**– Any place, building, or open space designed or regularly used for sports activities, such as gymnasiums, courts, fields, open grounds, fitness trails, and similar areas.
- h. **Persons with Disabilities (PWD)**– Those who have long-term physical, mental, intellectual, or sensory impairments, which in interaction with barriers may hinder their full and effective participation in sports and social life on an equal basis with others.
- i. **Youth**– Persons 15 to 30 years old, without prejudice to any subsequent changes adopted by national law.
- j. **Children**– Persons below 18 years of age.

**ARTICLE III
INSTITUTIONAL MECHANISMS**

SECTION 5. JARO SPORTS DEVELOPMENT COUNCIL (JSDC)- There is hereby created a Jaro Sports Development Council (JSDC) for the Municipality of Jaro to ensure the effective planning, coordination, and integration of all municipal sports development programs and initiatives.

SECTION 6. COMPOSITION- The JSDC shall be composed of:




SECTION 7. FUNCTIONS OF THE JSDC- The JSDC shall:

- a. Formulate and periodically update the Municipal Sports Development Plan (MSDP) aligned with the Municipal Development Plan and Youth Development Plan.
- b. Recommend priority sports, programs, and projects for funding and implementation.
- c. Coordinate with national government agencies, NGOs, schools, and sports organizations.
- d. Recommend policies on the management, maintenance, and utilization of sports facilities.
- e. Promote adherence to safe, child-friendly, and gender-sensitive sports practices.
- f. Submit an annual report on the status of sports development in Jaro to the Sangguniang Bayan.

**ARTICLE IV
MUNICIPAL SPORTS DEVELOPMENT OFFICE AND FOCAL PERSON**

SECTION 8. SPORTS DEVELOPMENT UNIT- The Municipality shall designate or create a Sports Development Unit under the Office of the Mayor, the Local Youth Development Office, or another appropriate office, to serve as the secretariat and implementing arm of the JSDC.




SECTION 9. FUNCTIONS OF THE SPORTS DEVELOPMENT UNIT- The Sports Development Unit shall:

- a. Assist the JSDC in formulating the Municipal Sports Development Plan.
- b. Implement sports programs and projects approved by the JSDC and Sanggunian.
- c. Maintain a database of athletes, coaches, officials, and sports organizations.
- d. Coordinate the scheduling and use of municipal sports facilities and equipment.
- e. Support barangays and schools in organizing their sports activities.
- f. Ensure monitoring and documentation of sports activities and results.

**ARTICLE V
SPORTS PLANNING AND PRIORITY SPORTS**

SECTION 10. MUNICIPAL SPORTS DEVELOPMENT PLAN (MSDP)- Within one year from the effectiveness of this Code, the JSDC shall formulate a three-year MSDP which shall include, at minimum:

- a. Priority sports for Jaro.
- b. Grassroots programs and talent identification mechanisms at barangay and school levels.
- c. Athlete development pathways from barangay to municipal, provincial, regional, and national competitions.
- d. Capacity development for coaches, trainers, referees, and sports volunteers.
- e. Facility development, upgrade, and maintenance plan.
- f. Inclusion strategies for children, youth, women, PWD, and vulnerable groups.
- g. Communication and advocacy strategies for sports promotion.
- h. Monitoring and evaluation framework.



SECTION 11. PRIORITY SPORTS- The JSDC shall identify priority sports based on:

- a. Existing strengths and interests of Jaro residents.
- b. Available facilities and environment.
- c. Opportunities for participation in provincial, regional, and national competitions.
- d. Potential of sports for tourism and economic benefits.

The list of priority sports may be updated through a JSDC resolution approved by the mayor.




**ARTICLE VI
GRASSROOTS SPORTS AND BARANGAY SPORTS PROGRAMS**

SECTION 12. BARANGAY SPORTS PROGRAM- Each barangay in the Municipality shall formulate and implement an annual Barangay Sports Program, in coordination with the Barangay Council, SK, LYDO, and Sports Development Unit.

SECTION 13. MINIMUM REQUIREMENTS FOR BARANGAY SPORTS PROGRAM- Each Barangay Sports Program shall:

- a. Include at least one team sport and one individual or non-traditional sport per year.
- b. Allocate part of the barangay and SK budget for sports activities, equipment, prizes, and maintenance of facilities.
- c. Encourage participation of children, youth, PWD, and girls/women.
- d. Integrate values formation, discipline, fair play, and anti-drugs/anti-gang messages.
- e. Coordinate with schools and community-based organizations.

SECTION 14. GRASSROOTS SPORTS CLINICS AND FESTIVALS- The Municipality, through the Sports Development Unit and JSDC, shall conduct periodic sports clinics, festivals, and summer sports programs focused on basic skills, fun, and mass participation.



**ARTICLE VII
ATHLETE, COACH, AND OFFICIAL DEVELOPMENT**

SECTION 15. ATHLETE DEVELOPMENT- The Municipality shall:

- a. Maintain a Municipal Pool of Athletes per sport, identified from grassroots programs, school meets, and municipal competitions.
- b. Provide, subject to availability of funds, training support such as facilities, uniforms, basic equipment, nutrition advice, and transportation during official training or competitions.
- c. Coordinate with DepEd, private schools, and sports associations for further training and competition opportunities.
- d. Encourage academic excellence and good conduct among athletes, in partnership with schools.

SECTION 16. COACHES AND TRAINERS' DEVELOPMENT- The Municipality shall:

- a. Maintain a list of accredited coaches and trainers per sport.
- b. Facilitate or support their participation in seminars, workshops, and certification by recognized sports authorities when possible.
- c. Adopt a Code of Conduct for Coaches and Trainers emphasizing child protection, non-abuse, non-discrimination, and safe training practices.

SECTION 17. SPORTS OFFICIALS AND REFEREES- The Municipality shall:




- a. Maintain an updated list of accredited referees, umpires, and table officials.
- b. Provide opportunities for training and accreditation.
- c. Implement a Code of Ethics for referees and officials to ensure fair, impartial, and professional officiating.

**ARTICLE VIII
SAFE, INCLUSIVE, AND CHILD-FRIENDLY SPORTS**

SECTION 18. SAFE SPORTS ENVIRONMENT- All sports programs, facilities, and activities under the Municipality and barangays shall:

- a. Be free from physical, verbal, emotional, and sexual abuse.

- b. Prohibit hazing, harmful initiations, and humiliating punishments in all teams and clubs.
- c. Ensure reasonable training loads, rest, and medical clearance where applicable, especially for children and youth.
- d. Prohibit the use of illegal drugs, performance-enhancing substances, and alcohol during sports activities.

This Code shall be read in harmony with any existing or future Anti-Hazing, Child Protection, and Mental Health Ordinances of the Municipality.

SECTION 19. GENDER SENSITIVITY AND INCLUSION- Sports programs shall:

- a. Ensure equal opportunities for girls and women to participate in sports activities and leadership roles.
- b. Promote a respectful, non-discriminatory environment regardless of sex, gender identity, religion, ethnicity, or socioeconomic status.
- c. Provide, as resources allow appropriate changing areas and sanitation facilities for females and PWD.

SECTION 20. PERSONS WITH DISABILITIES (PWD) AND SPECIAL GROUPS-



The Municipality shall:

- a. Designate and support inclusive sports activities that actively involve youth and persons with disabilities and other special groups.
- b. Whenever feasible, provide adaptive sports equipment and ensure that sports facilities are physically accessible, including paths of travel, seating, and basic amenities.
- c. Coordinate with PWD organizations, families, and relevant support groups in the planning, implementation, and evaluation of inclusive sports events and programs.

**ARTICLE IX
SPORTS FACILITIES AND EQUIPMENT**

SECTION 21. INVENTORY OF SPORTS FACILITIES- Within one year from the effectiveness of this Code, the Sports Development Unit, in coordination with barangays and the Municipal Engineer, shall prepare and maintain an inventory of all sports facilities in the Municipality, including ownership, condition, and usage.

SECTION 22. MAINTENANCE AND IMPROVEMENT- The Municipality shall:

- a. Encourage all barangays to allocate funds for the maintenance, repair and enhancement of their respective local sports facilities.
- b. Explore and pursue partnerships with the private sector, NGOs, and other organizations for the upgrading and expansion of sports facilities and related amenities.

SECTION 23. USE AND SCHEDULING OF MUNICIPAL SPORTS FACILITIES-
The Sports Development Unit shall:

- a. Manage schedules of municipal sports facilities to ensure fair and equitable use.
- b. Prioritize youth, school, and barangay sports activities.
- c. Issue guidelines on reservation, user fees (if any), and responsibilities of users.

SECTION 24. PROTECTION OF SPORTS FACILITIES- It shall be prohibited to:

- a. Vandalize, damage, or misuse sports facilities and equipment.
- b. Use sports venues for activities contrary to public morals, safety, or peace and order.
- c. Bring in illegal drugs, deadly weapons, or engage in violent acts within sports venues.




Violations may be subject to penalties under this Code and other applicable laws and ordinances.

SECTION 25. JARO SPORTS ARENA- The Jaro Sports Arena is hereby designated as the **principal outdoor sports facility** of the Municipality of Jaro. It shall serve as the primary venue for municipal-wide and inter-barangay sports competitions, training and coaching programs, physical fitness and wellness activities, and other lawful sports, youth, and community development initiatives.

The Sports Development Unit, in coordination with the Office of the Municipal Mayor and other concerned municipal offices, shall be responsible for the administration, operation, maintenance, and scheduling of the Jaro Sports Arena. In the utilization of the facility, priority shall be accorded to youth, school-based, barangay, and grassroots sports programs, subject to reasonable rules and equitable access.

SECTION 26. JARO SPORTS GYMNASIUM- The Jaro Sports Gymnasium is hereby designated as the principal indoor sports facility of the Municipality of Jaro. It shall be used for indoor sports competitions, training activities, physical fitness programs, and other lawful sports- and community-related events.

The Sports Development Unit, likewise, in coordination with the Office of the Municipal Mayor and other concerned offices, shall oversee the administration, operation, maintenance, and scheduling of the Jaro Sports Gymnasium. Priority in its use shall be given to youth, school-based, barangay, and grassroots sports activities, in accordance with established rules and regulations.

**ARTICLE X
SPORTS EVENTS, COMPETITIONS, AND RECOGNITION**



SECTION 27. MUNICIPAL SPORTS CALENDAR- The JSDC, through the Sports Development Unit, shall prepare an Annual Municipal Sports Calendar which shall include:

- a. Inter-barangay leagues.
- b. Municipal meets and championships.
- c. Sports festivals and clinics.
- d. Participation in provincial, regional, or invitational tournaments.

SECTION 28. ANNUAL SALUGNON SPORTS CUP- There shall be an Annual Salugnon Sports Cup, featuring multiple sports and inclusive categories, to be held on dates determined by the JSDC and approved by the Mayor.

SECTION 29. RECOGNITION AND INCENTIVES- The Municipality shall:

- a. Recognize outstanding athletes, coaches, officials, barangays, and schools during an annual awards program.
- b. Provide commendations or plaques, and where resources permit, modest incentives or assistance.
- c. Encourage private sector sponsorships for awards and incentives.

**ARTICLE XI
FUNDING AND RESOURCE MOBILIZATION**

SECTION 30. FUNDING SOURCES- Funds to implement this Code may be sourced from:

- a. Annual appropriations of the Municipal Government, including the General Fund and 20% Development Fund, where eligible.
- b. Barangay and SK budgets allocated for sports and youth development.
- c. Grants and assistance from national government agencies, such as PSC, DepEd, DOH, and others.
- d. Donations, sponsorships, and partnerships with private entities and NGOs, subject to existing laws.

SECTION 31. BUDGET PRIORITIZATION- The Municipal Budget Officer shall, as far as practicable, ensure that sports development is reflected as a priority in the annual budget proposals of relevant offices.


**ARTICLE XII
MONITORING, EVALUATION, AND REPORTING**

SECTION 32. MONITORING AND EVALUATION (M&E)- The JSDC shall establish simple M&E tools to track:

- a. Number and diversity of sports programs conducted.
- b. Participation rates are disaggregated by age, sex, barangay, and sector (e.g., PWD, OSY).
- c. Facility conditions and upgrades.
- d. Performance of athletes in higher-level competitions.

SECTION 33. ANNUAL SPORTS DEVELOPMENT REPORT- The JSDC shall submit to the Sangguniang Bayan an Annual Sports Development Report containing:

- a. Summary of activities and accomplishments.
- b. Challenges and issues encountered.
- c. Recommendations for policy or budget adjustments.



**ARTICLE XIII
PENALTIES AND ADMINISTRATIVE SANCTIONS**

SECTION 34. ADMINISTRATIVE SANCTIONS RELATED TO SPORTS FACILITIES- Without prejudice to applicable criminal laws:

- a. Any person or group found vandalizing or deliberately damaging sports facilities may be required to pay for repair costs and/or perform community service, as may be provided in the IRR and other ordinances.
- b. Organizations that repeatedly damage facilities or violate facility rules may be suspended or banned from using municipal sports venues for a period determined by the Sports Development Unit, upon recommendation of the JSDC.

SECTION 35. VIOLATIONS OF SAFE SPORTS PROVISIONS- Any coach, trainer, official, or person who violates provisions related to abuse, harassment, hazing, or unsafe practices in sports shall be:

- a. Subject to administrative sanctions such as suspension or removal from participation in municipal sports programs, and
- b. Referred to appropriate authorities for investigation and possible prosecution under applicable national or local laws.



Specific schedules of sanctions shall be included in the IRR, consistent with the Local Government Code and related ordinances.

**ARTICLE XIV
IMPLEMENTING RULES AND FINAL PROVISIONS**

SECTION 36. IMPLEMENTING RULES AND REGULATIONS (IRR)- Within six (6) months from the effectiveness of this Code, the JSDC, through a Technical Working Group convened by the Mayor, shall formulate the IRR, subject to consultation with stakeholders, and issue the same through an Executive Order.

SECTION 37. HARMONIZATION WITH EXISTING ORDINANCES- This Code shall be read and applied in harmony with existing ordinances on:

- 1. Youth welfare and development.
- 2. Anti-hazing and gang prevention.



3. Mental health and crisis safety.
4. Sports excellence and incentives.
5. Sports facilities ordinances.
6. Child protection and related measures.

In case of conflict, the provision more protective of the welfare of children and youth shall prevail, without prejudice to national laws.

SECTION 38. SEPARABILITY CLAUSE- If any provision of this Code is declared invalid or unconstitutional, the remaining provisions shall remain in full force and effect.

SECTION 39. REPEALING CLAUSE- All ordinances, rules, and regulations inconsistent with this Code are hereby repealed or modified accordingly.

SECTION 40. EFFECTIVITY- This Code shall take effect after compliance with the requirements on posting and publication under existing laws.






