**WHEREAS**, it has been observed that crimes against person, such as physical injuries and to the extent of murder, increase out of proportion to the detriment of the peace-loving residents.

**WHEREAS**, crimes of the above nature will greatly affect the well-being and progress of the community since peace and order situation, especially in public places is not under control;

**WHEREAS**, murder and physical injuries usually happen during social gathering and even fiestas as some persons are fond of carrying deadly weapons during these occasions.

**WHEREAS**, pursuant to RA 7160, otherwise known as the Local Government Code of 1991, the Sanggunian is empowered to enact ordinances to promote the general welfare of the inhabitants;

**NOW, THEREFORE**, be it ENACTED by the Sangguniang Bayan of Carigara, Leyte, by virtue of the powers vested in it by law, in its Regular Session duly assembled, that:

**Section 1. DEFINITION OF TERMS:**

1. **“Deadly Weapons”** refers to any bladed, pointed, or blunt instrument more than two (2) inches long, capable of inflicting bodily harm, injuries, or death to their victims, except where such articles are being used as necessary tools or implements to earn a livelihood or in pursuit

2. **“Specified Places”** shall refer to the following places:
  - a. Churches and places of worship;
  - b. Market Place;
  - c. Schools (Public and Private);
  - d. Government Buildings (Municipal Hall, Barangay Halls, Courthouses, Government Agency Buildings, and other similar government buildings);
  - e. Public Buildings (Health and Day Care Centers, Covered Courts, Cemeteries, Gym, Terminals, Municipal Library and Museum, and other similar structures);
  - f. Public plaza, parks, and playgrounds;
  - g. Financial and Commercial Establishments (banks, pawnshops, groceries, and similar businesses);
  - h. Entertainment and Recreation Venues (Cockpit, Dance Halls, Video Houses, Drinking Establishments, and other similar venues);
  - i. Restaurants or Food Shops;
  - j. Public or Private Offices;
  - k. Public Conveyances (Buses, Vans, Tricycles, Dos Manos, and other such public vehicles);
  - l. Jails and detention centers; and
  - m. Public occasions, events, festivals, and celebrations, including fiestas and founding anniversaries.

3. **“Minor Persons”** refer to persons below 18 years of age.

**Section 2. Prohibition.** Any person caught bearing or carrying or with their position a deadly weapon on the places specified above shall be punished according to the provision of this Ordinance, except when such weapon is being used as a necessary tool or implement in earning a livelihood or in pursuit of any lawful activity.

Provided, that such deadly weapon shall be safely wrapped/covered, secured, or sheathed, or deposited if applicable, when being carried or transported, and shall not be displayed or used in a threatening manner.

Provided, further, that the foregoing requirement shall not exempt any person engaged in lawful trade, occupation, or livelihood activity from the duty to ensure that such deadly weapon is handled and displayed safely, even while being used or sold as part of such trade or livelihood.

**Section 3. Prohibition on Minors.** Minor persons shall be absolutely prohibited from carrying bladed, pointed, or blunt instruments, except in authorized educational, cultural, sporting, or training activities. Provided, that such activities are conducted under the supervision of school authorities, blacksmiths, or other competent officials.

**Section 4. Penalties.** Any person violating this Ordinance shall be meted as follows:

**First Offense:** Confiscation of the deadly weapon and a fine of One Thousand Five Hundred Pesos (Php 1,500.00) or an imprisonment of One (1) month, but not more than Three (3)

months, or both at the discretion of the court.

**Second Offense:** Confiscation of the deadly weapon and a fine of Two Thousand Pesos (Php 2,000.00) or an imprisonment of Two (2) months, but not more than Four (4) months, or both at the discretion of the court.

**Third Offense:** Confiscation of the deadly weapon and a fine of Two Thousand Five Hundred Pesos (Php 2,500.00) or an imprisonment of Four (4) months, but not more than Six (6) months, or both at the discretion of the court.

In all cases, involving minors, the provisions of Republic Act No. 9344 and the intervention mechanism of the Department of Social Welfare and Development Office (DSWD) and the Local Council for the Protection of Children (LCPC) shall prevail.

**Section 5. Liability of Establishments.** Specified places mentioned in paragraph 2 Section 1 of this Ordinance whether public or private, shall exercise due diligence and take reasonable measure to prevent the entry, possession, or use of any deadly weapons within their premises. Any person or entity that knowingly allows, permits, or fails to prevent such acts shall be subject to the following penalties;

- a. **First Offense:** A fine of ₱1,500.00 and a written warning requiring immediate compliance.
- b. **Second Offense:** A fine of ₱2,000.00 and temporary suspension of business operations for a period of 3 to 7 days.

- c. **Third and Succeeding Offenses:** A fine of ₱2,500.00 and a revocation of business permit, and closure of the establishment, without prejudice to the filing of appropriate criminal, civil, or administrative actions against the owner, manager, or responsible officer.

The penalties herein imposed shall be separate and distinct from those imposed upon the individual offender found in possession of a deadly weapon.

**SECTION 6. Aggravating Circumstances.** If any person caught with a deadly weapon is found to be under the influence of alcohol or prohibited drugs, such person shall be punished with the next higher penalty, or with the maximum imposable penalty, at the discretion of the court.

**SECTION 7. Enforcement Clause.** The Carigara Philippine National Police (PNP), in coordination with the Barangay Officials and Barangay Tanods, shall enforce this Ordinance. Barangay Tanods are hereby deputized to assist in the enforcement of this Ordinance within their respective jurisdictions, particularly in monitoring and reporting violations, confiscating deadly weapons when necessary for public safety, and immediately turning them over to the Barangay Captain or the PNP for proper disposition.

**SECTION 8. Separability Clause.** Should any portion of this Ordinance be found unconstitutional or otherwise invalid by a court of proper jurisdiction, all remaining provisions shall remain in effect and shall not be affected by the ruling on the invalid section.

**SECTION 9. Repealing Clause.** All ordinances, rules, and regulations or parts thereof inconsistent with this Ordinance are hereby repealed or modified accordingly.

**SECTION 10. Effectivity Clause.** This Ordinance shall take effect fifteen (15) days following its posting in at least three conspicuous places in the Municipality of Carigara, Leyte.





8 **I. PRAYER & SINGING OF THE PHILIPPINE NATIONAL ANTHEM**

9 The committee formally commenced the public hearing with the  
10 Opening Prayer followed by the singing of the Philippine National Anthem.

11 **II. CALL TO ORDER**

12 The chairman of the Committee calls the meeting to order.

13 **III. ROLL CALL**

14 The Secretary disclosed that present thereat are the Chairman of the  
15 Committee on Police, Fire, Public Safety, Peace and Order and Human Rights

24 The Presiding Officer welcomed everyone and explained that the purpose of  
25 the hearing was to gather public comments and recommendations regarding the

13 knowingly allows, permits, or fails to prevent such acts shall be subject to the  
14 penalties;

16 Hon. Julius Cesar Caballes, likewise suggested to include a provision in  
17 the ordinance stating that minors who violates this ordinance shall be  
18 subject to the appropriate intervention measures of the Department of  
19 Social Welfare and Development (DSWD)

20 *All suggestions were noted by the Sangguniang Bayan Committee.*

21 **V. RESPONSE FROM THE AUTHOR AND THE MEMBERS OF THE**  
22 **COMMITTEE**

23 While the author of the ordinance acknowledges the suggestions and  
24 comments from the stakeholders who attended and participated in the public hearing  
25 on the proposed ordinance. The author further clarifies that the comments and  
26 suggestions raised by the representatives from different sectors and members of the  
27 community were all noted and that inputs have provided valuable insights on the  
28 practical challenges, regulatory implications, and community impact of
