This office opines that the subject Ordinance is, in general, within the legislative authority of the Sangguniang Bayan under Section 447(a)(3)(vi)<sup>1</sup> of the Local Government Code of 1991 (R.A 7160). Hence, we recommend for the declaration of its validity.



**AN ORDINANCE GRANTING RENEWAL OF FRANCHISE TO WILFREDO P. CANAYON FOR THE OPERATION OF A MOTORIZED TRICYCLE-FOR-HIRE ALONG THE POBLACION (POBLACION DIST 9 TODA) ROUTE, MUNICIPALITY OF BURAUEN, LEYTE**

WHEREAS, Section 447(a)(3)(vi) of Republic Act No. 7160, otherwise known as the Local Government Code of 1991, empowers the Sangguniang Bayan to regulate the operation of tricycles-for-hire and grant franchises for their operation within the municipality;

WHEREAS, Mr. Wilfredo P. Canayon has applied for the renewal of his franchise to operate a motorized tricycle-for-hire along the Poblacion (Poblacion Dist 9 TODA) route within the Municipality of Burauen, Leyte;

WHEREAS, the Committee on Transportation, Public Utilities, and General Services has conducted due evaluation and favorably recommended the renewal of said franchise, finding the same to be in order and compliant with applicable municipal and national regulations;

NOW, THEREFORE, upon the motion duly made and seconded, be it enacted by the Sangguniang Bayan of Burauen, Leyte, in session assembled:

**Section 1. RENEWAL OF FRANCHISE.** A franchise is hereby renewed in favor of **WILFREDO P. CANAYON** for the continued operation of one (1) unit of motorized tricycle-for-hire along the **Poblacion (Poblacion Dist 9 TODA) route** within the territorial jurisdiction of the Municipality of Burauen, Leyte.

**Section 2. VEHICLE SPECIFICATIONS.** The authorized unit shall have the following specifications:

<b>Make:</b>	HONDA
<b>Engine No.:</b>	KB50605Z043819E
<b>Chassis No.:</b>	KB506-05Z-043819
<b>LTO Plate No.:</b>	HY5611

**Section 3. PERIOD OF FRANCHISE.** The franchise granted herein shall be valid for a period of three (3) years from the approval of this Ordinance, unless sooner revoked or suspended for cause, and may thereafter be renewed upon proper application and compliance with applicable requirements.

**Section 4. COMPLIANCE.** The grantee shall comply with all applicable rules and regulations of the Municipality of Burauen and the Land Transportation Office (LTO), and shall secure the necessary permits and clearances for the continued operation of the franchise.

**Section 5. EFFECTIVITY.** This Ordinance shall take effect immediately upon approval.

ENACTED, this 12<sup>th</sup> day of January 2026, at the Municipality of Burauen.
