AN ORDINANCE GRANTING RENEWAL OF FRANCHISE TO EDWIN C. LANDRITO FOR THE OPERATION OF A MOTORIZED TRICYCLE-FOR-HIRE ALONG THE TAMBUCO-MARKET (BASTTODA) ROUTE, MUNICIPALITY OF BURAUEN, LEYTE

WHEREAS, Section 447(a)(3)(vi) of Republic Act No. 7160, otherwise known as the Local Government Code of 1991, empowers the Sangguniang Bayan to regulate the operation of tricycles-for-hire and grant franchises for their operation within the municipality;

WHEREAS, Mr. Edwin C. Landrito has applied for the renewal of his franchise to operate a motorized tricycle-for-hire along the Tambuco-Market (BASTTODA) route within the Municipality of Burauen, Leyte;

WHEREAS, the Committee on Transportation, Public Utilities, and General Services has conducted due evaluation and favorably recommended the renewal of said franchise, finding the same to be in order and compliant with applicable municipal and national regulations;

NOW, THEREFORE, upon the motion duly made and seconded, be it enacted by the Sangguniang Bayan of Burauen, Leyte, in session assembled:

Section 1. RENEWAL OF FRANCHISE. A franchise is hereby renewed in favor of MR. EDWIN C. LANDRITO for the continued operation of one (1) unit of motorized tricycle-for-hire along the Tambuco-Market (BASTTODA) route within the territorial jurisdiction of the Municipality of Burauen, Leyte.

Section 2. VEHICLE SPECIFICATIONS. The authorized unit shall have the following specifications:

Make:	SKYGO
Engine No.:	161FMJK1201004
Chassis No.:	LX8PCK507KE008983
LTO Plate No.:	H812CV

Section 3. PERIOD OF FRANCHISE. The franchise granted herein shall be valid for a period of three (3) years from the approval of this Ordinance, unless sooner revoked or suspended for cause, and may thereafter be renewed upon proper application and compliance with applicable requirements.

Section 4. COMPLIANCE. The grantee shall comply with all applicable rules and regulations of the Municipality of Burauen and the Land Transportation Office (LTO), and shall secure the necessary permits and clearances for the continued operation of the franchise.

Section 5. EFFECTIVITY. This Ordinance shall take effect immediately upon approval.

ENACTED, this 22nd day of December 2025, at the Municipality of Burauen.


